On Thursday morning, I received a call from an employee of Truth Well Transit at 7:10, alerting me that my ride would be arriving at 7:30 to transport me to my medical appointment, which was scheduled for 8:30. While alerting me, the individual also asked me to confirm the address of my destination. When my ride arrived at 8:00, the driver informed me that he could not transport me, as my scooter would not fit in his vehicle. He instructed me to wait for another driver and quickly departed. When the second driver arrived at 8:18, he was adamant that the scooter would not fit. However, I was determined to make this very important medical appointment, even though I knew that I would be extremely late. I insisted that he make an attempt, and his attempt proved successful. In addition to the driver taking little initiative to assist me when he arrived, he had the audacity to constantly check his text messages while driving me to my appointment at the Pain Treatment Medical Center. My fears were further heightened, as I had no seatbelt to secure me in the vehicle.

After my appointment, my nurse phoned Medical Transportation Management, the contractor for Truth Well Transit. I waited for an hour, but my ride did not show. The nurse at the treatment center became frustrated that no one had arrived within the hour. She decided to personally make the call to check for my ride. She called several times within a span of 3 and a half hours until a van finally arrived.

After the van finally arrived, I was transported to a pharmacy to fill a new prescription. Before leaving, the driver asked me how long I thought that I would need to be in the store. I informed him that I was not certain of the time, but that it should be no longer than an hour.

After the hour, no van was present. Several calls were made to Truth Well Transit , and each time there was the assurance that a van would retrieve me. After three hours, I gave up, and called another service. Pleading desperately, the company proved compassionate and decided to retrieve me, and transported me home. Tired and upset, I arrived home safely at 5:35 PM. Throughout the day, Truth Well Transit clearly exhibited a lack of concern for their passengers. And at the end of the day, they left me abandoned, a wheelchair bound individual with many serious health concerns. I was stranded and made someone else's responsibility. How is this fair?
