Howell Ave. Investigation revealed a customer was upset over a return and as they were leaving, they swung their hand, striking an employee. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
2. On 08/20/24 at 6:38p.m., Milwaukee Police were dispatched to a Property Damage at 4130 S. Howell Ave. Investigation revealed the business window was damaged by an unknown subject during closed hours.

Upon my arrival I observed the front cashier COBBS, Shemetra (B/F, 1/30/86) who stated that she was the one who first observed the individuals enter the establishment.

I spoke to the COBBS, Shemetra (B/F, 1/30/86, 414916-6970). COBBS stated that four black males wearing ski masks and who were approximately 16-20 years of age enter the establishment and grabbed random items of merchandise and put them in totes and garbage bins before leaving through the front door and driving off.

There was other no witnesses besides COOBS

I spoke to licensed premise employee GOODWIN, Debbie (B/F 07/31/1953, 414-943-1334) GOODWIN did not witness the theft but she helped show me the video surveillance footage depicting what time they entered the establishment and what they were wearing. The business was cooperative with the investigation.

I reviewed video surveillance footage. The footage showed four black males with ski masks enter the premise grabbing merchandise and putting them in totes and garbage bins before existing the establishment.

I spoke to the caller, Nohemi Muniz, W/F, 12-12-73 who is the assistant manager of the store. Muniz stated on today's date at 3:47 p.m., an unknown actor walks into the store and fills a shopping cart with cleaning supplies. Muniz stated at 3:53 p.m., the actor exits through the fire exit with the shopping cart with store merchandise. Store merchandise valued at approximately \$225.00.

I spoke to witness, Michale Bugalski, W/M, 12-07-78 who is the owner of Avenue Liquor, 4075 S. Howell Ave. Bugalski who stated he was in his store when he observed the unknown actor with the shopping cart running northbound on S. Howell Ave. Bugalski stated he followed the actor in his vehicle and recovered the stolen merchandise in the 4100 block of S. Austin St. Bugalski stated he returned the shopping cart with the stolen merchandise to Dollar General.



