This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 03/02/23 Milwaukee Police officers of District 7 did a Computer Aided Dispatch (CAD) search on the business location 4811 N Teutonia Av. The dates of the search were from 11/01/22 to 03/02/23. The following is a summary of the findings of the CAD search:
 - 12/23/2022 Armed Robbery Complaint: Officers responded to the location of N 24th and W Hampton Ave. The caller of the incident ran to the business after the robbery. Officers recovered video surveillance from the business location.
 - 12/26/22 Shot Spotter Complaint: Near the intersection of the business multiple Shot Spotters were called into Milwaukee Police. 8 casings were recovered outside of the business location.
 - 02/06/23 Armed Robbery Complaint: The victim stated that 2 suspects physically struck him and took his vehicle. The victim was at the business location and while outside was approached by the suspects who beat him up and took his keys to his vehicle. One of the suspects then drove the victim's vehicle from the location with the other suspect following in a separate vehicle. The business provided video of the incident.

- 2. On 04/12/23 at 3:24am, Milwaukee Police were dispatched to 4811 N. Teutonia Av, for a shooting complaint. Officers arrived and observed the victim sitting on the floor of the gas station with injuries sustained from gunshots. The store clerk was very cooperative and assisted by providing video from the business to the investigators. Subsequently it was revealed that the shooting took place at a nearby park, and the victim made his way to the business for help. The investigation was turned over and handled by Milwaukee Sheriff's Department.
- 3. On 07/23/23 at 5:23am, Milwaukee Police were dispatched to 4811 N. Teutonia Av, for a trouble with subject complaint. Officer arrived and spoke with the caller/employee, who stated that a subject came into the store and knocked down items on the floor. The subject argued with the clerk regarding paying for gas and became upset knocked items in the process. The subject was gone prior to police arrival.
- 4. On 07/26/23 at 9:35pm, Milwaukee Police were dispatched to 4811 N. Teutonia Av, for an armed robbery complaint. Officer spoke with the victim who stated that she was standing at the bus stop in front of the gas station. The suspect approached her pointed a gun and took her back pack from her. Officers reviewed video of the business which show the incident in its entirety.
- 5. On 08/27/23 at 9:57am, Milwaukee Police were dispatched to 4811 N. Teutonia Av, for a theft complaint. Officers arrived and observed a subject sleeping in front of the business. Officers spoke with the store clerk who stated that he has been dealing with the subject the last few days. The subject came into the business ate some food items and would leave, then return. The subject is a known subject who his homeless with mental issues. The subject was cited for retail theft.
- 6. On 11/18/23 at 10:16pm, Milwaukee Police were dispatched to 4811 N. Teutonia Av, for an armed robbery complaint. Officers spoke with the victim who stated that two suspect took his car at gun point and fled the location in the victim's vehicle. The victim stated that he left from the inside of the gas station and was approached outside the location by the suspects. Officers spoke with the store clerk and were provided video which showed the suspects and the incident in its entirety.

The following incidents occurred at 4811 N. Teutonia Ave.

- 7. On 03/15/24 at 7:30p.m., Milwaukee Police were dispatched to an Armed Robbery. Investigation revealed a suspect entered the driver's seat of a parked vehicle displayed a firearm and ordered the passenger out, then fled with the vehicle. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 8. On 04/01/24 at 2:26a.m., Milwaukee Police were dispatched to a Shot Spotter. Officers recovered 9 casings in the street. The clerk stated they did not see nor hear the shooting and the video surveillance would not have captured the incident.
- 9. On 08/22/24 at 6:41a.m., Milwaukee Police were dispatched to a Battery. Investigation revealed an employee was physically assaulted by a suspect when confronted regarding shoplifting. The suspect was arrested on scene. The business was cooperative.

- 10. On 09/28/24 at 10:36a.m., Milwaukee Police were dispatched to a Subject with Weapon. The employee stated a juvenile riding a bike, fired one shot at the ground. The employee stated they didn't see the juvenile shoot the gun, however, the juvenile had been in the store earlier and displayed a firearm. Video surveillance did show the juvenile riding a bike, however, the officers did not see a firearm.
- 11. On 10/23/24 at 2:59p.m., Milwaukee Police were dispatched to a Shot Spotter. Investigation revealed a suspect who had left the store with others, walked toward the bus shelter on W. Hampton Ave., and fired approximately 8 rounds, shattering the bus shelter. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 12.On 11/04/24 at 12:55a.m., Milwaukee Police were dispatched to a Call for Police. On arrival officers interviewed the caller who refused to give their first name, stating a group of subjects entered the store, stole items, broke a door and made threats to the caller. The caller did not want a police report filed and refused extra patrol when it was offered. The caller was advised to call the police if this continues.
- 13.On 11/14/24 at 10:13p.m., Milwaukee Police were dispatched to a Battery. Officers were advised a suspect that has previously caused problems attempted to enter, however, the employee closed it to prevent them from entering. The suspect was able to push the door open and punched the employee. The business was cooperative.
- 14. On 12/03/24 at 1:08a.m., Milwaukee Police were dispatched to an Armed Robbery. Investigation revealed suspects kicked in the locked door and entered the store, while armed with a handgun. The suspects then went behind the cashier counter and took items before fleeing the store. One of the cashiers was punched by a suspect during the incident. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 15.On 12/10/24 at 12:17a.m., Milwaukee Police were dispatched to a Threat. On arrival officers observed suspects running out of the store with merchandise and the clerk chasing them stating "he stole". Two suspects were taken into custody. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 16. On 01/02/25 at 12:00a.m., Milwaukee Police were dispatched to Additional Information regarding Item 13. The employee advised the officer one of the suspects from that incident had returned to the store and provided video surveillance of the suspect.
- 17.On 01/06/25 at 2:46a.m., Milwaukee Police were dispatched to a Threat. Investigation revealed this was a trouble with subjects that have stolen items in the past. The subjects were no longer on scene and the business was cooperative.
- 18. On 02/06/25 at 6:16a.m., Milwaukee Police were dispatched to a Property Damage. Officers were advised a suspect became angry and began throwing items around the store. The business was cooperative and provided video surveillance.
- 19. On 02/12/25 at 12:00p.m., Milwaukee Police were dispatched to a Theft. Investigation revealed suspects were attempting to steal soda, when approached by the employee, one of the suspects began punching the cashier. When the cashier fell to the floor, the suspects took

- 2 twelve packs of soda and fled the scene. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.
- 20. On 03/05/25 at 9:45p.m., Milwaukee Police took a walk-in motor vehicle theft. The victim stated they parked their vehicle at a gas pump, with keys in the ignition, and entered the store. When they returned to their vehicle it was gone. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

On Friday, March 15, 2024, at approximately 7:30 PM, I was dispatched to 4811 N Teutonia Ave (Citgo gas station) for an armed Robbery.

Upon arrival, I observed the Victim inside the gas station. There were four additional squads that responded to the call. (Squad 7210 Raymond DEBRASKA, 7214 Sergeant Robert WENGER, 7431 PO Kristopher WALKER, PO Alexander HAHN, 897 PO Nathan SMALKOSKI)

I spoke to the caller, Tydijha A. BROWLEE (B/F 12/27/99 262-208-6029) BROWLEE stated an unknown subject came to the vehicle with a firearm and forced her cousin to get out of the vehicle and took off with the vehicle Black Audi Q7 bearing Wisconsin license plates AWY-6400.

I Spoke to the victim identified as Tyrieon ROQUEMORE (B/M 10/22/10). ROQUEMORE stated he was sitting in the back seat in his motor vehicle when an unknown suspect entered the driver's seat with a black handgun and pointed it directly at ROQUEMORE and stated, "Hurry up and get out". ROQUEMORE stated he immediately got out the vehicle and ran inside the Citgo gas station. ROQUEMORE stated he immediately informed his cousin the owner of the listed vehicle identified as 2012 Black Audi Q7 bearing Wisconsin license plate AWY-6400. The owner of the vehicle was identified as Tydijiha A. BROWNLEE (B/F 12/27/1999) who was inside the gas station when the incident occurred.

ROQUEMORE stated the suspect was a B/M wearing a black ski mask, red and black jacket, light wash blue jeans, and armed with a black handgun. ROQUEMORE stated the suspect fled the scene going Southbound on Teutonia.

I spoke to the witness BROWLEE that stated she just went inside the gas station to pay for gas and her cousin came running inside after the incident.

The licensed premise clerk Gurpreet SINGH (W/M, 08/05/1995) spoke with Detective Jesse MATTSON regarding the incident. See Detective supplement regarding. The business was cooperative with the investigation.

I was not able to review video, P.O Kristopher WALKER observed the video. See PO WALKER supplemental regarding.

While on scene, I observed the licenses posted and they were up to date. During my investigation for an Armed Robbery, I did not observe any violations in the licensed premise.

This report is submitted by Officer Ryan Russell HUCK, assigned to District 7 Late Shift.

On Thursday, August 22, 2024 at 6:41 AM, Squad 7330 (PO Matthew SCHWISTER and I) were dispatched to a Battery Complaint at 4811 N Teutonia Av, 53209. This incident was determined to have started at approximately 6:26 AM on 08-22-2024 at 4811 N Teutonia Av, 53209. This premise is located in the City and County of Milwaukee, Wisconsin.

INTERVIEW WITH VICTIM (Surject S KHASRIA (A/M 05-30-1995))

Upon arrival we spoke to the victim, Surjeet S KHASRIA (A/M 05-30-1995) who was reporting the suspect, Sandra N LEE (B/F 04-16-1975) to have shoplifted and assaulted him. I was able to view camera footage of LEE concealing several bottles of cleaning solution inside of her pants totaling approximately \$14. KHASRIA then observes this and locks the door to the shop because LEE was attempting to walk out of the store. LEE then opens a bottle of Everfresh beverage (\$2.09) and two strings of Laffy Taffy (\$2.00 total). LEE then attempts to open the locked door and exit several times without paying for these items. KHASRIA calls the police and LEE at which point LEE begins getting in a physical altercation with him, and swinging her arms and hitting him. KHASRIA stated this caused him a 2/10 on the pain scale and I observed a visible scratch on his left forearm caused by LEE. KHASRIA did not consent to LEE's actions. LEE's identity was confirmed by MPD booking photo. A search incident to arrest of LEE showed that she had no money in her possession and she still had several bottles of cleaning solution on her person taken from the store.

LEE was arrested at 6:54 AM and conveyed to District 7 at 7:32 AM.

KHASRIA was cooperative with the investigation and allowed us access to camera footage and providing a detailed list of the property and their values. I did not observe any violations on the premise besides the incident we were dispatched to.

LEE was served a Harassment order with 4811 N Teutonia Av at 10:13 AM at D7 sallyport with MCSO notified by PO SCHWISTER. This is regarding MC Case#2024CV006028 which expires on 08-07-2028.

S1 begins kicking in the lower glass of the front door. S4 then kicks in the rest of the window. S1, S4, and S2, then walk through the broken door window frame in that order while S3 waits outside and keeps lookout while brandishing a black semi-auto handgun in his right hand. A different camera angle shows the interior of the cashier's desk where S1 had began fighting with SANDHU and SINGH. SANDHU informs me at this point that S1 had stated to him that he has a gun in his pocket. S1 then grabs two boxes of five vapes each (\$200 total) that were behind the cashier's desk and flees out of the store with S2 before heading towards W Hampton Av. S4 then flees the store several seconds later. SANDHU stated that all four suspects fled westbound on W Hampton Av on foot. SANDHU stated that at some point the was punched in the face as well while fighting with S1.

Squad 7392 (PO Anthony DAVENPORTE) interviewed a witness, Abigail S WASHINGTON (B/F 06-14-1993) who was at the bus shelter on the northwest corner of N Teutonia AV and W Hampton Av. WASHINGTON stated that the suspect ran westbound on W Hampton Av and then crossed over onto the southside of W Hampton Av and ran into an unknown alley southbound.

Upon my arrival I observed items on the floor of the store and shelves knocked over.

I spoke to the caller, SINGH, HARPREET w/m 08-03-00 (929)866-1455. SINGH stated he had a male and female who comes into store every day and steals. Today they came into the store and stole three cases of sodas. The female stood at the door with her foot holding the door open so that the door lock could not be activated. The male walks over to the sodas and attempted to take the sodas. SINGH stated that he went over to stop the male from taking the sodas and the male started punching him. As they were fighting the female came into the store and attempted to hit SINGH with one of the twelve pack of sodas that had fallen to the floor. SINGH stated the male stop fighting him when he fell to the floor. He and the female grabbed three twelve packs of sodas and ran out of the store.

I did not speak with the licensed premise owner just the employee.

The employee was very cooperative and showed me video. There was no security on scene. Upon reviewing the video, a black male with a gray hooded sweatshirt, and female wearing a red puffy coat come into the store at 11:52 AM. The male walks over to the sodas and picks up two twelve packs and starts walking to the door. The female is holding the door. As the male attempts to leave SINGH is seen walking over to him and tries to stop the male from leaving the store. They then get into a fight. Things are knocked over and the female is seen grabbing one of the twelve packs and raising it over her head as if she is going strike SINGH. When SINGH falls to the floor the male goes and grabs two twelve packs of sodas and the female leaves with a twelves pack. The employee was able to access the video and assist with recovery. The video was recovered and uploaded to Axon.
