Re: District Attorney Appointments for the Commission on Domestic Violence and Sexual Assault

Dear Attorney Skwierawski:

As the appointing authority for three positions on the Commission on Domestic Violence and Sexual Assault, I am requesting that the following individuals be appointed or reappointed to the Commission:

- 1) Reappoint Ann Ranfranz for the Sexual Assault position. Ann has been the director of our Sensitive Crimes Advocacy Unit for several years;
- 2) Reappoint Matthew Torbenson for the Children's Court Position. Assistant District Attorney Torbenson is the Team Captain for the Child Advocacy and Protection Unit. The unit is responsible for prosecuting caretakers for child abuse and neglect, children in need of protection and services litigation (CHIPS cases) and the prosecution of juvenile court sexual assault cases;
- 3) Appoint Chris Liegel for the Domestic Violence Position. Assistant District Attorney Liegel is the Team Captain of our Domestic Violence Unit. Although newly appointed to this position, Chris has 18 years of experience including prior assignments within the Domestic Violence and Sensitive Crimes Unit.


