Question #2(b) asks, "Have you ever been convicted of any violation of any municipal ordinances?" The applicant answered "No" to both of these questions. He signed the application and swore before a Notary Public that the answers were true and correct. Based on applicant's conviction record, as shown above in this report, both of these answers were false statements, contrary to City Ordinance #90-5-2(a). It should be noted that twice previously, the applicant filed false statements on Auxiliary Questionnaires, and was instructed to file amended applications, which he did on 9-18-1996, and 9-4-02. He was previously warned about filing false statements on the Auxiliary Questionnaire. He was instructed on 9-8-03, to again file an amended application in connection with this application.

Officers spoke with Valdemar Escobar who stated he was aware that his license was expired, however he was in the process of renewing it. Valdemar stated he has several restaurants and they are under different names and that he lost track of which license was in need of renewing. Officers asked Valdemar where he has been purchasing his alcohol since distributors will not sell to him without a valid license to which Valdemar responded he has been purchasing his liquor wholesale at Oklahoma Liquor. Due to this admission, officers' were able to determine that Valdemar has been operating as a Class B establishment since the expiration of his license in 2010. Valdemar was cited and advised that he can no longer operate as a Class B establishment until his liquor license was renewed and issued. Officers also made a referral to ATF Agent King regarding the purchase of liquor from a retail dealer. King stated she would follow up at the establishment in the next week.

Officers spoke with Valdemar Escobar and advised him that his Class B Tavern License was expired and that he could not sell alcohol until he received a valid Class B Tavern license. Valdemar stated he understood and was told he could not sell since officers advised him on October 6th, 2011. Officers requested copies of Valdemar's recent alcohol purchases from wholesalers or otherwise. Valdemar stated he did not keep receipts of such transactions. Valdemar was advised to keep these receipts on premise and that when requested he must provide them and failing to do so may result in a citation. Valdemar was also advised to remove any alcohol bottles located in plain view.

29. On 10/07/11 at 7:24 pm, Milwaukee police conducted a License Premise Check at 821 W Lincoln Avenue to ensure that alcoholic beverages were not being sold. Officers spoke with Valdemar Escobar in Spanish. Escobar told officers that on 10/06/11, two officers came into the business and advised him that he could not sell alcoholic beverages due to his Class B Tavern license being expired. Valdemar stated he had a hard time understanding the police. Escobar further stated that on police were there earlier in the day checking to make sure alcohol beverages were not being sold to which Escobar stated he was aware of the situation and that no alcohol was being sold. Officers asked Escobar if he was informed that no alcohol could be displayed during the restaurant hours of operation due to the fact his Class B Tavern license was expired, to which Escobar stated he was not informed. Escobar stated he would assure that no bottles containing alcohol would be displayed until his license was renewed. He further stated that his license was not renewed because of a \$3,000 lien on his license by the IRS. Escobar stated that he paid the lien and submitted his application to renew the license and that he was waiting for the next city council meeting on 10/11/11. Escobar was further warned that if he police found him to be selling alcohol that he could be cited for the offense.

30. On 12/06/11 at 1:45 pm, Milwaukee police, along with an agent from ATF, conducted a License Premise Check at 821 W Lincoln Avenue. Officers found that the businesses Class B Tavern license was expired and spoke with Valdemar Escobar in regards to having no valid license. Agent King spoke to him regarding bottles of alcohol and beer in the business. Escobar provided one receipt with eleven bottles of liquor purchased from an alcohol distributor. Escobar stated that other bottles of alcohol were either purchased from a retail liquor store, Oklahoma Liquor, or have been there for a couple of years because he does not sell liquor very often. Two bottles were found to be contaminated and were disposed of right on scene. Agent King counted 57 opened bottles and six sealed bottles of liquor that Escobar did not have receipts for proof of purchase from a distributor. These bottles were confiscated and Agent King advised Escobar that he needs to comply with the purchasing of alcohol and liquor from a distributor.




Concentration Map 821 W LINCOLN AVE






ADJACENT BUILDING


