This is in response to your request on behalf of a local resident to install the above-captioned parking restriction.

Our traffic engineering staff has investigated this request and found westbound motorists on West Waterford Avenue have a difficult time seeing northbound traffic traveling on South 13th Street when vehicles park close to the intersection. Therefore, in the interest of public safety, we recommend installing this parking restriction to increase cross traffic visibility at the intersection.

We will prepare the necessary legislation that will be heard at the next Public Safety and Health Committee meeting, so that you may support it to final passage.
