Center St., in regards to information received that Synthetic Marijuana was being sold at the locations. The employees were cooperative and allowed officers to check the entire store, however, nothing was found.

3. On 04/20/21 at 11:51am Milwaukee Police were dispatched to 1401 W. Center St, for a subject with gun complaint. Officers spoke with the manager of Eagle Foods who stated that the owner of Shop 414 confronted him in the parking lot while armed with a handgun. The confrontation was regarding a delivery of a package that was delivered to the wrong store. Officers reviewed video, which did not have any audio. Officers observed the owner of 414 Shop open carry a handgun at his waist in a holster. Officers did not observe the owner take the gun out its holster or any movements towards it at the time of the verbal confrontation. The manger stated that he believes that the owner of Shop 414 should not be walking around the location with a handgun. Officers spoke with the owner of Shop 414 who stated that he was surprised that the police were called regarding the verbal disagreement. Officers told the manger that the owner would not be arrested for the incident. Officers stated that both parties then were arguing with each other over on going issues. Officers stated that the complaints of both parties would be referred to the Community Liaison Officers of District #3.

but JARABA circles in the lot, then pulls off camera and later reappears and backs into the spot closest to his store entry door.

JARABA then exits his store and walks to a delivery truck at the opposite end of the parking lot. As JARABA is walking past he is observed looking into the windows of the store, again nothing is heard on the camera, but JARABA is observed shaking his head and then spits on the ground. After speaking to the delivery driver, JARABA then walks past his store, when MUSEITEF confronts him a second time, and it appears that both parties are observed to be engaged into a verbal altercation. JARABA is observed walking directly towards his store however he cuts between two cars and is observed saying things to MUSEITEF. MUSEITEF who was armed with a handgun in a holster on his right side hip never pulls out his gun, never grabs the gun, however he is observed to be using his hands while speaking. While he uses his hands and they go down to his side, his right hand did have a tendency to brush past the handgrip of his gun, but never really index's the firearm.

We then spoke to MUSEITEF who stated that he arrived to work earlier in the day after his brother. His brother informed him that he spoke to JABARA earlier before 10:30 a.m., and asked for a box that should have been delivered, and was told that JARABA informed his brother that it was thrown away because it was trash like him. This caused MUSEITEF to become upset, and he wanted to confront JARABA about this, and when he walked to JARABA's parked motor vehicle, he stated that JARABA was on the phone and he was only upset at this point, because JARABA was laughing at him over the phone. MUSEITEF stated that he then re-entered the store and was willing to leave it at what was done was done.

MUSEITEF stated that while he was inside his store, he observed JARABA walking past and was staring into his store, described that he was staring hard into his store. MUSEITEF then confronted him the second time to see if something was wrong, however the argument continued for a short period of time. This was when MUSEITEF decided to go back into the store and just wanted things to be how they were.

While speaking to MUSEITEF he was in disbelief that the police were actually called and did not think they needed to be.

During the course of this investigation both parties involved spoke english very well, and well enough to understand what was being said and well enough to articulate there stories. However during this investigation there would be interjections in there foreign language from other persons and the story would alter from what was originally stated.

After speaking to both store owners, they were yelling at each other, over one calling the other trash. This investigation did not reveal any threats upon speaking to JARABA, when asked first he stated that he was called trash or something of the type by MUSEITEF, and that he, "MUSEITEF" was armed. When closing out this investigation I was going over what was going to be occurring. While explaining to JARABA, that the Crime Intervention Team was contacted and we would notify the Districts CLO's to become more involved with there complaints, JARABA's wife made a statement in a foreign language to JARABA, and suddenly JARABA stated, oh, "he threatened to shoot me," out of the blue while manipulating items behind the counter and moving things around. This was almost 30 minutes after speaking to JARABA about what was going on or what occurred while reviewing the video, while speaking to him in the lobby of the store area and before we informed him we would go speak to the

The above application has been made by the above named applicant(s). This requires approval from the Licenses Committee and the Common Council of the City of Milwaukee. The hearing before the Licenses Committee will take place virtually on 9/28/2021 at 10:55 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


