Our office has received your claim relating to the towing of your car. You claim that your vehicle was towed after "No Parking" signs were posted on your street on October 31, 2000. You are seeking a refund of the towing and storage fees, the parking ticket, loss of income and other miscellaneous costs in the amount of \$417.65.

You claim you want a refund of the parking ticket, but you paid the ticket issued with the tow and did not contest its legality. If you believe that the tow was improper, you must reopen the case. You may do so by contacting the Ordinance Enforcement Division at (414) 286-2676. If you prevail, and the citation is dismissed, you may be entitled to a refund of the tow fee. The City followed proper procedure and accordingly, we are denying your claim.
