Reason for Claim: Basement Flood

Date of Incident: March 26, 2023

Location: 9021 W. Bluemound Road, Milwaukee, WI 53226

Details:

On Sunday, March 26, Mike was sleeping on the couch in the basement. He woke up and noticed water on the floor. At that time, the water was covering his foot. We called Roto Rooter (Invoice included) and they arrived at 3:10 p.m. They attempted to remove the clog 3 times but was unsuccessful. We were told it may be the City Sewer line. Mike called the Milwaukee Public Works but the office was closed. The Roto Rotter gentlemen suggested we have the basement jetted and since it was Sunday, we could not afford the cost. They arrived early Monday morning and scoped out the sewer lines on my block. He let me know that the sewer to the East was not flowing and to call the city. I immediately called the Milwaukee Public Works office and talked to Pam. She was very helpful and put a rush on the request to get a city worker out to check. About 45 minutes had passed and no one had arrived yet. At that time, I called the City Alderman and spoke with Jenn, his Legislative Aide. She also made a call regarding the situation (report included). Around 9:30 a.m., the workers arrived and checked the neighboring sewers. Around 10:30 a.m., a city worker informed me that the city sewer line was the cause and that the clog was removed. Our basement finally started to drain. Now remember, this started at 9:30 the day before so we had water filling our basement for 24 hours by this point. I also included pictures of the damage to the basement with an itemized list.

Due to the negligence of the city, our basement was flooded. This caused unreparable damages to a newly remodeled (2021) basement, which included new furniture. I included a list of what was lost. I feel we should be compensated for all that we lost along with wages, labor and pain and suffering.
