Dear Alderman Bauman:

At the last Public Safety Committee meeting, the above captioned parking restriction on West Wells Street was inadvertently legislated. To rectify this situation we will prepare legislation for consideration at the next Public Safety Committee Meeting to remove this legislation.

Also, legislation will be prepared for the installation of a no parking restriction on the north side of West State Street from North 8th Street to a point 55 feet east. The installation of this restriction is based on an investigation by our traffic engineering staff that found south bound motorists on North 8th Street have a difficult time seeing traffic traveling west bound on West Wells Street when vehicles park close to the corner. Therefore, in the interest of public safety, we recommend installing this restriction to increase cross traffic visibility at the intersection.

We will prepare the necessary legislation for the next Public Safety Committee meeting, so that you may support it to final passage.
