Subject: Honorary Street Name Request – Bishop K. Carter  
North 33<sup>rd</sup> Street from West Burleigh Street to West Auer Avenue

Dear Honorable Members:

This letter is in reply to an application dated February 22, 2023 regarding a request for an honorary street name of Bishop K Carter on North 33<sup>rd</sup> Street from West Burleigh Street to West Auer Avenue.

Chapter 113-3 of the Milwaukee Code of Ordinances provides the guidelines to consider when reviewing honorary street name requests. The guidelines provided in the code have been reviewed and the following comments are offered:

Bishop Kevin Carter was born in Milwaukee and resided here almost all of his life. Over 30 years ago he accepted a call from God to open the Joshua Possessing the Promise Ministries. Since April 2005, the ministry has been located at North 33<sup>rd</sup> and West Burleigh. They have opened a food pantry and housing for families in the community and he has mentored homeless women with children. He has pastored over 500 families over this time.

The request to honor Bishop K Carter with an honorary street name of “Bishop K Carter” includes 15 letters and spaces. The letter size of the honorary street name will be sized to fit the standard honorary street sign space.

Three (3) blue honorary street signs will be needed. Please refer to the attached map showing where the honorary street name signs will be located. The petitioner may choose to furnish the honorary street signs, but they must be fabricated to established City standards. The City can fabricate the signs at \$50 each. In either case, the City will install the honorary street signs at a cost of \$50 per sign. The petitioner is to deposit \$150 to the City if they furnish the signs or \$300 if the City fabricates and installs the signs. If a sign needs to be replaced in the future, the City is to be notified of the missing or damaged sign and the petitioner is to cover the cost to fabricate and mount the sign as described above. The City’s cost to fabricate and install future signs is subject to change.

North 33rd Street will remain the official street name so addresses will not change.

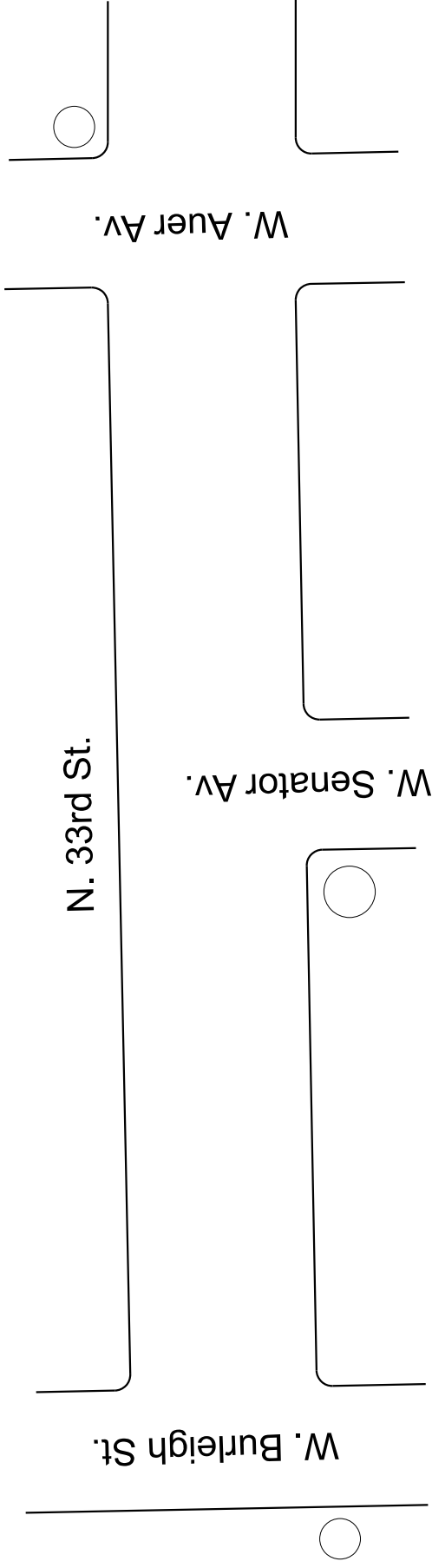
