This report is written by Police Officer Corstan D. COURT, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 03/10/2016 officers were dispatched to a sexual assault at Suburban Motel, 4600 S 27<sup>th</sup> St. The investigation revealed a juvenile female was at the motel and was advertising on the "Backpage" website for sex. She stated a male client had come to the door. She cracked the door and told him she was not feeling well, and he forced his way in and forcefully raped her. The night clerk at the motel was Ruth RUNTE. She stated the motel had cameras but she cannot access them, only the manager, Sheetal has access to the system. RUNTE stated the number for Sheetal is the motel. RUNTE was reluctant to supply the officer with information.

2. On 04/25/18 at 7:27pm, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> Street (Suburban Hotel) for a Subject with Gun complaint. Investigation revealed that a Motel guest (caller) had someone knock on his door and when he looked out the window to see who was knocking, he observed a subject standing outside his door with a handgun. When police arrived the subject was gone. The Motel has surveillance cameras but they were unable to capture the incident. A report was filed.

3. On 03/11/19 at 7:23am, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> Street for an overdose complaint. Upon arrival, officers were let into the room by the front desk clerk and found a female lying on the edge of the bed with a plastic tube inserted into her right thigh. Milwaukee Fire Department attempted life saving measures but were unsuccessful. Surveillance video captured a male exiting the room before police were called and leave the premise in a vehicle.
  
4. On 06/14/19 at 1:29am, Milwaukee Police were dispatched to 4600 S. 27<sup>th</sup> Street for an overdose complaint. Upon arrival, officers observed Milwaukee Fire Department personnel performing life saving measures on a female inside one of the hotel rooms. They interviewed the caller who stated the female was having a bad reaction to illegal drugs so he gave her NARCAN. When that did not work, he called 911 and was given instructions on how to perform CPR. The front desk clerk was able to provide the subjects who were registered to the room, their check in date, and the date of check out. The female was conveyed to the hospital and is listed in critical condition.

## Narrative (1)

### INITIAL INVESTIGATION

Romero-Perez, Ana C 027129

04/12/2019

On, March 11 2019 I was dispatched to an Overdose Complaint at approximately 7:22 am at the location of 4600 S 27th St #13 ( Suburban Motel) in the City and County of Milwaukee.

Upon arrival, we were unable to gain entry to the motel room. A front desk employee PATEL, Rasikubhai (A/M 6/01/52) was able to let us in the room. I observed a white female laying on the edge of the bed with a plastic tube inserted on her left thigh. MFD attempted life saving efforts but were unsuccessful. The subject was later identified as KUSCHEWSKI, Lonna A (W/F 10/10/1968).

A marijuana joint (cigar) was stuck to her body and a white/brown powder substance was observed on the dresser next to a rolled piece of paper. A crack pipe was found in the bathroom behind the door on the floor.

There is believed to be another subject that was with the victim but the subject left the scene.

At 7:17 am the motel video captured a male wearing a black jacket exiting hotel room #13. This subject got into a older white 2 door Sedan with a black rag top.

Per M.E the cause of death was due to acute mixed drug intoxication.

## Narrative (1)

### License Premise Report

Jackson, Christopher 017462

06/14/2019

This report is being written by P.O. Christopher JACKSON, assigned to District Six, Late Power Shift.

On Friday, June 14, 2019 I along with P.O. Michael WARD were assigned to the License Premise Unit, Squad 6468. At approximately 1:38am we responded to an Overdose call for service at the Suburban Motel (4600 S. 27th St. in the City of Milwaukee).

Squad 6330, P.O. Nash DATHE and P.O. Ana ROMERO-PEREZ were dispatched as the primary unit for the investigation. P.O. WARD and I arrived on scene moments after 6330 that arrived to motel room #26. Upon their arrival MFD units were assisting a black female subject later identified as Michelle D. LANIER (F/B 10-03-91). LANIER was unconscious, not breathing and unresponsive. MFD used life saving measures and was able to sustain a pulse but had to assist in her breathing. She was later conveyed by ambulance to St. Luke's hospital to receive addition medical treatment.

Also upon their arrival there was a male subject later identified as Nathanael D. POTTS (M/W 12-25-84). POTTS stated to officers that LANIER used both "Crack" Cocaine and Heroin. He stated that LANIER began to have reactions from the drugs and began to overdose. POTTS attempted to use a bottle of narcan and inject a syringe into LANIER. He did not have any positive results so he calls 911 and was given instructions over the phone for CPR.

I then spoke with the front desk clerk at the motel who was identified as Hetal PATEL (F/W 01-20-87). PATEL was only able to provide to me that both subjects were registered to the room with Wisconsin ID cards. She also was able to provide that they checked into the on 06/09/19 to 06/18/19. PATEL had no issue providing officers with any information she had.

LANIER remained in critical condition at the hospital with machine assisting in her breathing and possibly faces a danger of brain damage.

Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

## Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
  - a. Include only information relating to the above license application.
  - b. Include only information you have personally witnessed or seen.
  - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
  - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

**Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.**


