Enclosed please find a proposed resolution. We ask that it be introduced and referred to the Committee on Judiciary & Legislation, with the following recommendation.

Claimant, WE Energies, by its representative Regina Bolden, Claims-Room A145, P.O. Box 1132, Milwaukee, WI 53201-1132, alleges that on July 2, 2014 their gas main at 4234 North 30<sup>th</sup> Street was damaged when the Milwaukee Water Works excavated. Claimed damages total \$8,838.06.

Milwaukee Water Works records indicate that on July 2, 2014 they were repairing a break in an 8 inch water main at 4234 North 30<sup>th</sup> Street. During the repair process, their crew hit the claimant's properly marked gas service. The claimant

has agreed to accept a compromised settlement of \$8,665.21. Because settlement of this matter is deemed expeditious to the City of Milwaukee, we recommend settlement of this claim and have enclosed an appropriate resolution for your convenience.
