Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney of your choosing to represent you at this hearing.

You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

Tip: Sign in 10 minutes prior to the time your hearing is scheduled. Keep your phone or microphone muted until your hearing time.

Participating in the Meeting

When your item is called:

- Turn on your camera and microphone (if applicable).
- Confirm with the meeting organizer that you can be seen and/or heard.
- After confirmation is made you should mute your microphone or telephone.
- Leave your camera on or off if you desire, depending on if you want to be seen.
- If you wish to be heard during the meeting, unmute your device. When you are finished talking, mute your device again. Treat it like raising or lowering your hand.
- Make sure all background devices are off. Do not attempt to listen to the broadcast or livestream on another device. This will cause feedback, distortion and reverberation for all participants.
- Make sure to speak clearly into the mic on your device.
- If you are going to appear on camera, try to frame and light yourself properly. Avoid lighted or flat backgrounds. Find a quiet and undisturbed place to present yourself during your hearing.

On Tuesday August 6th, 2024, at approximately 4:18 PM I (squad 6230) was dispatched to the address of 3701 S Howell Ave. (Walgreens) which is located in the City and County of Milwaukee.

investigation:

Upon my arrival, I was met by manager Amy MARKOWSKI (W/F 09-26-1968), who stated on August 6th, 2024, at approximately 9:30 AM, a known retail theft suspect Vernell C. ANDERSON (B/M, 12/3/90), intentionally and without consent, carried away merchandise held for resale by Walgreens, passing the last point of purchase, causing the business permanent loss of its properties value (totaling \$44.97).

MARKOWSKI stated, ANDERSON entered the Walgreens, browsed the store aisles, took the listed items off of store shelves, and fled the scene with said items passing the last point of purchase.

I reviewed the stores security camera footage which confirms MARKOWSKI's description of ANDERSON and him walking out of the store with said items.

A DOT check revealed that ANDERSON is currently on active probation and has a warrant.

While on scene, I observed the business licenses posted, and they were up to date. During my investigation for the Retail Theft call for service, I did not observe any violations in the licensed premise.

A PV-17 and a Community Contact card has been issued.
