Shooting was related to an earlier altercation between a friend of the victims and one of the suspects over a Female while in the tavern.

4. On 10/08/2006 at 12:45am the Milwaukee Police Department conducted a lawful inspection of the licensed premise, Side Pocket Sports Bar at 9316 W Appleton Av. Upon arrival, Officers conducted a preliminary count of the amount of persons in the premises and it was determined that they were over posted capacity. Officers advised the staff they had to do an official count as the people exited the main doors the count was 187 people plus the 24 staff totaling 211 which exceeds the capacity by 71 people. A citation for over capacity was issued to licensee STREGE, John W.

5. On 10/21/2006 at 1:33am, Milwaukee Police Department squads were dispatched to Side Pocket Sports Bar 9316 W Appleton Av for a possible shooting complaint. Investigation at the scene revealed that a B/M named RUTLEDGE, Ronnie A (07/17/1975) had been jumped and sustained a laceration above left eye and bleeding from the ear. The injuries required 10 stitches at St Joseph's Hospital. The bar manager, Robert MITCHELL (B/M, 12/10/1960) stated he had escorted RUTLEDGE from the bar 20 minutes prior for attempting to take another unknown B/M's necklace. Then at about 1:30am MITCHELL observed a group of unknown B/M's jumping on one male. MITCHELL also stated he did not hear any shots being fired. Side Pocket Sports Bar was not cited for any of these incidents.
6. On 06/24/2007 at 12:50am, Milwaukee Police Department squads were dispatched to Side Pocket Sports Bar 9316 W Appleton Av for a shooting. Investigation at the scene revealed that there was a B/M named SMITH, Grayson P (04/23/1983) that involved in a fight inside the bar and was escorted by security outside the premises as well as other subjects. Once SMITH was outside he produced a firearm and fired shots towards patrons and security. Security guard KAASCH, Herbert K (W/M, 09/20/1978) returned fire and struck SMITH.

Freezing temperatures, icy roads cause accidents

Frost and freezing temperatures created icy spots that contributed to dozens of accidents on Milwaukee County freeways early Sunday that included two Milwaukee County sheriff's office vehicles.

The National Weather Service near Sullivan said patches of fog and temperatures in the high 20s also led to the slick roads.

Trouble spots occurred at bridges, underpasses and ramps, said sheriff's spokeswoman Kim Brooks.

Deputies responded to 39 accidents from 6:30 to about 10 a.m., a sheriff's dispatcher said. Eleven of the accidents involved injuries.

Brooks said part of the Marquette Interchange was briefly shut down to clear accident wreckage.

The first squad car was struck on southbound I-43 at Hampton Ave. About an hour later, another squad car was struck at U.S. Highway 45 and Capitol Drive. Both were stopped in emergency lanes when struck by passing vehicles, Brooks said. No deputies were injured.

Police report three people shot Sunday morning

Three people were shot early Sunday in Milwaukee, two at gasoline stations on the north and west sides and a third outside a northwest side tavern, police reported.

A 23-year-old woman was shot in the buttocks at 1:15 a.m. when a gunman inside a blue Monte Carlo sedan fired into a group standing outside of Side Pockets in the 9300 block of W. Appleton Ave.

Neither a fight nor other disturbances had occurred in the tavern before the shooting, leading police to speculate that the shooting was random.

About 12:30 a.m., a 24-year-old man was shot in the left leg at a gas station in the 2700 block of W. Clarke St., police said. He was on foot when shot and told police he was not the intended target.


This is to notify you that on October 30, 2006 the City's Licenses Committee voted to recommend to the City's Common Council that your renewal application for a Class "B" Tavern and Tavern Dance license for the premises at 9316 West Appleton Avenue ("Si de Pocket Sports Bar") be approved with a ten (10) day suspension based upon a police report.

On November 2, 2006 you were sent a true and correct copy of the findings of fact, conclusions of law and recommendations of the Licenses Committee with respect to your renewal application for a Class "B" Tavern and Tavern Dance license in which the Committee recommended that your renewal application be approved with a ten (10) day suspension. You were further notified that the Milwaukee Common Council would consider the matter at its meeting of November 14, 2006 commencing at 9:00 a.m. in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin. 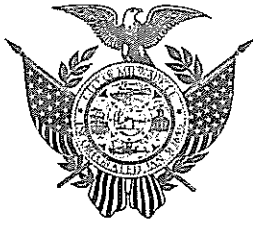

Re: Report of the Renewal Application of John N. Strege, as agent for "Strege, LLC." for a Class "B" Tavern and Tavern Dance license for the premises located at 9316 West Appleton Avenue in the City and County of Milwaukee, Wisconsin ("Side Pocket Sports Bar").

FINDINGS OF FACT

1. John N. Strege (hereinafter the "Licensee") is the agent for "Strege, LLC" doing business at 9316 West Appleton Avenue in the City and County of Milwaukee, Wisconsin ("Side Pocket Sports Bar"). Said license expires at midnight, December 19, 2006.
2. An application to renew said license was filed with the Office of the City Clerk on September 26, 2006.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a report that could form the basis of non-renewal or suspension of this license on September 27, 2006.
4. On October 20, 2006, the City Clerk's Office provided notice to the Licensee, pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the police report that could form the basis for suspension or non-renewal of the license of the Licensee and included a copy of the police report. The matter was scheduled for a hearing on the police report on October 30, 2006 at 9:15 a.m. in Room 301B of the third floor of City Hall. At said date, time and place the licensee appeared at the hearing and also admitted service of the notice of hearing. The Licensee was represented by Attorney Joseph T. Ganzer, 7161 North Port Washington Road, Milwaukee, WI 53217.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
- A. On August 31, 2005, at 5:15 p.m. an underage police aide, under the direction of officers of the Milwaukee Police Department, purchased beer from a bartender at the licensed premises at 9316 West Appleton Avenue. The applicant who was not on the scene was not cited. The bartender was cited and had an initial appearance on October 18, 2005.
 - B. On March 11, 2006 at 11:45 p.m., the applicant received a citation for posting of occupancy capacity at the licensed premises at 9316 West Appleton Avenue ("Side Pocket Sports Bar"). On May 31, 2006 he was found guilty and fined \$5,000.
 - C. On October 8, 2006 at 12:45 a.m. officers of the Milwaukee Police Department conducted a lawful inspection of the licensed premises at 9316 West Appleton Avenue ("Side Pocket Sports Bar"). Upon their arrival, officers conducted a preliminary count of the number of persons in the premises and it was determined that they were over posted capacity. Officers advised the staff that they had to do an official count as the people exited the main doors and the count was 197 people plus the 24 staff totaling 221 persons which exceeded the capacity by 71 persons. A citation for over capacity was issued to the licensee which is pending a hearing date on November 29, 2006.
 - D. At hearing, the Committee was informed that the licensee admits responsibility for the over capacity situation occurring on March 11, 2006, but denied he was over capacity and disputes the accuracy of the count for the incident of October 8, 2006, and is thus contesting it. The reason for the over capacity on March 11, 2006 is because he sponsors two teams, and they were both in the premises at the same time with their friends on the date in question.
 - E. There are no neighbors in the immediate vicinity of this premises, and it is very popular. That accounts for the fact that there were no neighborhood objections to the operation of this premise.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provided Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee concludes that the licensee,

John W. Strege, as agent for "Strege, LLC" at 9316 West Appleton Avenue has not met the criteria of Chapter 90 of the Milwaukee Code of Ordinances or Chapter 125 of the Wisconsin Statutes to allow renewal of his Class "B" Tavern and Tavern Dance license without undergoing a ten (10) day suspension. The Committee finds the police and report to be true.


3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Class "B" Tavern and Tavern Dance license of John W. Strege, as agent for "Strege, LLC" for the premises located at 9316 West Appleton Avenue with a ten (10) day suspension.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noes and one (1) excused recommends that the Class "B" Tavern and Tavern Dance license of John W. Strege, as agent for "Strege, LLC" for the premises located at 9316 West Appleton Avenue be renewed with a ten (10) day suspension.

Said suspension is to be in effect from 12:01 a.m. December 20, 2006 through midnight, December 29, 2006.

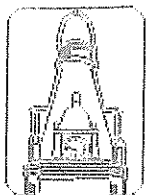
