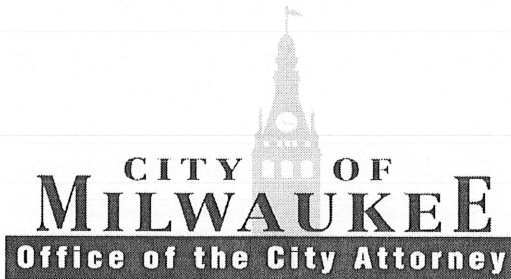

Dear Council Members:

Hupy & Abraham, S.C. alleges that on December 27, 2020 their client sustained injuries when the tire of her bicycle caught in the streetcar tracks while she was traveling at/near North 2<sup>nd</sup> Street and West St. Paul Avenue. Claimed damages total \$50,000.00.

The Infrastructure Services Division indicates that the streetcar tracks at/near North 2<sup>nd</sup> Street and West St. Paul Avenue were constructed in accordance with the standard specifications, plans, and accepted standards for streetcar infrastructure. This project was constructed and completed under a City of Milwaukee contract. The work was performed by Kiewit Infrastructure Company.

There is no evidence that the City was negligent. Therefore, we recommend that this claim be denied.
