Dear Ms. Conner:

We have received your claim in the amount of \$913.52 in relation to damage to your washing machine and furniture, allegedly occurring on December 28, 2022 when the Milwaukee Police searched your residence.

Our investigation determined the Milwaukee Police Department responded to your residence on a tip regarding a Subject Wanted on December 28, 2022. Wanted suspects were ordered to come out of the basement, apprehended and taken into custody. You agreed to a Consent to Search and officers searched the premises. Their search included looking under couch cushions and in the washer and dryer, where guns were recovered.

It is our position that the police department acted within the scope of their responsibility, and the action taken in this matter was necessary and appropriate for the circumstances in this case. As such, the City of Milwaukee would not be liable. Therefore, we are denying your claim.


