PLEASE TAKE NOTICE that on June 11, 2002, MATTIE HUTSON of 6836 N. Appleton,
#3, Milwaukee Wisconsin, became ill after drinking tap water provided by the CITY OF
MILWAUKEE.

PLEASE TAKE FURTHER NOTICE that as a proximate result of said incident, MATTIE
HUTSON, sustained personal injuries which necessitated medical care and attention; furthermore,
these injuries may be permanent in nature.

Liability for the injuries is claimed as follows:

The CITY OF MILWAUKEE on account of its liability for the acts of its agents and
employees, and particularly the MILWAUKEE WATER WORKS and an unknown employee, as
further set forth in this Notice of Injury and Claim for Damages, who was acting within the scope of
his/her employment at the time of said incident.

The said incident was caused by the negligence of said MILWAUKEE WATER WORKS on
account of its unknown employee, for his/her in allowing tainted water supply to be sent to MATTIE
HUTSON at her above address.


As a proximate result of the above-described negligence, MATTIE HUTSON, sustained personal injuries to her person causing her to incur medical bills and expenses, loss of earnings, loss of future earning capacity, and past and future pain and suffering as itemized below:

<u>MEDICAL EXPENSES:</u>	\$5,000.00
<u>WAGE LOSS:</u>	N/A
<u>PAST AND FUTURE PAIN AND SUFFERING:</u>	\$15,000.00
<u>TOTAL CLAIM:</u>	\$20,000.00

WHEREFORE, MATTIE HUTSON demands Twenty Thousand Dollars and No/100 (\$20,000.00) from said CITY OF MILWAUKEE and MILWAUKEE WATER WORKS.
