QUIT CLAIM DEED

Sanitary sewer, manholes and appurtenances thereto located in the Northeast one-quarter (NE ¼) of Section 26, Township 8 North, Range 21 East in the City of Milwaukee, County of Milwaukee, State of Wisconsin, more particularly described as follows, to-wit:

A 21-inch diameter circular sanitary sewer beginning at the center line of a sanitary sewer

manhole located seven-tenths (0.7) feet north from a point of intersection of North line of West Douglas Road and East line of North Hopkins Street and twenty-four and four tenths (24.4) feet west of the east line of North Hopkins Street;

Thence North 7° 50′ 25″ East, two hundred sixty and six tenths (260.6) feet to the center of

a sanitary sewer manhole;
