

Dear Mr. Grant:

We are in receipt of your claim regarding damages to your door, on August 10, 2024, when Milwaukee Police made forced entry at the property located at 3920 N. Port Washington Road.

Our investigation revealed that Milwaukee Police Department (MPD) undertook the necessary and appropriate action in response to a suicide call on August 10, 2024, at the subject location.

When MPD arrived at your property, officers knocked and rang the ring doorbell several times which was not audible, announced themselves, and proceeded to force entry in order to conduct a welfare check and no one was found inside.

It is our position that the Milwaukee Police Department followed standard procedure and exercised the appropriate action in this forced entry. As such, the City would not be liable for damages and we are denying your claim.
