On Friday April 25th, 2025 at approximately 9:30 PM I was dispatched to a welfare complaint located at S. 27th st & W. Euclid Ave. Upon arrival, the updated address was the BP gas station at 3200 S. 27th St, which is located in the City and county of Milwaukee.

Upon arrival, I observed subject later identified as BAKALARSKI, Kyle R. (W/M, 09/04/1984) sitting and rolling on the ground in the lot. I observed BAKALARSKI to not wear any shoes or socks on his feet. I also observed BAKALARSKI to ramble as he spoke as well as a white foam around his mouth.

MFD Red Shift, E-12, Captain. LESZCZYNSKI responded to the scene to provide medical for BAKALARSKI.

Upon speaking with MFD personnel, I was informed that BAKALARSKI stated he used the narcotic crystal meth. I observed BAKALARSKI to experience a form of excited delirium. MFD personnel informed me that BAKALARSKI was observed rolling on the ground in his own feces. BAKALARSKI was deemed by MFD and MPD (myself and PO TORRES) unacable of caring for himself in his current state.

As BAKALARSKI continued to roll on the ground, kick his legs, and swing his arms, I asked him "where did you get the crystal meth from". BAKALARSKI whispered to me "those folks over there, there standing over there" directing my attention to three unknown H/M subjects standing in front of four (4) vehicles parked in the parking spaces in front of the entrance door to the premise.

BAKALARSKI was ultimately conveyed to Aurora St. Luke's for medical attention.

Upon entering the location, I approached the cash register and requested to review surveillance footage. The unknown subject behind the counter stated he does not work at the location and that he does not have access to the cameras. I then observed a second unknown subject standing behind the counter and asked him if he was an employee at the location and he stated he is not an employee and does have access to the footage. Subject later identified as Adil MOHAMMED (M/A, DOB 03/07/2000) stated he is an employee at the location but only helps out sometimes. MOHAMMED stated he only works at the location one to two days a week from 6:30 PM to 12:00 AM.

I then conducted a brief walk through of the location. I observed numerous frozen food items with no "SELL BY" date stamped on packaging. I located an opened frozen sandwich in the freezer for sale.

As I was finishing my walk through of the premise, I observed MOHAMMED sitting in a chair in a side

room. I then observed MOHAMMED'S eye begin to roll as he fainted and slide onto the ground from his chair. I then requested medical attention.

One of the two unknown subjects yelled "you scared him?" to me, as MOHAMMED regained consciousness. MOHAMMED stated he had not ate and and that is why he fainted. MOHAMMED ultimately denied medical upon MFD E-13, Red Shift'S arrival.

The hearing before the Licenses Committee will take place on 7/22/2025 at 9:20 AM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
