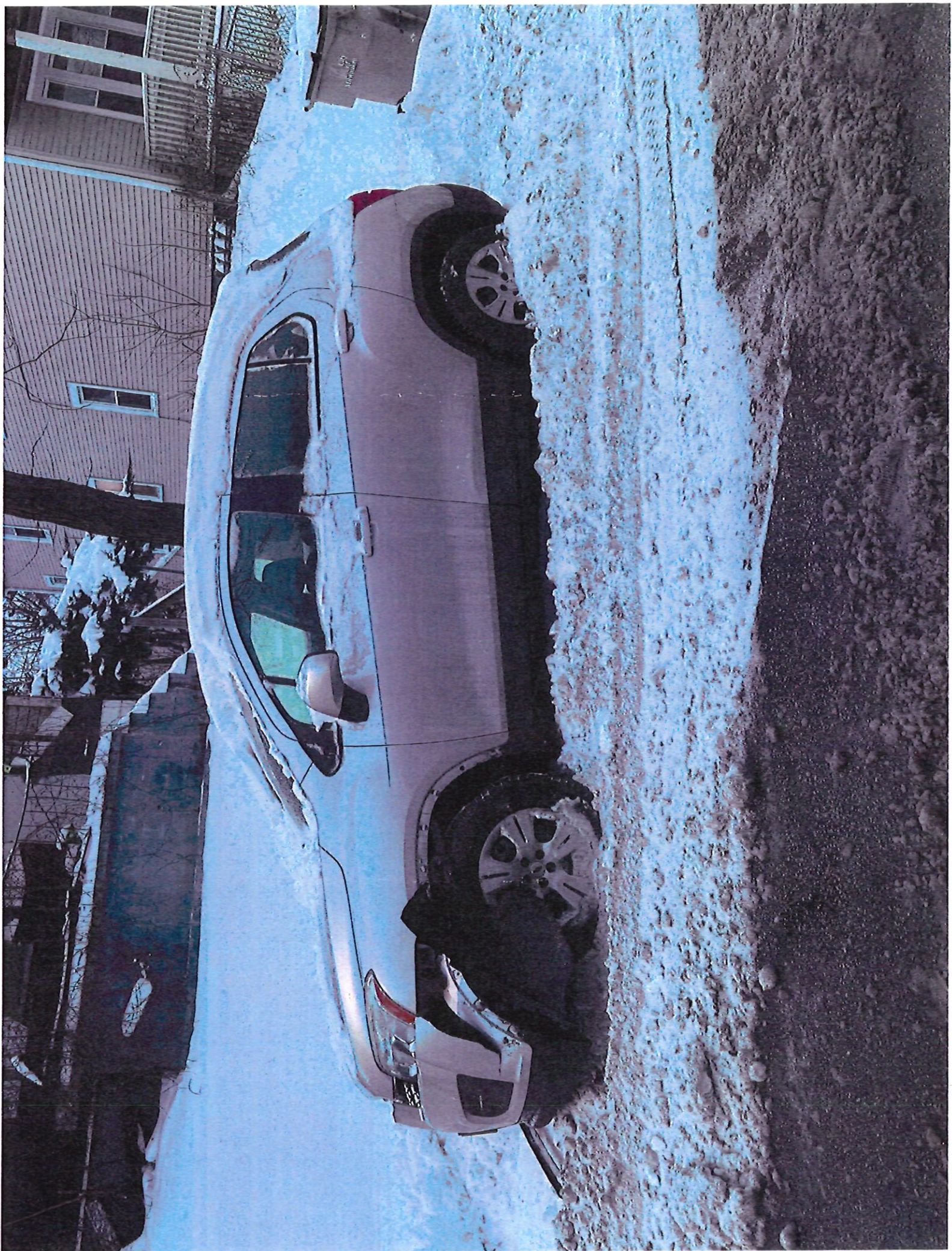

Dear Ms. King:

We have received your claim in the amount of \$4,119.36, in regards to vehicle damage you sustained on February 16, 2025 at 305 North Buffum Street when it was allegedly struck by a City truck.

Our investigation reveals that while there is no conclusive evidence that a City plow truck struck your vehicle, City trucks were in the area on the day in question. However, since you are no longer in possession of the vehicle we are not able to ascertain the damages. In addition, you have not provided evidence that you have paid for damages in this case. Accordingly, we are unable to accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.
