
With regard to the items listed above, the Public Safety Committee held an evidentiary hearing on October 5, 2006.

Re: Report of the Renewal Application of Duryea D. Dixon for a Public Passenger Vehicle Driver License.

#### FINDINGS OF FACT

1. Duryea D. Dixon (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, October 31, 2006.
2. An application to renew said license was filed with the Office of the City Clerk on September 6, 2006.
3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed an objection to renewal of this license dated September 7, 2006. That objection could form the basis of non-renewal or suspension of this license.
4. On September 19, 2006, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of police objections that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 5, 2006 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did appear and admitted receipt of the notice and was not represented by counsel.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. On September 29, 1991 the applicant was cited by the Milwaukee police for carrying a concealed weapon. The applicant was charged with this offense and found guilty on October 24, 1991 and fined \$265.00.
  - B. On May 7, 1997 the applicant was cited by the Milwaukee police for noise nuisance. The applicant was charged with this offense and found guilty on June 25, 1997 and fined \$203.35.
  - C. On October 1, 2001 the applicant was cited by the Milwaukee police for loitering and prowling. The applicant was charged with this offense and found guilty on February 6, 2002 and fined \$115.00.
  - D. On November 12, 2005 the applicant was charged in Milwaukee County with inappropriate personal ID and on April 3, 2006 was found guilty. The applicant was sentenced to 2 years in prison and 3 years extended supervision, 5 years probation and 9 months in the House of Corrections. The applicant is on probation until June 7, 2011.
  - E. On January 26, 2006 the applicant was charged in Milwaukee County with theft-false representation and on April 3, 2006 was found guilty. The applicant was sentenced to 2 years in prison and 3 years extended supervision, 5 years probation and 9 months in the House of Corrections.

#### CONCLUSIONS OF LAW


1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Duryea D. Dixon, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license without undergoing a thirty (30) day suspension based upon the police report.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Public Passenger Vehicle Driver license held by Duryea D. Dixon with a thirty (30) day suspension based upon the police report.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes, zero (0) noes and one (1) excused, recommends that the Public Passenger Vehicle Driver license of Duryea D. Dixon be renewed with a thirty (30) day suspension based upon the police report.

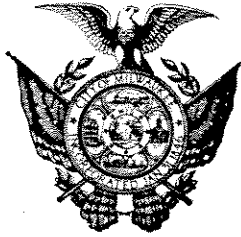

1. Khurram Khan (hereinafter the "Licensee") is the holder of a Public Passenger Vehicle Driver license in the City and County of Milwaukee, Wisconsin. Said license expires at midnight, October 31, 2006.
2. An application to renew said license was filed with the Office of the City Clerk on August 31, 2006.
3. Pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department filed an objection to renewal of this license dated September 1, 2006. That objection could form the basis of non-renewal or suspension of this license.
4. On September 19, 2006, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of police objections that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. 3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to renew the Public Passenger Vehicle Driver license held by Khurram Khan with a ninety (90) day suspension based upon the police report.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes, one (1) noe, and one (1) excused, recommends that the Public Passenger Vehicle Driver license of Khurram Khan be renewed with a ninety (90) day suspension based upon the police report.

Said suspension is to be in effect between 12:01, November 1, 2006 through midnight, January 29, 2007.

The Milwaukee Police Department filed an objection to renewal of this license dated August 29, 2006. That objection could form the basis of non-renewal or suspension of this license.
4. On September 19, 2006, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of police objections that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. May with a ten (10) day suspension based upon the police report.



On September 21, 2006, the City Clerk's Office provided timely notice to the Licensee, pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24 of the Wisconsin Statutes of police objections that could form the basis for suspension or non-renewal of the license of the licensee and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police report on October 5, 2006 at 9:00 a.m. in Room 301B of City Hall. At said date, time and place, the licensee did not appear.

5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
  - A. Notice was sent to Steven Walker at 5947 North 65<sup>th</sup> Street, Milwaukee, WI 53218, along with a copy of the police report on September 21, 2006 in an envelope which was sent by U.S. first-class prepaid mail in an envelope bearing the return address of the License Division, 200 East Wells Street, Room 105, Milwaukee, WI 53202. The address of 5947 North 65<sup>th</sup> Street, Milwaukee, WI 53218 was the address given by the applicant on his renewal application. The notice included a copy of the police report. The licensee failed to appear at the hearing and the envelope containing the notice and police report was not returned to the License Division by the U.S. Postal Service.
  - B. On July 19, 2006, the applicant was cited by the Milwaukee County Sheriff's Department for possession of alcoholic beverages. The applicant was charged with this offense on August 23, 2006 and fined \$279.00. The applicant also has a warrant with the City of Franklin Police Department for expired registration.


#### CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact and Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 100 of the Milwaukee Code of Ordinances and § 349.24, Wisconsin Statutes.
2. Based upon the above facts found, the Committee concludes that the licensee, Steven Walker, has not met the criteria of Chapter 100 of the Milwaukee Code of Ordinances or § 349.24 of the Wisconsin Statutes to allow renewal of his Public Passenger Vehicle Driver license based upon non-appearance.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Public Safety Committee that the full Common Council of the City of Milwaukee should exercise its judgment to not renew the Public Passenger Vehicle Driver license held by Steven Walker based upon non-appearance.

#### RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes, zero (0) noes and one (1) excused recommends that the Public Passenger Vehicle Driver license of Steven Walker not be renewed based upon non-appearance.
