## **DEAR PERSON OF INTEREST:**

The Common Council has referred File No. 240250 to the City Plan Commission (CPC) for recommendation. This file relates to the change in zoning from Local Business, LB2, to Two-Family Residential, RT4, on the western portion of 1585 South Cesar E. Chavez Drive, located on the north side of West Lapham Street, west of South Cesar E. Chavez Drive, in the 12th Aldermanic District.

This zoning change was requested by Ristic Joint Revocable Trust and will allow the applicant to purchase a portion of the subject site from the City of Milwaukee and add it to their residential lot at 1610 West Lapham Street. The applicant plans to construct a driveway next to their existing residence for off-street parking. Please refer to the reverse side of this notice for map details.
