There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. It is the intention of the Common Council to suspend or non-renew the licenses if objectors provide testimony related to the factors enumerated in MCO 85-4-4 that the Common Council finds to be true by a preponderance of the evidence and/or police reports are found to be true by a preponderance of the evidence. The police reports and other attached documents relating to objections to the license are a part of this notice and expressly incorporated in this notice. The licensee should be prepared to address these matters at the hearing.

Notice for applicants with warrants or unpaid fines:

Proof of warrant satisfaction or payment of fines must be submitted at the hearing on the above date and time. Failure to comply with this requirement may result in a delay of the granting/denial of your application.

Failure to appear at this meeting may result in the denial of your license. Individual applicants must appear only in person or by an attorney. Corporate or Limited Liability applicants must appear only by the agent designated on the application or by an attorney. Partnership applicants must appear by a partner listed on the application or by an attorney. If you wish to do so and at your own expense, you may be accompanied by an attorney of your choosing to represent you at this hearing. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing. You may examine the application file at this office during regular business hours prior to the hearing date.  4. On 01/27/2019 officers responded a shooting at Eve Lounge, 6222 W. Fond du lac Av. The investigation revealed there was an altercation between patrons inside the tavern. Security guards attempted to separate the parties and pushed them outside. Once outside one subject went to his auto, obtained a gun and began shooting. The victim was shot outside and died from her injuries. The officers spoke with the applicant who stated there is a security guard at the front door checking ID's. The security guard at the door also uses a metal detector and pats down patrons. There is also additional security inside, but that depends on the day of the week.
5. On 03/14/2019 officers conducted underage tavern enforcement in District 7. An underage Police Aid attempted to gain entry to Eve Lounge, 6222 W. Fond du lac Av. The Police Aid stated there was no security at the door. The Police Aid went to the bar and purchased a Miller Lite beer for \$3.00. The bartender was identified and was cited. The bartender did not have a Class D Operators license.

 6. On 07/06/2019 at 6:22am officers were dispatched to Eve's Lounge for a Sexual Assault Complaint. The caller stated she stayed in the bar after hours and the owner sexually assaulted her. The officer spoke with the applicant who stated he did ask the victim to stay after hours and was serving her drinks. He admitted that they engaged in sexual activity inside the bar. The applicant was taken into custody and the case was no processed by the District Attorney.
7. On 12/02/2019 at 12:55am officers were dispatched to a Subject with Gun at Eve's Lounge, 6222 W. Fond du lac Av. The officers spoke with the applicant, who stated a subject was stopped by security and asked to produce ID. The subject became agitated and threatened to shoot up the bar. No gun was seen, just threatened. The staff was cooperative with the officers.
8. On 12/18/2019 at 9:10pm officers conducted a licensed premise check at Eve's Lounge, 6222 W. Fond du lac Av. The officer spoke with the bartender and asked to see her Class D Operator's license. She was not able to produce it and the officers checked LIRA, which

confirmed that the bartender did not have a Class D issued. The bartender was cited for bartending without a license and the applicant was cited for Responsible Person on Premise.

9. On 01/24/2020 at 2:09am officers conducted a licensed premise check at Eve's Lounge, 6222 W. Fond du lac Av. The officer asked the applicant about the Hookah he has at the tavern. The applicant advised it is non-nicotine tobacco. The officer advised the applicant to cease selling any tobacco until he has the proper license.
10. On 03/02/2020 at 1:19am officers were flagged down by security at Eve's Lounge, 6222 W. Fond du lac Av., regarding subjects driving around with guns. The officer spoke with security who stated they denied entry to two subjects, who became upset. The guards escorted them to their cars, at which point one subject opened his trunk and the guard saw a gun in the trunk. The guard quickly closed the trunk and told the subjects to leave. The subjects did leave but made a u-turn and drove by again. That's when the security guard flagged down the police. The subjects were stopped but no gun was found. The applicant was on scene during the investigation. The security guards became upset when the officer advised a tavern report would be filed.
11. On 03/14/2020 at 1:45am officers responded to a Shots Fired complaint at Eve's Fine Dining, 6222 W. Fond du lac Av. The investigation revealed two subject who were denied entry produced firearms and fired at the building entrance. An armed security guard used his service weapon and fired at the subjects. Officer's recovered 10 to 20 casings and five vehicles damaged from the bullet strikes. Security stated a subject who was part of a large group that was denied entry, became upset and punched the applicant in the chest. The subject then produced a firearm and began to fire shots. A second subject than produced a firearm and also began to shoot toward the business. Security produced his firearm and fired 13 shots towards the individuals. The applicant was on scene and cooperative. The cameras could not be viewed that night but stated the officers could return on 03/16/2020 to view the video.
12. On 04/18/2020 at 9:15pm officers observed 13 vehicles parked in front of Eve's Fine Dining, 6222 W. Fond du lac Av. The officer entered the business and observed 12 people inside the business with 6-7 of the people sitting at the bar with drinks on the bar in front of them. The applicant was behind the bar blending up what he described as "slushies", which did contain alcohol. The applicant thought he could sell the drinks to go if he covered them with saran wrap. There were also people standing on the dance floor. The applicant stated most of the people were employees, which included 3 cooks, 3 security guards and 2 DJ's. The other people were customers waiting for food. The officers checked the kitchen and found no food being prepared and the fryers where not turned on. The applicant was advised he could not sell alcohol in "to go cups", he could not have more than 10 people inside, including employees, and customers could not consume any food or drink inside.

13. On 05/28/20 at 1:21am, Milwaukee Police were dispatched to 6222 N. Fond Du Lac Avenue for a tavern violation. Upon arrival, officers observed several patrons exit the tavern, patrons dancing in the streets blocking traffic, and patrons hanging outside their vehicles, speeding up

and down W. Fond Du Lac Avenue. There was only one security guard outside trying to move patrons, but nobody was listening. Officers interviewed the applicant who stated that there is no order enforcing him to be closed and that his lawyer told him he has a right to be open. The applicant was in violation of mostly every requirement contained in the order and the applicant did not believe the information provided to him by officers. The applicant said that he contacted four district stations and he stated that the officers at those districts said he could be open. The applicant said he had documentation of this but was unable to provide that information to officers. On a later date, officers conducted follow-up on the incident and the applicant said he understood the order now but was misinformed by police on the original incident.

14. On 06/11/20 at 10:00pm, Milwaukee Police conducted a license premise check at 6222 W. Fond Du Lac Avenue. The officers informed the applicant of the mayors reopening plan and the applicant said he understood.
15. On 07/26/20 at 12:23am, Milwaukee Police conducted a license premise check at 6222 N. Fond Du Lac Avenue. Upon arrival, officers entered the establishment and observed far more than the 50% capacity limit set by the city. Officers asked the front door security how many people were in the establishment and he told officers there were 94 patrons which is above the 50 person maximum. The applicant was advised that he could only have 50 patrons.
16. On 12/02/20 at 1:45am, Milwaukee Police were dispatched to 6222 W. Fond Du Lac Avenue for a theft complaint. Investigation revealed that a patron left her person on a table and went to the bathroom, when she returned, he purse was missing. The applicant told the patron and officers that he would look at surveillance cameras in the morning.
17. On 01/24/21 at 2:00am, Milwaukee Police were dispatched to St. Joseph's Hospital for a shooting complaint. The victim stated that he was shot when exiting a vehicle which was parked near the side of 6222 W. Fond Du Lac Avenue. The victim stated they parked near Eve's dining and his friends told him to go check it out. While exiting the car he heard five to six shots and his friends drove off. No contact was made to Eve's dining from the victim or the initial officers.

18. On 06/05/21 at 10:30pm, Milwaukee Police were dispatched to 6222 W. Fond Du Lac Avenue for a subject with gun complaint. Investigation revealed that the bartender heard from security that there was a subject outside of the tavern who may have a weapon. The bartender just wanted officers present to help prevent crime.
19. On 06/16/21 at 3:23am, a subject walked into the Seventh District to report an E.S.B.U.D.W which occurred at 6222 W. Fond Du Lac Avenue. The subject, who works as security at that location, stated that a subject pointed a handgun at him and shot it one time in the air.
20. On 12/13/21 at 1:35am, Milwaukee Police responded to 6222 W. Fond Du Lac Avenue for a fight complaint. Upon arrival, officers observed 20-30 spill out of the tavern fighting which traveled into the busy street. Multiple security guards and Milwaukee Police Officers split up the subjects fighting. The applicant told officers that the subjects fighting were all family and were mourning the death of another family member.

21. On 01/01/22 at 2:20am, Milwaukee Police were dispatched to 6222 W. Fond Du Lac Avenue for a shots fired complaint. Investigation revealed that a fight happened inside the establishment where a female sprayed "pepper spray" during the fight and outside, a subject fired a handgun into the air during another fight. The applicant was on scene and was mostly cooperative with the investigation.

22. On 09/02/22 at 4:30pm, a victim walked into the Seventh District to report a theft that happened at 6222 W. Fond Du Lac Avenue. The victim was the applicant of the tavern and he told officers that a bartender was stealing money from the business. He was cooperative with the investigation and will be obtaining the video evidence of the incident.

23. On 09/10/22 at 1:50am, Milwaukee Police were dispatched to 6222 W. Fond du Lac Avenue for a personal injury accident. Investigation revealed that a patron was escorted out by security and while she was across the street, was struck by a vehicle. The applicant was cooperative with police but security either left directly after the incident or were uncooperative with answering questions regarding the incident.

24. On 11/17/22 Milwaukee Police were dispatched to 6222 W. Fond du Lac Avenue for a subject with gun complaint. The officers found the assignment to be unfounded/baseless and advised the people they talked to.

25. On 11/17/22 at 1:39a.m., Milwaukee Police were dispatched to a Shooting at 6241 W. Fond du Lac. Investigation revealed a patron was leaving Eve's Lounge at 6222 W. Fond du Lac Av., when they heard gunshots and was shot in the knee. Officers check the scene and located casings in the street in front of 6241 W. Fond du Lac. Officers then interviewed the manager, who stated security was made aware of an argument outside regarding a fender bender and went outside. The bar manager advised security to come back inside, and as they were crossing the street, heard gunfire. The employee was cooperative with the investigation.

26. On 11/27/22 Milwaukee Police were dispatched to 6222 W. Fond du Lac Avenue for a subject with gun complaint. The officers were unable to locate the complainant.

27. On 12/14/22 at 1:44am, Milwaukee Police were dispatched to 6222 W. Fond Du Lac Avenue for a subject with gun complaint. Investigation revealed that three subjects were not allowed inside the tavern because they refused to remove their ski masks. The subjects were observed with firearms and circled the area but left before police arrival.

28. On 02/01/23 at 10:36pm, Milwaukee Police were dispatched to 6222 W. Fond Du Lac Avenue for a shooting complaint. Upon arrival, officers observed a drop of blood on the front steps of the tavern but all the employees at the establishment stated that there was no shooting at the location. The manager refused to speak to officers and only did because the applicant told her she could. The staff at the tavern were already cleaning up the establishment and mopping the floor. Later, officers found a casing and bullet fragment in one of the garbage bags and located another bullet fragment in the bar area. The surveillance video was unplugged which would have captured the incident and it was later learned that the shooter walked out of the tavern while police were on scene and nobody informed the officers so they could have taken him into custody. The shooter worked at the establishment. It also appeared that the establishment was selling Hookah without a tobacco license.

29. On 02/05/23 Milwaukee Police were dispatched to 6222 W. Fond du Lac Avenue for a fight complaint. The officers filed a report.
30. On 04/01/23 at 12:41am, Milwaukee Police were dispatched to 6222 W. Fond Du Lac Avenue for a trouble with subject complaint. Investigation revealed that a patron had lost his key and wanted the tavern to turn off the music and help him look for his keys. When the tavern refused, he became highly agitated. The subject towed his vehicle home. The employees did not request the police and said they would look for the keys after the tavern was closed.

Agent/Owner:

On scene, I spoke with the owner of the Tavern, identified as Thomas J. HOLMES (B/M, 08-19-1957). HOLMES stated that a female had been acting belligerent in the bar and had to be escorted out by an unknown security guard. The female, later identified as the victim of this incident, was then struck by a vehicle across the street from Eve Lounge, near her vehicle which was parked on the street on W Fond Du Lac Av.

Owner/Agent:

On Wednesday, February 1, 2023, while in full duty uniform and with an Axon body-worn camera activated and in a marked squad, my partner (P.O. Brian BAKER) and I were dispatched to a Shooting located at 6222 W Fond Du Lac Ave (Eve's Lounge), which is located in the City and County of Milwaukee. The victim of the shooting had walked into St. Joseph's Hospital and stated that he was shot at Eve's Lounge.

Upon arrival, we met with Squad 7250 (PO SROMALLA & PO WASZAK), who had located a drop of blood on the front steps of the premises. When squad 7250 first arrived on scene and asked if a shooting had occurred at the bar, they were told "no." PO WASZAK asked if there were any altercations at all at the bar tonight, and were again told "no." The officers were told by employees that "nothing happened in the bar all night" and they were closing the bar early due to it being a "slow night." PO WASZAK observed that the floor was already being mopped.

All of the employees officers spoke with initially were not forthcoming with information and were concealing what had actually occurred.

I confronted the manager (DENNIS, Laquita R, F/B 05-19-90) about what had happened, and she refused to speak with me until she spoke with the owner of the establishment (HOLMES, Thomas J, M/B 08-19-57), who told her it was okay to speak with me. DENNIS then finally revealed that there had in fact been a shooting in the bar.

I attempted to watch video footage of the incident from one of the many cameras in the bar, however, HOLMES stated that the cameras had all been unplugged. I reviewed the app on HOLMES' phone that views the cameras, and it showed that the cameras had been unplugged for at least a week. All of the

interior cameras are run off of a single power strip behind the bar, and HOLMES claimed that the garbage can behind the bar often bumps into the plug and unplugs it. HOLMES feigned disappointment that the cameras had not recorded the incident. The only functioning camera only records a 16 second clip when it sees motion and did not record the actual moment of the shooting. HOLMES' demeanor was nervous and he appeared to be lying when I asked him about the identity of the suspect. HOLMES stated that a person he knows only as "Reed (first name)" rents the kitchen from him, and his son, who he only knew as "Taz" just recently started working there as well. HOLMES claimed that "Reed" rents the kitchen at Eve's and he is not on Eve's payroll.

I attempted to speak with another employee/witness (DE LEON LACEND, Alexander M, M/W-H, 03-21-01). DE LEON LACEND is a trainee learning how to tend bar. DE LEON LACEND claimed he had seen nothing happen tonight.

Prior to police arrival, employees at the bar had cleaned up the crime scene and we located a cartridge and a bullet fragment in one of the trash bags. We also located another bullet fragment in the bar area and a bullet strike to the bar itself.

None of the at least 6 employees on scene called 911 after someone was shot inside the bar. Instead, they chose to call the owner of the bar (HOLMES). It should be noted that an employee that my partner spoke to (JONES) stated that she saw the shooter walk out and leave while police were on scene. If employees at the bar had been forthcoming with information, the suspect could have been taken into custody immediately on scene. As a direct result of the false statements made by all of the employees, the shooting suspect got away. The shooter works in the kitchen at Eve's lounge.

It also appears that the establishment is selling Hookah (approximately 20 Hookah towers which are used to smoke Hookah) without a tobacco license.

Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
