We are in receipt of your claim for damages regarding your stolen/recovered 2013 Hyundai Elantra on July 30, 2024.

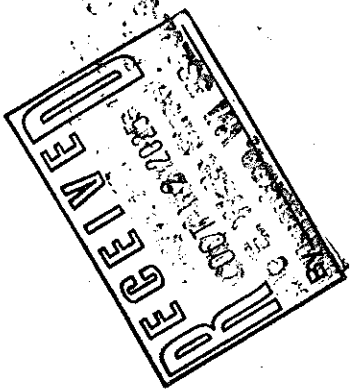
This notice of claim was filed on March 3, 2025, regarding damages that occurred on July 30, 2024. Wis. Stat. § 893.80(1d)(a) requires that a notice of circumstances of the claim be served within 120 days after the happening of the event given rise to the claim. This service of notice is untimely.

Our investigation determined the City of Milwaukee City tow lot attempted to serve four separate notices regarding your vehicle on, 7/30/24, 9/30/24, 10/30/24, and 11/27/24, to the last known address on file at 2101 Patricia Lane #106, Waukesha WI 53188, and was returned undeliverable. Further records indicated on July 30, 2024, the City of Milwaukee Police attempted to reach you by phone but your phone was not in service. After several attempts to reach you without success, the vehicle was processed in auction on January 4, 2025.

There is no evidence that the City is negligent. The City is not liable for damages and we are denying your claim.

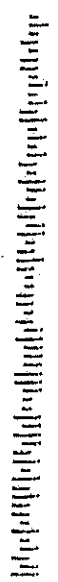
