3. On 03/11/19 at 7:23am, Milwaukee Police were dispatched to 4600 S. 27th Street for an overdose complaint. Upon arrival, officers were let into the room by the front desk clerk and

observed a subject standing outside his door with a handgun. When police arrived the subject was gone. The Motel has surveillance cameras but they were unable to capture the incident.

found a female lying on the edge of the bed with a plastic tube inserted into her right thigh. Milwaukee Fire Department attempted life saving measures but were unsuccessful. Surveillance video captured a male exiting the room before police were called and leave the premise in a vehicle.

- 4. On 06/14/19 at 1:29am, Milwaukee Police were dispatched to 4600 S. 27th Street for an overdose complaint. Upon arrival, officers observed Milwaukee Fire Department personnel performing life saving measures on a female inside one of the hotel rooms. They interviewed the caller who stated the female was having a bad reaction to illegal drugs so he gave her NARCAN. When that did not work, he called 911 and was given instructions on how to perform CPR. The front desk clerk was able to provide the subjects who were registered to the room, their check in date, and the date of check out. The female was conveyed to the hospital and is listed in critical condition.
- On 07/16/2020 at 1:35pm officers went to 4600 S 27th St. to check for a subject wanted on a probation violation. The officers spoke with the clerk, who confirmed the subject was registered at the hotel. The subject was located and taken into custody.
- 6. On 07/22/2020 at 1:30pm officers conducted a Safety and Security meeting at the Suburban Motel, 4600 S 27th St. The officers spoke with the manager about security issues. The property has 36 cameras that are accessible on scene by employees. The manager stated he has a list of people not allowed to rent because of past problems. The manager stated his primary concern is overdoses on the property. He stated if housekeeping observes signs of drug use during or after a stay the subject is added to the do not rent list. The officer also advised to not rent to a subject that appears to be impaired at check in. The manager wasd cooperative.
- 7. On 08/05/2020 at 7:27pm officers were dispatched to Suburban Motel, 4600 S 27th St. for a Property Damage complaint. The officer interviewed the manager, who stated he kicked out a subject who was causing a disturbance. The subject was upset and kicked the manager's auto damaging it. The manger provided officers with a photo copy of the suspect's driver's license and the officers issued the subject citations.
- 8. On 10/07/2020 at 12:19am officers were dispatched to an Overdose at Suburban Motel, 4600 S 27th St. The officers interviewed the caller who stated she took several prescribed muscle relaxant pills and drank several beers. She stated she took the medications to sleep and not harm herself. She was conveyed to the hospital for clearance.
- 9. On 10/09/2020 at 6:12pm officers were dispatched to Call for Police at Suburban Motel, 4600 S 27th St., room 51. The officers received no answer at the door. The officer was able to contact the caller by phone and she stated she did not need police service. The manager was cooperative with officers.
- 10. On 10/17/2020 at 10:08pm officers were dispatched to an Overdose at Suburban Motel, 4600 S 27th St. The officers interviewed the caller, who stated her boyfriend rented the room and they were on a binge snorting heroin and cocaine. She stated they went to bed at 7:00pm and she woke up at 10pm and found her boyfriend not breathing. She ran out and called for police. The subject was transported to the hospital where he was pronounced deceased.

- 11. On 12/28/2020 officers were dispatched to a Trouble with Subject call at Suburban Motel, 4600 S 27th St. The caller stated he was fearful to stay at the hotel because he thought people were after him. The officer conveyed the subject to a different hotel in the area.
- 12. On 01/12/2021 officers conducted a Safety and Security meeting at the Suburban Motel, 4600 S 27th St. The officers spoke with the manager about security issues. The manager stated additional parking lot lighting had been added since their last visit. The officers discussed recent calls for service at the motel and discussed how to reduce drug use. The officers advised of a recent increase in stolen autos and told the manager to have customers secure their auto. The manager was cooperative with the officers.
- 13. On 04/23/2021 at 8:08am officers were dispatched to a Threat complaint at Suburban Motel, 4600 S 27th St. The officer spoke with the caller, who stated she was being threatened by a subject she was staying with. The subject was not on the scene and she was not concerned. She did request medical treatment for anxiety. The officers observed no violation with the motel.
- 14. On 04/27/2021 at 11:14pm officers were dispatched to a Trouble with Subject at Suburban Motel, 4600 S 27th St. The officers interviewed the clerk, who stated the couple in room #43 were causing a disturbance and she asked them to leave. The clerk agreed to let them stay as long as there were no more problems. On 04/28/2021 the clerk called back to request the subject leave due to another incident. The officers responded and advised the subjects to leave.

When he woke up he found his Xbox and wallet missing. The officers spoke with the manager who checked the video. The video showed the victim going door to door at 4am looking for the subjects. The victim never notified the night clerk of the theft.
- 16. On 05/16/2021 at 1:25pm officers were dispatched to a Sick/Injured call at Suburban Motel, 4600 S 27th St. The officers were met by MFD who stated there was a subject deceased in room #14. There were no signs of drug use in the room but there was alcohol. The subject was found by an employee who came to clean the room.
- 17.On 05/22/2021 at 6:03am officers investigated a theft at Suburban Motel, 4600 S 27th St. The caller stated money was missing from his room. He stated he was outside his room for about 5 minutes but was in close proximity and did not see anyone enter his room. The clerk stated there is a camera pointed in that direction but the clerk could not access the video.
- 18.On 05/28/2021 at 11:35am officers were dispatched to an Injured Person at the Suburban Motel, 4600 S 27th St. The investigation revealed a subject was transported to the hospital because he was extremely intoxicated.
- 19. On 06/07/2021 at 4:29pm officers were dispatched to a Check the Welfare at the Suburban Motel, 4600 S 27th St. The officers located the subject and found him to not need medical treatment. He was arrested on an unrelated warrant.
- 20. On 06/21/2021 at 4:50am officers were dispatched to a Property Damage at the Suburban Motel, 4600 S 27th St. The caller stated someone was breaking out car windows in the parking lot. The officer did not locate any damaged auto and the call back number was not in service.

MFD administered Narcan and conveyed the subject to the hospital. The subject admitted to snorting heroin but did not remember how long ago that occurred. The clerk was cooperative with officers.
- 23. On 07/10/2021 at 4:47pm officers were dispatched to a Trouble with Subject at the Suburban Motel, 4600 S 27th St. The clerk stated a subject was refusing to leave the property. He stated the subject was dropped off by the Brown Deer Police but is on the do not rent list. The officers transported the subject to another motel in the area.
- 24. On 07/23/2021 at 1:01pm officers were dispatched to a Trouble with Subject at the Suburban Motel, 4600 S 27th St. The officers interviewed the clerk, who stated the subject in room #43 was causing problems and he wanted him removed. SAFETY AND SECURITY MEETING

This report is written by Police Officer Michael WARD, assigned to District 6, Early Power, and the Community Liaison Office.

On this day I was assigned to Squad 6264 with my Partner Police Officer Fabian GARCIA.

On Wednesday, July 22, 2020, Sgt. Christopher MCBRIDE, P.O. GARCIA, and I conducted a Safety and Security meeting with Manger/Owner, Jatin N. PATEL (A/M, 2-5-1976), of the Suburban Motel located at 4600 S. 27th St..

The Suburban Motel had a Provisional Renew License (0000559) updated 7-1-2020 and expires 8-31-2020 . Listed Agent and Owner, Narottambhai V. PATEL (06-01-1947).

The property consist of two buildings. The front building has approximately 23 units, and is intended for short term rentals at the location. The rear building has approximately 27 units and is a mixture of short term rentals and long term rentals. The rear building has a residential unit located on the north end of the building. The residential unit is occupied by manager/ owner, Jatin PATEL and his family.

Building 1 (front) has hallway between the front and back units. This hallway is not accessible to the renters. The hallway is used to access the rooms for housekeeping. Cameras are located in the hall for safety and security. Renters only have access to their rooms from the exterior of the building.

Building 2 (rear) has common halls accessible to the public and unsecured with posted signs stating "Keep doors closed". This building is a two story building with multiple units on the upper and lower. Cameras are located in the halls and exit and entrance points. There are 5 access points to the common halls.

The area around the buildings were clean. The parking lot had no abandon or disable vehicles in the lot. PATEL stated he just returned a bid for new LED lighting for the parking lot and around the building.

We observed multiple video cameras on the exterior of the building, entrance and exit points and hallways. The property has approximately 36 security cameras on location. The cameras are in color and digital. The cameras store information for 14 days. Employees have access to the cameras on location.

PATEL stated check in procedures involve making copies of all identification of people staying in the units and documenting vehicle information. Patel stated he has a list of people who are not allow to rent from the property for past issues.

PATEL provided us with his Rules and Regulation/Disclosure Statement/Code Conduct form he has each guest initial and sign.

PATEL stated his main concern is the overdoses on his property. PATEL asked advice regarding how to screen for possible drug use. PATEL was advised if he can make observations of guest that appear to be impaired, not to rent to these subjects. PATEL stated that when observations are made after checkout regarding drug paraphernalia, PATEL adds the guest to the "do not rent list" to try and address the drug issues. PATEL stated for long term stays it is mandatory for the cleaning service to go through the unit once a week. PATEL stated that any indication of drug activity or use would result in termination of rental agreement and guest would be removed from the premises.

PATEL was receptive to all concerns that were discussed and is interested in future meetings and keeping an open line of communication with the Milwaukee Police Department.

INITIAL INVESTIGATION

This report is written by P.O. Daniel SIDA, assigned to District 6, Early Shift.

On Wednesday, August 5th, 2020, I was assigned to Sq 6250, in full duty uniform, operating marked MPD Squad #537. At 7:27p.m., I was dispatched to the Suburban Motel at 4600 S 27th St., in the City and County of Milwaukee for a property damage complaint. I arrived on scene at 7:38p.m.

I spoke with motel manager Jatin N PATEL (a/m, 2-5-1976) who stated he was having issues with a client, identified him via a photocopy of his WI DL as Juan J VILLAGRANA (w/m, 3-20-1983; DL V426-4308-3100-09; address of 820 S 21st St, Milwaukee WI 53204). PATEL stated VILLAGRANA had rented room #9 on 8-4-2020 and was set to check out on 8-6-2020. PATEL stated VILLAGRANA had his unidentified girlfriend stay in the room. PATEL stated there were several arguments between VILLAGRANA and the female. PATEL stated earlier today he had told VILLAGRANA to stop with the problems or they would be removed from the premises. PATEL stated that at approximately 6:30p.m., VILLAGRANA once again began arguing with his girlfriend and PATEL had enough. PATEL stated he informed VILLAGRANA he would not longer be allowed to stay. PATEL stated VILLAGRANA then complained saying he had paid until the 6th of August. PATEL stated he told VILLAGRANA he still had to go. At that time, VILLAGRANA exited the front door of room number #9, which is in the rear of the main building, facing east. PATEL stated VILLAGRANA walked over to PATEL's white Lexus SUV (WI Auto 110-ZDZ). PATEL stated he observed VILLAGRANA kick the driver door of PATEL's car three times with his right foot. PATEL then called the police and VILLAGRANA left the location.

I checked room #9. I observed no one inside. The TV was still turned on and several pieces of food and chicken were scattered all over the floor. PATEL stated VILLAGRANA had fled going northbound on S 27th St. at approximately 6:35p.m. PATEL stated the girlfriend had also fled but did not see when she left the location. I observed the white Lexus SUV parked across from room #9. I observed a couple of dents on the driver side door and a few foot prints, consistent with kicking. PATEL stated he did observe VILLAGRANA kick the car. I advised PATEL I would be issuing VILLAGRANA a citation for vandalism and disorderly conduct.

Exterior Scene:

The Suburban Motel is located on the east side of S. 27th St with it's main office located in the west building. Room #15, where the overdose occurred, is located behind the main office. A service drive off 27th St. leads to several rooms for rent including #15.

Initial Interview with Terra C. CASWELL:

Upon arrival, officers observed Milwaukee Fire Department, (MFD) Engine 17 and Greenfield Medical Unit were on scene treating the victim, later identified at Shawn S. HAWKINS, B/M, 11-16-65. Also on scene was Terra C. CASWELL, w/f, 12-07-74. She was observed standing outside the doorway of room #15.

I interviewed Terra in my squad car since it was beginning to rain. She was sobbing and appeared to be intoxicated with the smell of intoxicant. Terra, stated she is Shawn's girlfriend and has been for two weeks. She stated Shawn had rented the room on the 15th of October at 6:45pm. She stated she was staying with him. Terra stated they both had been on a binge, snorting heroine and using cocaine. Terra stated she and Shawn last snorted heroin yesterday 10-16-20 at 3pm and used crack cocaine as well. Terra stated they went to bed at approximately 7:00pm' Terra stated she could not sleep that whole time but that Shawn was sleeping heavily, and snoring loudly. Terra stated she woke up at 10:08pm and noticed Shawn was not snoring. She stated she touched him and he felt cold. Terra stated she could not wake up Shawn. She stated she found vomit in his mouth. Terra stated she then ran out of the apartment and called for police. Terra stated, shortly after, the fire department and police arrived on the scene.

Scene Description of Room #15:

Room #15 is a single room with queen size bed. The beds headboard is situated off the north wall of the room. A dresser with tv is situated off the south wall. The bathroom is located off the south west
