
You are hereby notified that the Milwaukee Common Council will hold a hearing on Wednesday, January 21, 2015, commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin to consider whether to renew, renew with a suspension between 10 and 90 days, or not renew the Class B Tavern and Public Entertainment Premises license(s) for the premises located at 628 N Water St ("Ultra Lounge").

Attached you will find a copy of the Report of the Licenses Committee, which includes its Findings of Fact, Conclusions of Law, and Recommendation, recommending a 45 day suspension of the Class B Tavern and Public Entertainment Premises license(s) based upon the police report and police testimony. This recommendation is the result of a public hearing before the Committee held on Tuesday, January 6, 2015.

Please be advised that the Common Council will determine whether to renew, renew with a suspension between 10 and 90 days, or not renew your Class B Tavern and Public Entertainment Premises license(s) based upon the Findings of Fact contained within the Licenses Committee report.

Re: Report on the renewal application of Tremaine J. Brown, Agent for Ultra Lounge, LLC, for a Class "B" Tavern and Public Entertainment Premises licenses renewal applications for the premises located at 628 North Water Street in the City and County of Milwaukee, Wisconsin ("Ultra Lounge").

FINDINGS OF FACT

1. Tremaine J. Brown ("Licensee") is the holder of a Class "B" Tavern and Public Entertainment Premises license for the premises located at 628 North Water Street in the City and County of Milwaukee, Wisconsin ("Ultra Lounge"). Said license expires at midnight, January 21, 2015.
2. An application to renew said license and change of member was filed with the Office of the City Clerk on December 15, 2014.
3. Pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On December 22, 2014, the Milwaukee Police Department responded with a police report that could form a basis for non-renewal or suspension of said license.
4. On December 19, 2014 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapters 90 and 108 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and neighborhood objections and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the Police Department report and neighborhood objections on January 6, 2015, commencing at 10:15 a.m. in Room 301B of City Hall, 200 East Wells Street, Milwaukee, Wisconsin 53202. At said date, time and place, the Licensee appeared and admitted receipt of notice for the hearing, as well as notice of the objection to renewal of licenses.



5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On April 20, 2014 Milwaukee police, while on patrol in the 600 block of North Water Street as part of Code Red, observed two subjects fighting in front of Ultra Lounge (628 North Water Street). After placing both subjects in custody, a third subject approached the arresting officers and yelled at one of the arrested subjects. This third subject approached officers a total of three times, the third time he was armed with a semi-automatic pistol. This subject, who was also arrested for disorderly conduct while armed, stated he was at Ultra Lounge prior to the incident. The two subjects originality observed fighting were cited for disorderly conducted.
 - B. On June 19, 2014 at 2:15 a.m. Milwaukee police officers were on patrol in the 600 block of North Water Street and observed that there were still patrons inside 628 North Water Street (Ultra Lounge) well after legal hours of operation. On scene was David Hinton who stated he was the owner. He stated he did not know the hours of operation and it was his fault the people were in the bar. The officer showed him the license posted on the wall which showed the closing time was 1:45 a.m. The applicant was cited for Class "B" Premises Allow Patron After Hours, and was found guilty on August 5, 2014 and fined \$378.00.
 - C. On July 12, 2014 Milwaukee police, while on patrol in the 600 block of North Water Street as part of Code Red, were speaking to bouncers outside Ultra Lounge (628 North Water Street) when a fight broke out inside the business. Bouncers were able to control the situation and held their positions until additional squads responded to assist with crown control.
 - D. On September 27, 2014 Milwaukee police were approached by security from Ultra Lounge and 618 Live, stating there was fight on the sidewalk at approximately 630 North Water Street. While responding, one of the officers fell and injured his right hand.
 - E. On September 29, 2014 a Milwaukee police officer was flagged down by a citizen who stated there was a large fight In the 600 block of North Water Street. Officers responded and discovered a group of 40-50 people in the street and on the sidewalk in front of Ultra Lounge (628 North Water Street), some of which were fighting. This group eventually dispersed and no citations or arrests were made.
 - F. On October 4, 2014 at 1:46 a.m. a Milwaukee police officer went over the air with a "huge fight" in front of 618 Live. Subsequently, the Milwaukee police mounted patrol and 15 additional police squads responded and discovered numerous separate fights in the area involving 20-40 people each. While investigating these fights, officers were told by staff from the bar that there were still approximately 150 people inside the tavern. The officer who originally called for assistance regarding the "huge fight" indicates that he had been assigned to monitor the release of The Ultra Lounge and 618 Live. This officer observed a subject screaming, pounding and pulling on the front door of 618 Live after being ejected from the business. The applicant told police that this subject had been

ejected for fighting inside the business and that the other combatant had been kicked out of the back door of the tavern. The two combatants located each other again after being ejected from the club and again began fighting. This incident led to other fights and other patrons gathering to view the commotion. Security staff from 618 Live was observed assisting officers break up the fights. 618 Live staff also provided police with video footage of the incident. Five subjects were cited as a result of the fights, officers were unable to detain additional subjects because of the number of fights occurring in close proximity to each other. At one point an officer used Oleoresin Capsicum "pepper spray" to stop the actions of one of the combatants. One of the suspects cited admitted to coming from the Ultra Lounge.

- G. On October 8, 2014 the applicant and representatives of The Ultra Lounge met with representatives of the Milwaukee police department and the Milwaukee city attorney's office to discuss areas of concern including fights that occur on a regular basis at the end of the night. Several suggestions were made to help alleviate these issues. Some of the suggestions recommended for implementation by The Ultra Lounge, such as using an ID scanner, are already in place at 618 Live. Some suggestions, such as a patron being banned from one business also being banned from the other, are applicable to both businesses. Suggestions that would apply only to 618 Live were to change their minimum age to 23 and decrease capacity from the current 480 to 350. On October 9, 2014 it was agreed that capacity would be lowered to 400 and the minimum age would be changed to 23. The applicant was advised to contact the license division to update paperwork in order to reflect these changes.
- H. On October 20, 2014 a Milwaukee police officer was dispatched to the front desk at Milwaukee police district #1 regarding a battery complaint. The victim told officers she had been attacked around 1:30 a.m. while inside Ultra Lounge (628 North Water Street) by another patron known to her as Brande Conner. The victim stated she was struck several times in the head with a bottle while inside the business. The victim was treated and released at Froedtert Hospital for a concussion. An incident report was filed.
- I. On October 31, 2014 officers were flagged down at 610 North Water Street by a City of Milwaukee parking checker. The checker stated she was writing citations when she was confronted by a group of females who wanted to know why they were getting tickets. The group was understanding except one person, identified as Brittany Hortman, who pushed the checker. The police were flagged down at this point and Hortman was issued a disorderly conduct citation. Hortman stated she was at the Ultra Lounge having drinks right before the confrontation.
- J. On November 8, 2014 Milwaukee police were flagged down regarding the possibility of an underage patron being inside Ultra Lounge. Officers discovered an 18 year old female inside the business that had used another person's identification to gain entry to the bar. The female was cited for presence of underage in place of sale and misrepresentation of age. The applicant was cited for allow underage on premise and liquor license required (later amended to refilling of liquor bottle). Both items are due for arraignment January 2, 2012.

- K. On November 15, 2014 at 12:22 a.m. Milwaukee police officers received a call about a large fight at 628 North Water Street (Ultra Lounge). When officers arrived they saw patrons leaving in all directions and the front glass door shattered. They were given a description of the actors and that one may be armed with a gun. The investigation revealed a fight occurred inside and continued outside. Two bouncers were Injured during the altercation. The actors were not located but while on scene a patron of the bar was observed exiting the bar drinking an alcoholic beverage. The patron continued walking down the sidewalk where he was stopped and cited for public drinking.
- L. The applicant states that on April 20, 2014, the valet was supposed to work only for Ultra Lounge but they also served 618 Live. The valet was also supposed to move down the block per a request from the police, but did not do so on the night of the incident. The crowd from 618 Live got into a fight in front of the building, so the item was placed on Ultra Lounge's police report. The incident with individuals on premise after hours was a mistake. In regards to item #4 on the police report, two individuals began fighting and security broke them up. The security guard had to pick up person and bring him outside. In regards to item #5, there was a fight outside, but because closing times were not staggered it is unclear where the individual involved came from. In regards to item #6, a fight started outside and security held the individuals involved until police arrived. In regards to item #7, patrons of 618 Live had been fighting, were removed, and began fighting outside. One individual involved may have come from Ultra Lounge. The applicant has met with the police department. He has purchased an ID scanner, but it hasn't been used yet as the entrance to the establishment will need to be reconfigured to accommodate the scanner. The applicant agreed at a meeting with the police department to have staggered exit times from 618 Live. Since staggered times have been implemented, there have not been any fights outside. In regards to item #9, two individuals who had come to the establishment together began fighting. Security guards broke up the fight and the applicant called police. One of the individuals left immediately. Regarding item #9, the underage individual who gained access used a fake ID and the security guard was fired as a result. The applicant is working on paying for fines related to item #11. In regards to item #12, the business was getting ready to shut down and people taking a picture together began fighting. A security guard needed to physically remove the person and a window was kicked during incident.

They have contacted police and other establishments for advice and have had no incidents in the last two months. The establishment does have a banned patron list. They initially had internal security with 2 guards at the door and 4-5 inside. They have increased security to 8 inside and 3 outside.

He states they have not accused 618 Live of anything and are not in competition. He states that security escorts patrons to cars, but they are in plain clothes and they do not have as many guards as 618. They have had some learning experiences and know that improvements need to be made. There is a dress code with no baggy clothes or hoodies.

- M. David Hinton - 422 East Pleasant - He states that after the police incidents and meeting with the police department, they have started letting cut at staggered times from 618 Live. The establishment has cameras at the entrance, but the business is not currently set up to have the ID scanner at the entrance. They are working on resolving the issue. Alderman Bauman present at the table. He states that the initial application was for a lounge that serves a different market than 618, yet they are competing with 618. A license was initially issued despite some concerns, and the concerns have come to fruition. There have been 11 police incidents in one year of being open.
- N. Captain Thiele testified that in the June incident Mr. Hinton stated he was the owner and had people in the bar after the closing time. Last year the applicant stated at committee that the business would close 15 minutes prior to 618. There was a large fight on October 4th that required many personnel. The police department has met with both owners because it was unclear which patrons were involved in the fight. At the meeting the applicant agreed to buy an ID scanner, have staggered closing times, have a common banned list, and have communication with security guards between the establishments. The establishment has not been escorting patrons to parking areas. Ideas brought up at the meeting had also already been discussed at the previous committee meeting. On November 19th a minor with a fake ID had been turned away at 618. The fake ID indicated an age of 21, but the individual gained entry to Ultra Lounge despite the 23+ age restriction.
- O. Sgt. Ackley testified that at the meeting with Ultra Lounge and 618, there was a discussion regarding cohesion between security units. There was cohesion at first, but it deteriorated a month later. Closing times were not being staggered. 618 has kept its closing time, and he cannot determine if Ultra has a standard closing time. 618's customers usually park a block or two away and security walks them to parking lots. He has not observed Ultra Lounge helping customers to the parking areas. They have offered assistance in front of the establishment, but not to parking areas. Outside security footage can only be obtained by contacting the building owner and it is difficult to reach him. He is not aware of any dress code at Ultra and has not seen any signs posted. 618 has a database from their ID scanners, but there is a lack of communication between clubs. He is concerned about after hours activity, though he has not observed any issues for a month. About a month ago there were still patrons a minute before closing time. Curtains covering the windows were added about a month ago. He has not seen any signage indicating the age restriction.
- P. Tiffany Campbell - 2422 West Roosevelt - She has just begun helping with the operations of Ultra Lounge. There has been a disconnect in communication between the Ultra Lounge and 618 because there is business competition. She witnessed item #12 on the police report. She called police, but Mr. Manjee from 618 had already called police. Curtains were placed in the window to help draw in customers. The curtains are opened if there are already patrons on the premises. There is a kitchen on the premises.

- Q. Alexander MaCavene -8525 West Helena - He is a patron of the establishment. He states the applicant and Mr. Hinton take his input into account as a customer. He states if there is an argument, security and management step in to find out the details of the situation.
- R. Samantha Lynn Bigsharp – P.O. Box 51073 - She states the establishment is the only lounge on Water Street that caters to an urban crowd. She states it is a mature crowd and she feels safe in the establishment. She states Mr. Brown and Mr. Hinton can sit on the second level of the establishment to monitor the crowd. She also agrees with previous speakers.
- S. Kyle Allen - 4181 North 19th Place - He is a patron and states there is a diverse crowd with good music, poetry, and live jazz.

CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapters 90 and 108 of the Milwaukee Code of Ordinances.
2. Based upon the above facts found, the Committee finds that the Licensee, Tremaine J. Brown has not met the criteria of Chapter 125, Wis. Stats. or Chapters 90 and 108 of the Milwaukee Code of Ordinances to allow renewal of the Class "B" Tavern and Public Entertainment Premises license held by him for the premises located at 628 North Water Street in the City and County of Milwaukee, Wisconsin ("Ultra Lounge") without undergoing a forty-five (45) day suspension of said license. The Committee finds the police report and testimony, as stated above, to be true.
3. The Committee recommends that the full Common Council of the City of Milwaukee exercise its judgment to renew the Class "B" Tavern and Public Entertainment Premises license for the licensed premises at 628 North Water Street in the City and County of Milwaukee, Wisconsin ("Ultra Lounge") with a forty-five (45) day suspension of said license based upon the danger that this nightclub represents to the health, safety and welfare of the citizens of the City of Milwaukee.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of three (3) ayes and two (2) noes, recommends that the Class "B" Tavern and Public Entertainment Premises license of Tremaine J. Brown, as agent for Ultra Lounge, LLC, for the premises located at 628 North Water Street in the City and County of Milwaukee, Wisconsin ("Ultra Lounge") be renewed with a forty-five (45) day suspension.

Said suspension is to be in effect between 12:01 a.m., January 22, 2015 to midnight, March 8, 2015.



Re: Report on the Renewal Application of the Class "D" Operator's License of Robert C. Fiebelkorn

FINDINGS OF FACT

1. Robert C. Fiebelkorn (hereinafter the "Licensee") is the holder of a Class "D" Operator's License in the City and County of Milwaukee, Wisconsin. Said license expired at midnight, December 31, 2014
2. An application to renew said license was filed with the Office of the City Clerk on November 4, 2014.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. On November 5, 2014, the Milwaukee Police Department responded with a police report that could form a basis for nonrenewal or suspension of said license.
4. On December 18, 2014, the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on December 1, 2014, commencing at 1:00 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee did appear and he was not represented by counsel.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. On October 8, 2014 the Wisconsin Department of Transportation revoked the applicant's driver's license for seven months for operating while intoxicated.
 - B. The applicant stated that he has quit drinking because of medical reasons. In regard to the first item on the police report he had gotten into a domestic dispute and used poor judgment. He was over served alcohol and then later drove after the incident.



CONCLUSIONS OF LAW

1. The Committee has jurisdiction to hold hearings and provide Findings of Fact, Conclusions of Law and a Recommendation to the full Common Council pursuant to Chapter 125 of the Wisconsin Statutes and Chapter 90 of the Milwaukee Code of Ordinances.
2. Based on the above facts found, the Committee concludes that the Licensee, Robert C. Fiebelkorn has not met the criteria of Chapter 125 of the Wisconsin Statutes or Chapter 90 of the Milwaukee Code of Ordinances to allow renewal of the Class "D" Operator's license without undergoing a twenty (20) day suspension based upon the licensee's testimony.
3. In order to protect the health, safety and welfare of the citizens of the City of Milwaukee, it is the recommendation of the Licenses Committee that the full Common Council should exercise its discretion to renew the Class "D" Operator's license held by Robert C. Fiebelkorn with a twenty (20) day suspension based upon the licensee's testimony.

RECOMMENDATION

Based upon the Findings of Fact and Conclusions of Law stated above, the Committee, by a vote of four (4) ayes and one (1) excused recommends that the Class "D" Operator's License be renewed with a 20-day suspension based upon the licensee's testimony.

Said suspension is to be in effect from January 21, 2015 and for twenty (20) days thereafter.



FINDINGS OF FACT

1. Precious N. Boone (hereinafter the "Licensee") is the holder of a Class "D" Operator's License in the City and County of Milwaukee, Wisconsin. Said license expired on December 31, 2013.
2. An application to renew said license was filed with the Office of the City Clerk.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a police report that could form a basis for nonrenewal or suspension of said license.
4. On December 29, 2014 and December 18, 2014 the City Clerk's Office provided timely notice to the Licensee pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes of the report of the Milwaukee Police Department and included therewith a copy of the Milwaukee Police Department report. The matter was scheduled for a hearing on the police department report on January 6, 2015 at 1:00 p.m. in Room 301B of City Hall. At said date, time and place, the Licensee did not appear.
5. Based upon the sworn testimony heard and the evidence received at the hearing, the Committee finds the following:
 - A. A notice of the hearing as well as a copy of the police report was sent to Precious N. Boone, 1508 West Meinecke Avenue, Milwaukee, WI 53206 on December 18, 2014 by U.S. prepaid first-class mail in an envelope bearing the return address of the License Division. 

FINDINGS OF FACT

1. Antoinette Bee (hereinafter the "Licensee") is the holder of a Class "D" Operator's License in the City and County of Milwaukee, Wisconsin. Said license expired on December 31, 2014.
2. An application to renew said license was filed with the Office of the City Clerk.
3. Pursuant to Chapter 90 of the Milwaukee Code of Ordinances and Chapter 125 of the Wisconsin Statutes, the matter was referred to the Milwaukee Police Department for investigation. The Milwaukee Police Department responded with a police report that could form a basis for nonrenewal or suspension of said license.
4. CONCLUSIONS OF LAW
