

 = INSTALLATION OF YIELD

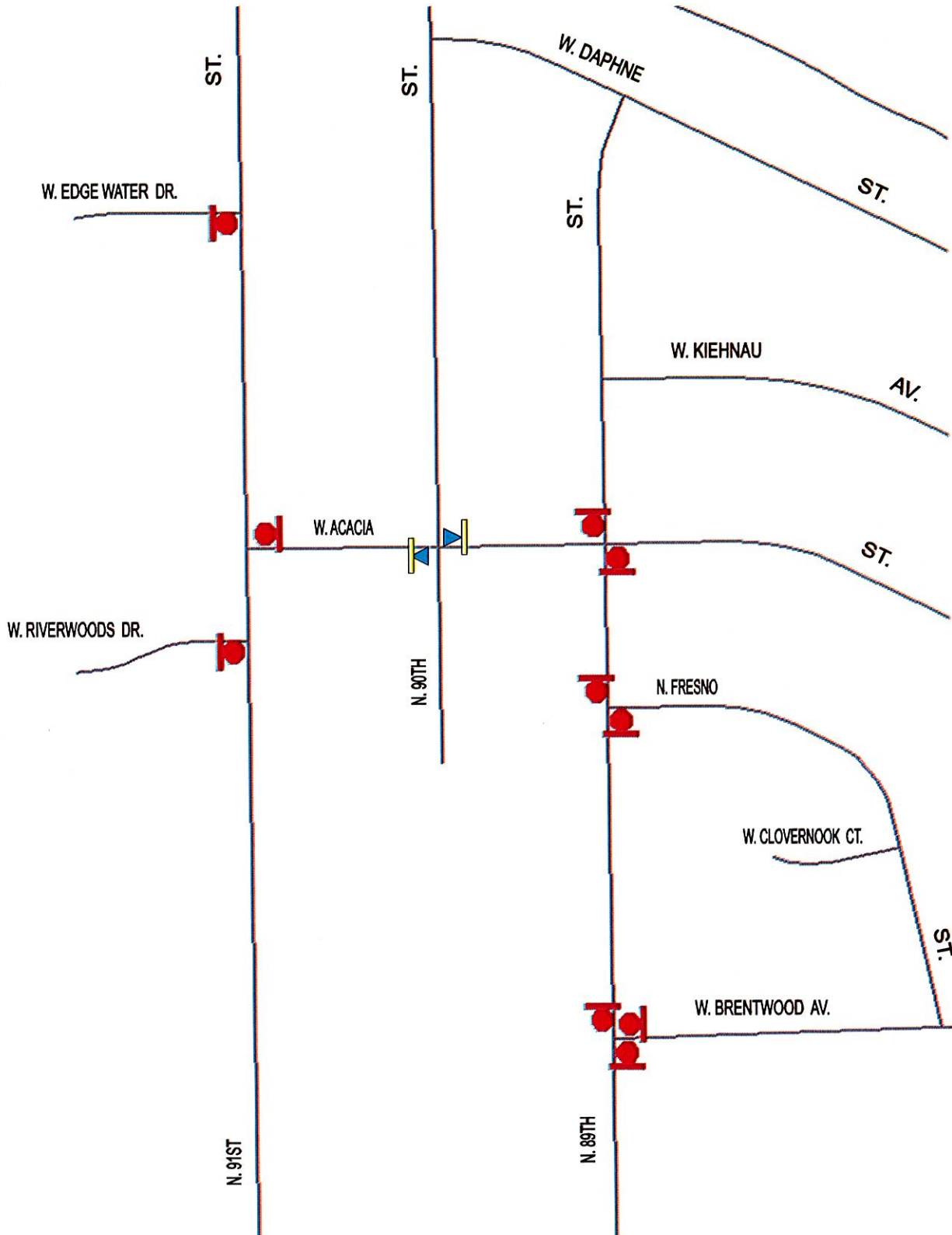

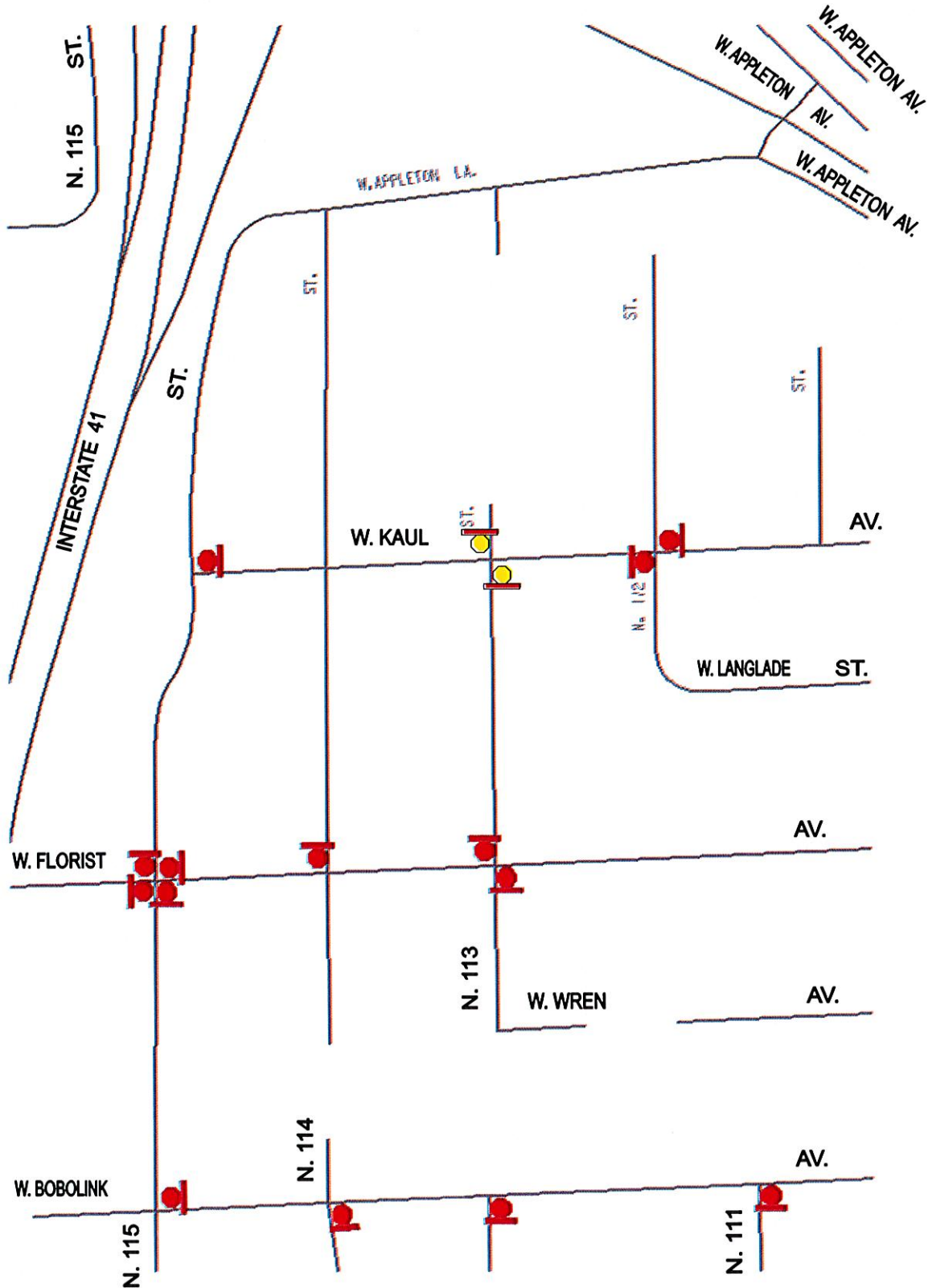

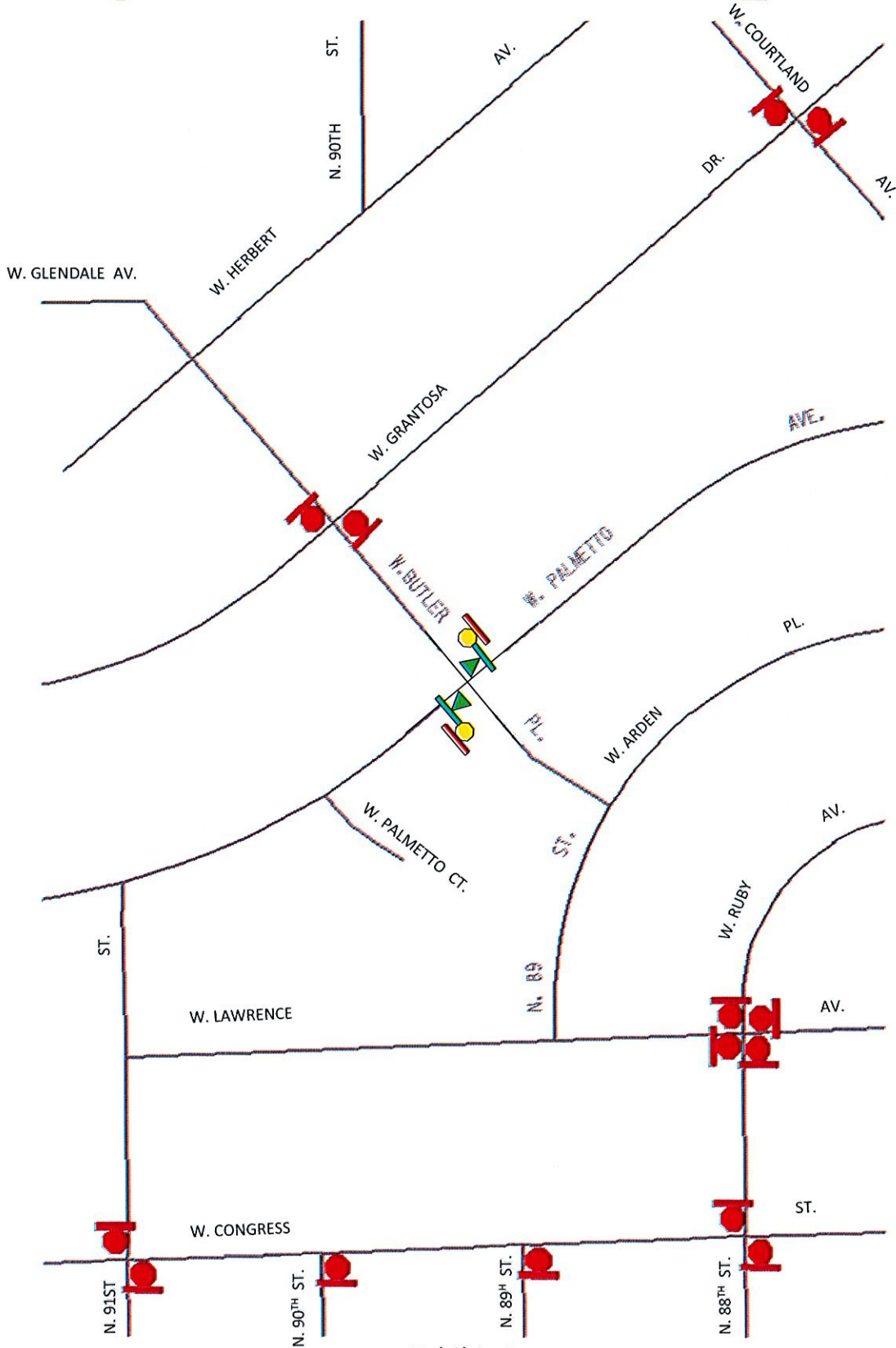

This is in response to your request on behalf of a local resident in an effort to alert truck driver exiting the Wisconsin Paperboard Corporation facility that trucks 3 tons or over are not allowed on North Newhall Street from a point 700 feet north of East North Avenue to a point 600 feet north thereof.

Our Traffic Engineering staff has investigated this request and found that trucks should not be proceeding north on North Newhall Street from the Wisconsin Paperboard Corporation facility. We therefore recommend the installation of the above-captioned trucking restriction and will prepare the necessary legislation that will be heard at the next Public Safety and Health Committee meeting so that you may support it to final passage.
