- NSP 12 Youth Organizer is Derrick Shoates

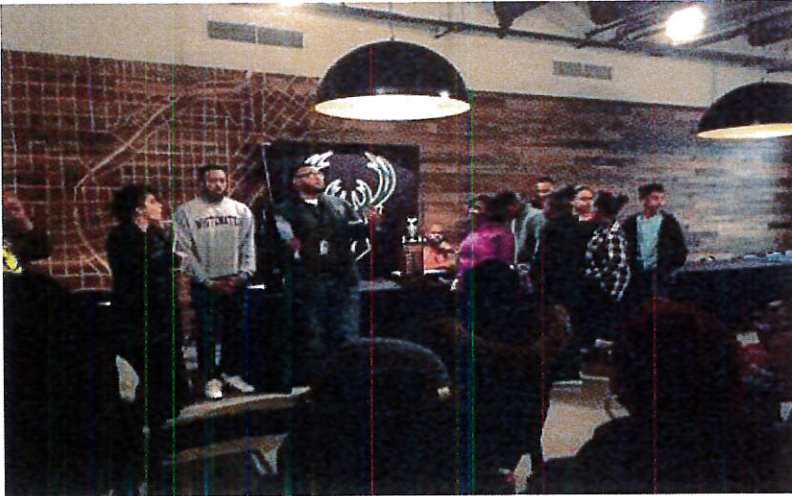
NSP 12 Resident Engagement in 2017

- Organizers knocked on 959 doors that resulted in having 301 front porch conversations with residents at their front porch.
- Organizers distributed 3,869 resource materials that connected residents to events, employment opportunities and local resources.
- Organizers held 568 hours engaged in the community with office hours at partner locations and at events.
- Organizers participated in 38 meetings and events (facilitating 15) that drew more than 1,300 residents.

NSP 12 Youth Engagement in 2017

- Our youth organizer participated in 14 youth focused events and meetings (facilitating 8) that attracted 185 youth.
- These youth focused events and meetings included educational/awareness programming to bring about neighborhood safety and social cohesion around issues pertinent to youth such as:
 1. Project 943 (unlawful driving)
 2. Prevention Game (opioid/drug awareness)
 3. Barbershop Monday (youth mentoring)

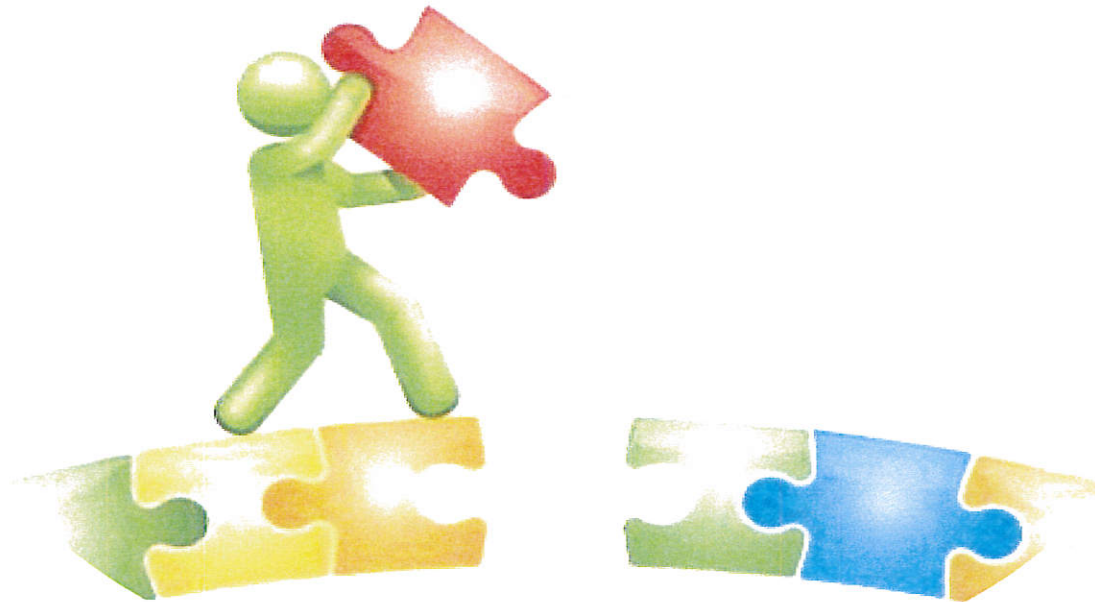

Neighborhood Safety Coordinators

(formerly Community Prosecution Unit Coordinators)

Helping Bridge the Gap



The Neighborhood Safety Coordinators (NSC) work throughout the entire Police District, while the Community Organizer and Youth Organizer are focused in their two priority neighborhoods. We work in Milwaukee Police Department Districts 2, 3, 4, 5 and 7

The role of the Neighborhood Safety Coordinator is to work closely with the various entities within the Neighborhood Safety Team to assist with problem solving, coordination of interventions, and follow up in regards to a specific problematic property.



2017 Neighborhood Safety Coordinator Outputs

District 2-Maritza

- Participated in 81 events and meetings (48 were facilitated by the NSC).
- Closed 281 cases with 261 instances of nuisance abated.
- Spent 818 hours in the community/district conducting outreach and attending meetings and events.

District 4-Beth

- Participated in 81 events and meetings (23 were facilitated by the NSC).
- Closed 180 cases with 246 instances of nuisance abated.
- Spent 1,902 hours in the community/district conducting outreach and attending meetings and events.

District 5-Claudia

- Participated in 159 events and meetings (15 were facilitated by the NSC).
- Closed 151 cases with 281 instances of nuisance abated.
- Spent 1,013 hours in the community/district conducting outreach and attending meetings and events.

District 7-Scott

- Participated in 147 events and meetings (42 were facilitated by the NSC).
- Closed 208 cases with 254 instances of nuisance abated.
- Spent 1,119 hours in the community/district conducting outreach and attending meetings and events.
