

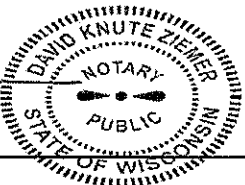

**NOTICE TO BE PUBLISHED
WITHIN 15 DAYS
AFTER THE INITIAL RESOLUTION
IS RECORDED**

**IF A PERMISSIVE REFERENDUM
ON BOND ISSUES IS ALLOWED**

Pursuant to sec. 67.05(1), Stats., PLEASE TAKE NOTICE That the City of Milwaukee has adopted an initial resolution authorizing the issuance of general obligation bonds in the amount of \$3,431,766 for the purpose or purposes hereinafter enumerated, which was recorded on November 26, 2013. PLEASE TAKE FURTHER NOTICE that such initial resolution must be submitted to the electors under sec. 67.05(5), Stats., if within thirty (30) days after the recording thereon there shall be filed in the Office of the City Clerk a petition requesting such submission signed by electors numbering at least ten (10%) percent of the votes cast for Governor in the City at the last general election, and that if such petition is filed, proceedings shall be had in accordance with sec. 67.05(5), Stats.

Resolution authorizing the sale and issuance of general obligation bonds in the aggregate amount of \$3,431,766 for water systems.

Whereas, The 2013 budget of the City of Milwaukee adopted by the Common Council approved \$200,000,000 of contingent borrowing; and

Whereas, The City desires to use \$3,431,766 of the Contingent Borrowing for Water Systems; and

Whereas, The City desires to issue general obligation bonds in the aggregate amount of \$3,431,766 for water systems; now, therefore, be it

Resolved, By the Common Council of the City of Milwaukee, that it hereby authorizes the issuance of \$3,431,766 of Contingent Borrowing for Water Systems; and, be it

Further Resolved, That it hereby authorizes and declares its purpose to sell and issue general obligation bonds in the aggregate amount of \$3,431,766 for water systems; and be it

Further Resolved, That such bonds may be issued as notes pursuant to Common Council Resolution File Number 121149 (Contingent Borrowing - Unallocated) including temporary borrowing as Extendable Municipal Commercial Paper, as bonds pursuant to Resolution File Number 121150 (Contingent Borrowing - Unallocated), and/or as revenue bonds as may be authorized from time to time.
