There is a possibility that your application may be denied for one or more of the following reasons: The recommendation of the committee regarding the application shall be based on evidence presented at the hearing. Per MCO 85-4-4, unless otherwise specified in the code, probative evidence concerning non-renewal, suspension or revocation may include evidence of the following: failure of the applicant to meet municipal qualifications, pending charges against or the conviction of any felony, misdemeanor, municipal offense or other offense, the circumstances of which substantially relate to the circumstances of the particular licensed or permitted activity, by the applicant or by any employee or other agent of the applicant. If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. You will be given an opportunity to speak on behalf of the application and to respond and challenge any charges or reasons given for the denial. No petitions can be accepted by the committee, unless the people who signed the petition are present at the committee hearing and willing to testify. You may present witnesses under oath and you may also confront and cross-examine opposing witnesses under oath. If you have difficulty with the English language, you should bring an interpreter with you, at your expense, so that you can answer questions and participate in your hearing.

You may examine the application file at this office during regular business hours prior to the hearing date. Inquiries regarding this matter may be directed to the person whose signature appears below.

The hearing before the Licenses Committee will take place on 5/16/2023 at 2:00 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony via phone or internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.
Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.

This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 11/26/20 at 11:44am, Milwaukee Police were dispatched to 620 W. Oklahoma Avenue for a theft complaint. Investigation revealed that 2 subjects entered the establishment, took items, and left without paying for those items.
2. On 12/11/20 at 11:50pm, Milwaukee Police were dispatched to 620 W. Oklahoma Avenue for a theft complaint. Investigation revealed that two subjects entered the establishment, filled two laundry bags full of items, and left the store without paying for the items.

3. On 01/11/2021 at 6:58pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Threat complaint. The officers spoke with the manager, who stated a known subject comes in the store and intimidates employees with aggressive language. The manager stated she has information on a restraining order but the business is hesitant to put one in place.
4. On 01/12/2021 at 7:52pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the clerk who stated a subject was observed leaving with merchandise he did not pay for. The clerk described the subject to the officers. The officer recognized the subject based on the description as a known shoplifter. Officers filed a report and ordered it in to the DA's office.

5. On 01/14/2021 at 8:49pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a subject came into the store and took merchandise without paying for it. The same subject has been observed stealing the same items from the store in the past. The manager stated they would call if the subject returns.
6. On 01/16/2021 at 7:05pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers interviewed the clerk, who stated a subject came in the store and loaded up a shopping cart with merchandise. The subject attempted to walk out with the cart without paying for it. The clerk and the manager stopped the subject and he grabbed some items from the cart and fled the store. The clerk provided a list of the items stolen.
7. On 01/27/2021 at 9:02pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a known shoplifter came in the store and took \$60 worth of shampoo. The manager stated she is normally able to stop the subject before he is able to take anything.
8. On 02/02/2021 at 7:40pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Trouble with Subject. The officer spoke with the manager, who stated a subject was in the store drinking alcohol so she asked him to leave. The subject then fell asleep in the vestibule. The officers spoke with the subject who stated he was homeless and cold. The subject was transported to the hospital for medical treatment.
9. On 02/11/2021 at 3:43pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a known subject placed merchandise in a plastic bag and left the store without paying for the items. The officers checked the area but were unable to locate the subject.
10. On 02/17/2021 at 8:57pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a known subject comes in the store 3-5 times a week and steals merchandise. The manager stated she noticed the subject as he was leaving the store. On 02/18/2021 the officers located the subject in the area and arrested him on outstanding warrants.
11. On 02/24/2021 at 2:45pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers interviewed the clerk, who stated an unknown subject filled two bags with merchandise and fled the store. The clerk showed the officers the video but there were only 4 cameras working and did not cover the area the subject was in.
12. On 02/25/2021 at 4:07pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Trouble with Subject. The officers interviewed the clerk, who stated a subject had been in the store since 10am and she wanted her to leave. The officers spoke with the subject who stated she was homeless. The officers attempted to find the subject housing and made arrangements for the subject to wait at the district station until housing was found.
13. On 03/09/2021 at 4:44pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Property Damage complaint. The officers interviewed the manager, who stated a subject caused a disturbance in the restroom. The subject was cited for Disorderly Conduct and conveyed home.

14. On 03/09/2021 at 5:04pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officer spoke with the manager, who stated a subject stole merchandise and fled in a car. The officer checked the location the license plate listed to but did not locate the vehicle.
15. On 03/15/2021 at 8:32pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Trouble with Subject. The officers spoke with the manager, who stated a subject was in the bathroom refusing to leave. The officer made contact with the subject and escorted him out of the store.

The officer spoke with the clerk, who stated he observed a subject concealing items in his sweatshirt. The subject left the store without paying for the items. The clerk followed the subject and took pictures of the subject and the car he got into. The officers followed up on the auto and found it was stolen in a burglary.
18. On 05/30/2021 at 4:26pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a subject was attempting to walk out with a cart full of merchandise, so he stopped the subject. The officers determined a theft did not occur because the manager stopped the subject before he passed the last point of payment.
19. On 06/10/2021 at 7:10pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for an Armed Robbery. The officers arrived and determined no robbery had occurred. The officers spoke with the caller, who stated she saw people running out of the store so she thought it was being robbed.
20. On 07/13/2021 at 1:05pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officer spoke with the clerk who provided details of the theft.
21. On 08/14/2021 at 9:06pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officer spoke with the manager about two known individuals who frequently steal from the location.
22. On 09/02/2021 at 9:48am officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers interviewed the manager, who informed the officers of two theft incidents that occurred that day. The officers filed report for both incidents.
23. On 09/02/2021 at 11:36am officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a known subject concealed on his person merchandise and left the store without paying for the items. The manager confronted the subject but he refused to return the items. The officers went to the subject's residence and arrested him. The business provided video of the incident.
24. On 10/12/2021 at 6:40pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers interviewed the manager, who stated 3 subjects came in and filled up a shopping cart with merchandise. The subjects walked out without paying for the items. The

manager provided video to the officer and a license plate number. The officers will conduct follow up with the owner to see who was driving the vehicle.

25. On 11/14/2021 12:00pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a subject took items without paying for them and fled on foot. This subject has shoplifted in the past but they have not been able to identify him.
26. On 12/16/2021 at 5:25pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officer spoke with the manager, who reported the theft.
27. On 12/31/2021 at 8:10am officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated a subject took items without paying for them and fled on foot. This subject has shoplifted in the past but they have not been able to identify him.
28. On 01/09/2022 at 3:25pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers spoke with the manager, who stated two people took \$100 of merchandise without paying for it. The manager was not able to operate the surveillance system.
29. On 01/10/2022 at 6:45pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a Shoplifter. The officers interviewed the clerk who stated two subjects loaded up a cart full of baby wipes. They pushed the car out without paying for the items and fled in a car with no plates.

30. On 01/20/23 at 9:39am, officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a theft complaint. The manager stated that a known subject took items from the store without paying for them. The suspect was no longer on scene upon police arrival. The business was cooperative with police during the investigation.
31. On 02/05/22 at 8:39pm, officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a shoplifter complaint. Officers spoke with the manager who stated the suspect left the last point of payment with unpaid items. The suspect left the store on foot south from the location. The manager was cooperative with investigation; and gave officers access to the camera system regarding the incident.
32. On 04/08/22 at 6:02pm, officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a subject with gun complaint. Officers spoke with employees and patrons who all stated that they did not observe any subject with a gun. Officers determined the scene was safe an attempted to get hold of the caller but were not able to. The officer did not observe the business license displayed.
33. On 04/15/22 officers were dispatched to the area Walgreen's, 620 W. Oklahoma Av. for a welfare check. The caller requested a check of a subject in a wheel chair, near the location. The subject was located across the street from the business waiting at a bus stop. The subject was fine and was not in any distress. The dispatched assignment was not related to the business.

34. On 05/08/22 at 1:16pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a trouble with subject complaint. Officers responded the location and the subject was no longer on scene according to staff. The staff were cooperative with officers.
35. On 05/24/22 at 9:57pm officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a threat complaint. Upon arrival officers observed that, the doors were locked and there was no answer at the doors of the business. Officers called the phone number associated with the assignment and there was no answer.

The original caller observed a subject arguing with employees regarding possible stolen items. Officers spoke with the manager who stated that they did not contact the police. The manager did request that the police be in the area and look for the subject. Police stated that the manager was cooperative and there were no violations of the business observed.

Officers spoke with the manager regarding a subject who was asked to leave the business. Before leaving, the subject yelled at the manager and caller her names. The manager observed the subject leave on foot and stopped near the location. The manager gave officers the subject's description and pointed him out. Officers stopped the subject and issued him a citation regarding.
38. On 07/12/22 at 6:44pm, officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a theft complaint. The manager stated that three suspects took items out of the store without paying for them. The suspects then left the location in a black sedan. The suspects obtained \$160.98 dollars' worth of merchandise. The manager stated to officers that she would email him a copy of video regarding the incident.

The manager was cooperative with the investigation.
44. On 09/26/22 at 8:35pm, officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a trouble with subject complaint. Officers spoke with the manager who stated that an irate customer refused to leave the store, when asked by staff. The manager was cooperative and no longer required police service. The subject left the business prior to police arrival.
45. On 11/17/22 at 7:55 pm, officers were dispatched to Walgreen's, 620 W. Oklahoma Av. for a shoplifter complaint. The manager stated that 4 suspects came to location and took items from the location without paying for them. The manager knew one of the suspects and their information.
