You are hereby notified that the Milwaukee Common Council will hold a hearing on July 6, 2005 commencing at 9:00 a.m., or as soon thereafter as this matter may be heard, in the Common Council Chambers on the third floor of City Hall, 200 East Wells Street, Milwaukee, Wisconsin 53202 to consider your Class "B" Tavern renewal application for the premises at 3515 West Villard Avenue in the City and County of Milwaukee, Wisconsin ("Conversations").

Attached you will find a copy of the Report of the Utilities and Licenses Committee which includes their Findings of Fact, Conclusions of Law and Recommendation, recommending renewal with a fifteen (15) day suspension of the Class "B" Tavern license. 
