This report is written by Police Officer Kristyn KUKOWSKI, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On Wednesday, 4-19-97, at about 10:25PM,. Officers were sent to check for an unlicensed bartender at Chaser's Pub, located at 2155 So Kinnickinnic Avenue. Upon their arrival officers found Eugene F Timm tending bar without a Class D Bartender license, and he was not supervised by a licensed person. Mr Timm told the officer that he was filling in for the owner while he was out picking up liquor. The licensee (Frank F Dobert) was summoned to the scene where he stated that he had gone to the bank for change.

2. On 5-20-01, at 1:10AM, officers were sent to the Chaser's Pub, 2155 So Kinnickinnic Avenue, to investigate a tavern violation. The officers observed a 20 year old person on the premises, who fit the description given to officers of an underage person on the premises. She told the officers she had been waiting for her boyfriend to finish his last drink so she could drive him home, and had been there only 20 minutes. She told officers she wasn't drinking. The bartender told officers the underage person was only there to pick up her boyfriend.

3. **INCIDENT** -- On 6-6-01, at 12:12am, officers were sent to Chaser's Pub, 2155 So Kinnickinnic Avenue, regarding a hold up alarm. On arrival they found a victim lying on the sidewalk. They spoke to the bartender, who stated three (3) hispanic males came into the business at approximately 12:00AM requesting to be served. She told them the bar was closing and they would not be served. They became angry, and one of the subjects sprayed OC at a customer, and in the air. The victim attempted to get the subjects out of the premises and close the door, but was pulled outside and battered by the subjects. The bartender then pulled the hold up alarm.

Substantial Battery report filed.

4. On 12-15-01, at 2:10AM, officers observed three subjects appearing to be juveniles run westbound across S Kinnickinnic Avenue in the 2100 block. The three were then observed going into Chasers' Pub. Upon parking the squad the officers observed a young person looking out the front window, and then closing the front door. Then saw five juveniles exit the side door and run west through the yards. The front door was locked; the side door was ajar, but was closed and locked just as the officers attempted to open it. After a couple minutes of knocking the door was opened by an unknown patron. The officers asked why the door was locked, and

he bartender said, "I gave the last call, and locked the door to keep people from entering." The officers asked the bartender why there were juveniles in the bar, and she said "There were no Juveniles". The officers told her they saw Juveniles exit the side door, and she said, "No one exited the side door." The basement door was locked, and after several minutes of the bartender trying various keys to attempt to open the door, the basement door was opened by a 17 year old holding an open can of Miller Beer. Three more underage persons were found hiding in the basement.

The subject was instructed during a tavern check on 2-5-05, that the door had to remain unlocked during business hours. The licensee was issued the following

7. On 07/19/07 at 10:23 pm, an uncovered officer was able to purchase cocaine base from a patron, identified as Saundra MORTON, inside of Chaser's Pub located at 2155 S KK Avenue. On the same date at 11:00 pm, this same uncover officer was able to purchase additional quantities of cocaine from MORTON. On 07/26/07 at 9:28 pm, the same uncover officer was able to purchase quantities of cocaine from a patron identified as Jamell Dent, inside the Chasers Pub. On 08/01/07 at 9:35 pm, the same uncover officer was able to purchase cocaine from DENT inside Chaser's. On 08/01/07 at 11:28 pm, this same officer was able to purchase more cocaine from MORTON inside the Chaser's Pub. It was at this time that officers placed MORTON and DENT into custody and a custodial search revealed 11 corner cuts of cocaine base inside DENT's shorts pocket. MORTON was found to have in her possession 13 corner cuts of cocaine. Both were charged with POCS w/Intent to Deliver, Manufacture/Deliver Cocaine and DENT was also charged with two counts of Bail Jumping.

8. On 10/09/07 at 2:00 pm, Milwaukee Police along with a special agent from the Department of Revenue conducted a tavem check at 2155 S KK, Chasers Pub. Investigation revealed that the licensee, Frank Dobert, could not provide the agent with the proper invoices for the purchases of liquor as required by law. Dobert stated he had these invoices at home and later delivered them to the tavern for inspection. It was then that the agent stated the invoices were not in compliance with the proper purchasing of alcohol. A total of 55 bottles (sealed and unsealed) were confiscated due to uninvoiced alcohol. Officers observed 26 bottles of liquor that were contaminated and destroyed on scene by the bartender, Eugene Timm. The remaining alcohol was placed on inventory.
