A substitute ordinance relating to the change in zoning from Detailed Planned Development to General Planned Development to General Planned Development and approval of the Third Amendment to the General Planned Development known as Kilbourn Square, to permit future residential development, on land located on the southwest corner of West State Street and North 23rd Street, in the 4th Aldermanic District.
