Following consideration of the report of the Licenses Committee, the Common Council voted to renew with a 90 (ninety) day suspension the Class B Tavern, Public Entertainment Premises and Food Dealer Licenses based upon the preponderance of the evidence in the police report and aldermanic testimony that demonstrates the operations results in a threat to health, safety or welfare of the public for the failure to comply with the approved plan of operations. Said suspension is in effect between 12:01 a.m. on December 16, 2025 and 11:59 p.m. on March 15, 2026.
