This report is written by Police Officer Xavier Benitez, assigned to the License Investigation Unit.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 06/12/07 at 8:16 pm, Milwaukee police were dispatched to 1361 N 36th Street for a Strong Arm Robbery complaint. Investigation revealed that a unknown subject entered the location grabbed four gallons of antifreeze and walked out of the store without paying. An employee tried to stop the subject and was hit in the face by the suspect with one of the gallons of antifreeze. The victim sustained a one-inch laceration to his face and was treated for his cut by MFD. The suspect fled before police arrived.

Applicant is also the licensee of a 24-hour convenience store, Penzmart 1225 W Lincoln Avenue. Following is an incident regarding that premises.

2. On 4-29-2006, Milwaukee Police officers delivered a copy of a new City Ordinance 106-36-3-b which refers to the sale of Drug Paraphernalia at convenience foods stores, to Penzmart, at 1225 W Lincoln Avenue. The copy was given to Cheema Harminder, who said she was the responsible person on the premises. On 11-8-06, Police officers conducted a plainclothes investigation at Penzmart, 1225 W Lincoln Avenue. The officers entered the store and asked the clerk if he sold any pipes or filters. The clerk said that they don't sell that anymore. The officer asked if they had anything for weed. The clerk offered a blunt cigar from behind the counter and sold it for \$.75. The licensee met the officers at District #2 on 11-8-06, and was issued a citation #5961456 for Sale of Drug Paraphernalia.

Citation was not found in the municipal system.

Applicant is also the licensee of a 24 hour convenience store, Hopkins Liquor, 1646 W Hopkins Avenue. Following is an incident regarding that premises.

3. INCIDENT – On 6-18-06, Milwaukee Police officers conducted an investigation in the area of 16th and West Hopkins Street. They observed a person loitering in the bus shelter at Chambers and Hopkins Street. Several busses passed and the subject did not board a bus. The area is a high drug/crime area. Upon the subject noticing that he was being watched, the subject walked across the street and into the Hopkins Liquor, 1646 W Hopkins Street. This is a common occurrence in this area. When the subject exited the liquor store he was interviewed and an edge weapon was found on the subject, and he was issued a citation for CCW. The officers spoke to an employee of the liquor store several months ago about the illegal activities in the area, and offered to help, giving their names and phone numbers. However, they have never received any calls regarding this from the store employees, even though they constantly see loitering/panhandling/public drinking in the area.

4. On 07/09/09 at 4:41 pm, Milwaukee police were working the Wisconsin Wins Tobacco Initiative and had a 15 year old student enter 1361 N 36th Street in attempts to purchase cigarettes. The clerk Gurram Singh, sold a pack of Newport 100's to the student even after viewing her ID. Gurram stated she was of age and did check her ID. A citation was issued to the licensee Harbhajan Singh for Sale of Cigarettes To Minor/Underage.

10. On 05/19/2018 a 17 year old working in conjunction with the Milwaukee Police Department and WI WINS Tobacco initiative, was able to purchase White Owl cigar from the clerk at Vliet Shell, 1361 N. 36th St. The clerk was identified as Sanjay DUTTA. He remembered the sale but stated he checked the ID but thought it showed the juvenile was 18. The applicant was mailed a MARTS enrollment letter.

11. On 02/21/20 Milwaukee Police Officers responded to the location's (1361 N. 36th St) parking lot regarding a shooting complaint. It was determined by investigating officers that the initial incident occurred in the parking lot of the gas station. Investigators spoke with the gas station clerk who stated that he heard gun shots come from the outside of the location. The clerk was cooperative with investigators and provided them with access to the video footage of the gas station parking lot. Two victims sustained multiple gunshot wounds from the incident. Subsequently victim one was pronounced deceased at the scene due to his injuries. The second victim was transported to Froedtert Hospital for treatment. A check revealed no phone call was made from the location regarding the shots fired.

12. On 03/10/20 the listed agent attended a meeting with District #3 personal regarding a homicide that occurred on 02/21/20, which started at the location (1361 N. 36th St). The agent gave details during the meeting on what business practices have changed. The agent stated that a security company (Securitas) will be used as oppose to just the summer months, improved cameras in the location, additional signs of no loitering no firearms on the premises, and routine keep up of the security cameras. During the meeting the agent was cooperative, helpful, and stated he will work closely with neighboring partners.
13. On 06/01/20 Milwaukee Police Officers came to the location (1361 N. 36th St) regarding a shots fired complaint that occurred at a building south of the location (3611 W. Vliet St). Officers recovered several spent casings outside the location of 1361 N. 36th St. Officers were allowed to review video footage of the business. Officers observed the suspects and the elements of the crime on the video. The employee stated to officers he heard 10-12 shots fired and people run through the gas station lot. A check revealed no phone call was made from the location regarding the shots fired.

This report is written by P.O. Andrew KEMPEN, assigned to District 3, Late Power Shift.

On Friday, February 21st, 2020 at 1:41 AM, Squad 3465, P.O. Larry LEIBSLE and I, responded to 3701 W Vliet St for a shotspotter call. Upon arriving on scene it was determined that a shooting had occurred and the incident had started in the parking lot of 1351 N 36th St.

The clerk that was working that night, Aiman F ABUNAAH (M/W 11/13/68) told CIB Detective Matthew BELL that he observed two vehicles enter his lot one was a silver Cadillac which was occupied by a female who entered the store and the victim's vehicle. ABUNAAH stated that shortly after the female in the Cadillac left the store he heard gunshots and observed a subject shooting at the victim's vehicle. ABUNAAH stated that he heard 4 to 5 gunshots follow but 3 more gunshots 15 seconds later. ABUNAAH was cooperative with investigators and provided them with access to the video surveillance in the parking lot.

The location did not appear as a caller on any call generated regarding this incident.

Two victims sustained gunshot wounds as a result of this incident. The first one sustained multiple gunshot wounds, which included one to his neck and chest and was pronounced on scene while the second victim sustained a single gunshot wound to his neck and was transported to Froedtert Hospital for medical treatment.

On Tuesday, March 10, 2020 at approximately 12:30P, a call in meeting was conducted with the owner, Harbhajan SINGH (m/w, 10/02/53), of 1361 N 36th St (Vliet Shell). This meeting was scheduled due to the recent homicide and shooting that was drug related at the Vliet Shell on Friday, February 21, 2020 (See MPD IR# 200520014). Present for the meeting included Captain Norman, Sergeant Velazquez, PO Finkley, ADA Ballenger, Safe and Sound Kenyatta Bryant, SINGH, SINGH's wife, SINGH's son, and myself.

SINGH stated that there has a communication link that has been missing between his business and District Three. SINGH stated prior to the shooting he had witnesses some problems and did not know who to contact. I gave SINGH the correct information and contact guide for District Three. I explained the types of calls that should be called into 911, non-emergency, and the CPU office.

SINGH gave details of what he has changed since the homicide. SINGH has worked with Securitas in the past and uses the company mainly in busy summer months. Since the homicide SINGH has started Securitas. SINGH stated that he has increased and used improved cameras. SINGH also had a person come to the location to conduct a check of the cameras. SINGH provided a receipt for proof. SINGH has also added more no loitering and no firearm signs on the premise. SINGH also signed an updated Standing Complaint form for the property.

SINGH was cooperative and helpful during the entire meeting. SINGH understood the severity of the incident that took place at his business. SINGH has been working closely with Near West Side Partners to become a good neighborhood partner.

On Monday, June 1st, 2020 at 10:07 PM, Squad 3465, P.O. Yang LEE and I, were dispatched to 3611 W Vliet St. Upon arriving on scene I located several casing just south of the building which is a Clark Gas station 1361 N 36th St.

A total 21 casings were recovered south of the building. 10 silver Hornady 9mm luger casings and 11 brass PSD 16, .223 casings. (AC20019131)

I spoke to the attendant at the gas station, Aiman ABUNAAJ (M/A 11/13/68) who stated that he did hear the gunshots and believes there were approximately 10 to 12 gunshots in very close proximity to the building. ABUNAAJ did not see anyone with any firearms and only saw a number of people running in all directions. ABUNAAJ did not call regarding the shots fired. ABUNAAJ allows me to view the video from the gas station.

At 21:59:21 - Suspect 1 enters view of Camera 9 from the east and appeared to be a on flip phone.

At 22:01:01 - Suspect vehicle pulls in to the back parking lot having traveled north on N 37th St.

At 22:01:10 - Suspect 2 exits Suspect Vehicle from Driver's side rear door on a phone. Both Suspect 1 and 2 get off their phones at this time.

At 22:01:14 - Suspect 1 walks slightly west in the alley and Suspect 2 follows.

At 22:01:29 - Suspect 2 hands Suspect 1 what appears to be money and Suspect 1 counts it.

At 22:01:54 - Suspect 1 puts the money in a left leg pocket and starts patting down his other pockets.

At 22:02:00 - Suspect 1 pulls a gun and points and attempted to fire at Suspect 1 they are only 2 to 3 feet apart.

At 22:02:02 - Suspect 1 is back pedaling and fires his handgun toward Suspect 2 while Suspect 2 and turned and is running east past Suspect Vehicle.

At 22:02:04 - Suspect 3 exit Driver's seat and Suspect 4 exit Front Passenger seat. Suspect 3 is armed with a rifle and Suspect 4 is armed with a handgun and fire several rounds toward Suspect 1.

At 22:02:07 - Suspect 2 runs east toward N 36th St and goes out of view going south on N 36th St.

The hearing before the Licenses Committee will take place virtually on 9/29/2020 at 11:45 AM. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at <http://city.milwaukee.gov/citychannel>. Those wishing to provide oral testimony will be asked to do so by phone or internet and are asked to contact the staff assistant, Molly Kuether-Steele at (414) 286-2775 or molly.kuether-steele@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
2. You must testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are willing to testify).
4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)
6. You may then provide testimony.
 - a. Include only information relating to the above license application.
 - b. Include only information you have personally witnessed or seen.
 - c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
 - d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.


