



Commencing at a found concrete monument with a brass cap marking the Northwest corner of the Northeast ¼ of said section 19: thence South 00°00'31" East, along the West line of the Northeast ¼ of said section, 33.00 feet; thence South 89°50'28" East and parallel with the North line of said ¼ section, 30.00 feet to the point of beginning and the Southeast corner of North 20th Street and West North Avenue; thence South 89°50'28" East along the south line of West North Avenue, 80.87 feet to the Southwest corner of West North Avenue and West Monroe Street; thence South 46°50'00" East along the South line of West Monroe Street to a found 1" iron pipe 111.77 feet; thence South 43°06'57" West, 68.50 feet; thence North 46°50'00" West, 30.00 feet; thence 43°06'57" West, 51.66 feet to the north line of a fifteen foot wide public alley; thence North 46°50'00" West 80.03 feet to the East line of North 20th Street; thence North 00°00'31" West 89.13 feet along the East line of North 20th Street to the point of beginning. 


