Badger Mutual Insurance Company on behalf of Mas Ventures, LLC alleges that on November 26, 2023, their building experienced water back up that caused damage to their property located at 10112 W. Sharon Lane. Badger Mutual submitted a damage claim in the amount of \$22,184.45, and is seeking \$20,000 representative of their policy limits for sewer back up coverage.

Our investigation revealed that Sewer Maintenance responded to a backwater call at 10112 W. Sharon Lane and discovered a clogged eight-inch sanitary sewer. The Jet vac crew immediately relived the backwater. The clog was due to heavy grease and tissue. It is our position that the City is not liable for damages and we recommend that the claim be denied.
