We have received your claims totaling \$727.22, relating to damage allegedly sustained to your vehicle when it collided with a pothole on February 14, 2008 at West Medford Avenue and Oak and on March 21, 2008 while you were traveling westbound on Silver Spring Drive, at the top of the southbound ramp to Sherman Boulevard.


Regarding the February 14, 2008 loss, C.I. File No. 08-S-391, our investigation reveals that the Infrastructure Services Division (ISD) records indicate that prior to February 14, 2008 the City had no notice of this hazard in the roadway and because of this lack of notice the City would not be liable. Therefore, we are denying this claim.

Regarding the March 21, 2008 loss, C.I. File No. 08-S-391-1, our investigation reveals that the ISD records indicate that prior to March 21, 2008 the City had no notice of this hazard in the roadway and because of this lack of notice the City would not be liable. Therefore, we are denying this claim.
