
This office is in receipt of your claim in the amount of \$1,009.02, relating to damage allegedly sustained to your vehicle on September 10, 2001 when debris from a water main break was splashed against it by passing traffic near 6680 North Teutonia.

Our investigation reveals that the Milwaukee Water Works records indicate that a possible water main break was reported to them at approximately 2:34 p.m. on September 10, 2001. A Water Works investigator was immediately dispatched to the location, arrived before 4:00 p.m., and throttled a twelve-inch main break. A repair crew arrived by 4:30 p.m., and served shut-off notices to affected customers. The investigator and repair crew were not aware of any vehicle damages resulting from this break. The Milwaukee Water Works was not negligent regarding the response to and repair of the main break. As such, the City cannot accept liability. Accordingly, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the receipt of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
