Investigation revealed that four vehicles were broken into and two firearms were taken. The incident occurred in the western part of the parking lot and there were no surveillance cameras, which would have captured the incident.

Upon arrival, officers interviewed the applicant who stated that his staff had an altercation with a group of females who were attempting to engage in fights. On Saturday August 29th 2020, at 01:20 AM squad 4320 (P.O. PIKULIK and I) while on duty in full duty uniform equipped with an axon body worn camera in a marked squad car (568) were dispatched to 7225 N. 76th Street which is located in the city and county of Milwaukee for an entry to auto investigation.

Upon arrival we met with Business owner of Prime Social LLC identified as Odean H TAYLOR (b/m, 03/26/79) who stated that a few of his patron's vehicles had been broken into in the furthermost west part of locations parking. He stated that there are no video cameras that cover this part of the parking lot.

Unknown subjects intentionally and without consent forcefully entered (4) vehicles taking items of value including 2 unknown at time of report FIREARMS, to deprive owners permanently.

At the time of report officers interviewed 4 vehicle owners who had their vehicles broken into.

#### Victim's Interview

P.O. CHEATHAM interviewed the following two victims.

IR 202420017 Victim #1 identified as Imani A. COLEMAN (b/f, 06-12-1997) who is the owner of 2009 Volkswagen CC with no plates and not currently registered with no auto insurance. COLEMANS front passenger window was broken, and Items missing is her sister's purse. COLMANS sister identified as Candice A. COLEMAN (b/f, 04-14-1990) COLEMAN stated that her brown and gold MK purse valued at \$400 with contents inside her purse was an pen, \$91.00 in cash (4- \$20, 1-\$10, 1-\$1) and an unknown model and serial numbers black in color loaded 9mm Beretta handgun with unknown value. COLEMAN will update officers with Information. IMANI COLMAN stated that she just recently bought this vehicle from an auction and has not had an opportunity to register and or obtain insurance for the vehicle.

Victims stated that they arrived to the club for a private birthday at approximately 11:15 PM on 08-28-2020 and parked in the rear parking lot. Candice COLEMAN stated that she put her gun in her purse and placed it under the driver's seat of the vehicle to conceal it. She stated that at around 01:05 AM she returned to the vehicle to find the passenger window broken out and her purse and contents missing. COLEMEN Stated that the firearm is registered to her and that she bought it at Cabalas, but did not remember the price. She stated that she would retrieve serial and model numbers along with purchase information and get it to officers.

IR 202420024 Victim #3 Identified as Tiffany S. DABNEY (b/f, 04-23-1991) 414-252-8442 who is the owner of a 2007 Nissan Altima Sedan Automobile Gray in color. VIN 1N4AL21E07C157267. DABNEY has no insurance on the vehicle. This vehicle had its rear passenger window broken. Taken from the vehicle are the following items: 1 black fanny pack valued at \$20, with 3 social security cards, WI State ID, 3 bank cards, 1 WIC card, a forward health card, and a quest card. Also stolen from vehicle were her two children's Chrome books issued from Kilburn Elementary School. No identifying information was given for Chrome books; DABNEY will update officers with information.

Victims stated that they arrived to the club for a private birthday at approximately 11:00 PM on 08-28-2020 and parked her vehicle in the rear parking lot. She stated that at around 01:40 AM on 08-29-2020 she returned to the vehicle to find the driver's side rear window broken out and her fanny and contents missing. DABNEY also stated that her children's school Chrome books which were in a plastic shopping bag on the rear seat of her vehicle were missing. DABNEY stated that she did not give anyone consent to remove items from her vehicle.

shift. I was wearing a full duty uniform with my nametag and badge affixed to the outermost garment with an Axon Body worn camera which was activated during this investigation. I was operating a fully marked MPD squad car while on duty.

#### NATURE OF CALL/ JUSTIFICATION

On Sunday, December 20, 2020 at approximately 8:00 pm, PO Khalid MAJEED and I (Squad 4467- Tavern Car) responded to a Trouble with Subject complaint located at 7225 N 76th St which is the Prime Social Restaurant and Bar. This address is located in the City and County of Milwaukee, WI.

#### INVESTIGATION

Upon arrival, PO MAJEED and I were met by the owner Odean H TAYLOR (B/M 03/26/1979) in the front parking lot of the business. TAYLOR stated that earlier this same day his security staff was forced to remove a few customers from inside of the business after they started minor altercations. TAYLOR stated that three group of females attempted to engage in physical fights but were escorted out of the business by security. TAYLOR stated that his business rarely have any issues dealing with the public but on this day the females who were attempting to fight were threatening his security staff. TAYLOR stated that two females had to be separated by his security staff after a brief fight in the parking lot when they were escorted out of the building. TAYLOR stated that the females departed the scene prior to police arrival.

PO MAJEED and I conducted a walk thru of the business where we observed patrons inside of the location. I observed that the individuals inside of the building were wearing face coverings and were acting accordingly. I observed the security staff inside of the location as well as walking in the parking lot around the exterior of the building. I was informed by TAYLOR that the close of business is at 9:00 pm but he was shutting down early because of the commotion between the groups of females who started that altercation.

PO MAJEED and I remained on scene inside of our squad car in front of the establishment until everyone departed from the scene. We observed the security staff monitor the vehicles leaving from the parking lot and directed the traffic flow. I did not observe anything which required police action

I informed TAYLOR that a License Premise report will be filed regarding our response to the business.

#### **FOLLOW UP**

On Monday, December 21, 2020 at approximately 1:39 am, PO MAJEED and I were dispatched to St Joseph's Hospital for a Battery complaint in which the victim stated that she was punched in the face while at Prime Social Restaurant and Bar. Upon arrival we were escorted to ER room 24 by the hospital staff where we observed that the victim was no longer on scene. The hospital staff searched the hospital for the victim but could not locate her inside of the hospital. The RN who treated the victim stated that she was a B/F who had a laceration inside of her lip and minor bruises which prompted the staff to contact the police to report an assault. We were informed that the victim was intoxicated and did not provide a telephone number to be contacted. PO

W Good hope Rd which is located in the city and county of Milwaukee. While on patrol, a dispatched call came over for the prime social club at 7225 N 76th st for a subject with gun. The CAD stated that there were several subjects with rifles and security shirts. Officers were driving by the location when this call came over and observed several subjects wearing black security shirts open carrying various rifles. Officers stopped and advised the security guards that a call had come in and that we were just there to check on the status of a large party that was going on.

Officers observed that the Southbound traffic on N 76th st was becoming slightly congested but due to the amount of cars that were at the event, we considered it to be reasonable job done by the security guards on scene who were very cooperative with officers. They reiterated that the parking lot on the East side of the street (Destiny School) was not related to their party. Officers observed the Destiny school parking lot to be half full and the entire Prime Social Club parking lot to be completely full. Officers advised the security guards that the main issue will be with people attempting to park on Good Hope southbound. Security acknowledged this point and stated they would keep up with the traffic. I observed that the buildings front entrance was almost entirely blocked by a crowd of people so that I could not see into the building. Officers stated to security to call us with any problems and to try and keep up with the cars coming and leaving creating the traffic calls for service.





- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
