This report is written by Police Officer Monreal, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

- 1. On 01/15/14, applicant was cited for Possession of Marijuana and Possession of Drug Paraphernalia by Greenfield Police Department.
 - Charge:Possession of Marijuana
Possession of Drug ParaphernaliaFinding:Guilty

- 2. On 03/06/18 at 10:26am, Milwaukee Police, along with State of Wisconsin Revenue Agents and Milwaukee City Inspector, conducted a license premise check at 3425 W. Oklahoma Avenue. While performing the check, officers observed several items which are considered "drug paraphilia" and found all their licenses were not properly posted. State of Wisconsin Revenue Agents found several invoice violations at the establishments and told the owner the proper way of filing these invoices. No items were confiscated and no tickets were issued.

- 3. On 03/15/18 at 10:26am, Milwaukee Police, along with a State of Wisconsin Revenue Agent, conducted a license premise check at 3425 W. Oklahoma Avenue. The applicant was on premise and the Revenue Agent found tobacco products that were delivered to the establishment which were intended for the applicants business in the City of Cudahy. The applicant told the Revenue Agent that the wholesaler would only deliver his products to the Milwaukee establishment. The Revenue Agent called the wholesaler and told them to pick the tobacco products up and deliver them to the Cudahy store. No items were confiscated and no tickets were issued.
- 4. On 12/24/20 at 11:20pm, Milwaukee Police were dispatched to 3425 W. Oklahoma Ave, for a damage to property complaint. Officers spoke with the agent who stated that at approximately at 10:20pm an unknown subject appeared to have thrown a blunt object at window causing it to break. The incident was captured on video. Officers did not locate the suspect, and filed a police report for the agent

5. On 02/25/21 at 5:15 pm, a subject filed a missing /stolen complaint at District 6. The victim stated she went to 3425 W. Oklahoma Av on 02/24/21 to purchase candy. The victim left her wallet at the counter of the business after paying for the items. The victim was unable to locate her wallet after checking for it at the store.

- 6. On 06/16/2021 at 4:50am officers were dispatched to a Trouble with Subject at Petro Mart Gas, 3425 W. Oklahoma Av. The officers spoke with the clerk, who stated there was a female that has been at the business for some time refusing to leave. The officers located the subject and determined she was in need of medical treatment. An ambulance arrived and conveyed the subject to the hospital.
- 7. On 11/21/2021 officers located a stolen auto at the gas station at 3425 W. Oklahoma Av. The owner came to the location to assist officers in recovering video. The business did not have its licenses posted but the officer confirmed the business licenses were current.
- 8. On 01/11/2022 officers were dispatched to a Fight at Petro Mart, 3425 W. Oklahoma Av. The officers spoke with the clerk, who stated two cars parked in the lot and the occupants started fighting. The subjects had left prior to the arrival of the officers and the clerk had no information on the vehicles.
- 9. On 01/13/2022 officers were dispatched to a Trouble with Subject at Petro Mart Gas Station, 3425 W. Oklahoma Av. The officers spoke with the clerk, who stated a subject was parked blocking the pumps. The subject was not on scene when officer arrived.

- 10. On 05/25/23 Milwaukee police were dispatched to a Trouble with Subject at 3425 W. Oklahoma Av. The employee called officers to the location regarding a pan handler refusing to leave. The subject was gone upon police arrival.
 - 11. On 07/28/24 at 1:06a.m., Milwaukee Police were dispatched to a Motor Vehicle Accident at 3425 W. Oklahoma Ave. Investigation revealed a vehicle was left running at the pump, with a

rear seat occupant. A suspect entered the vehicle and began to drive off, when the rear occupant began to struggle with the suspect, causing the vehicle to crash into a house. The business was cooperative with the investigation and allowed officers to view video surveillance of the incident.

- 12. On 09/15/24 at 10:19a.m., Milwaukee Police were dispatched to a Subject with Gun at 3425 W. Oklahoma Ave. Investigation revealed a patron was dissatisfied with a product and was disruptive and disorderly with the clerks. The clerk eventually refunded the patron, however, retrieved a firearm from the back room and waved it, before placing it in their waistband. The firearm was confiscated as evidence and the case was ordered in to the District Attorney, but was dismissed on prosecutors' motion.
- 13. On 03/24/25 at 12:00a.m., Milwaukee Police were dispatched to a Subject with Gun at 3425 W. Oklahoma Ave. On arrival officers were advised 3 suspects come daily and cause a disturbance, however, today they were armed with firearms. The subjects were no longer on scene, however, the business was cooperative and allowed officers to view video surveillance, which depicts the suspects armed with weapons.

This report is written by P.O. Nashata NORWOOD, assigned to District Six, Late Shift, and assigned to Squad 6320.

On Sunday, July 28, 2024, at approximately 1:06 AM, while in full duty uniform equipped with Axon body camera activated and in a marked squad, I was dispatched to S.35th St. and W. Oklahoma Ave. (3425 W. Oklahoma Ave.), in the City and County of Milwaukee regarding a motor vehicle accident with injuries complaint call for services.

Upon arrival, I spoke with caller/victim Aidan W. MARTINEZ (H/M, 03/04/2002) who stated an unknown male intentionally and without consent took his vehicle while he was inside the gas station. MARTINEZ stated he left his vehicle running at the pump and did not think it would be a problem because his brother Anthony R. MARINEZ (H/M, 09/28/1999) was in the back seat.

I spoke with ANTHONY who stated he was seated in the middle of the seat in the rear of the vehicle when an unknown male jumped in the driver seat. ANTHONY stated he thought it was his brother getting back in the vehicle at first and when he realized it was not him, he grabbed the unknown male from the back seat. ANTHONY stated while he was tussling with the unknown male to get out of the vehicle the vehicle crashed into a house.

I spoke to licensed premise employee Tarek A. MOHANY (A/M, 03/21/1989) who provided video surveillance of the incident. MOHANY stated he did not see the incident until he watched the incident on his video surveillance. MOHANY was informed to close the doors to the business so customers would not enter while Milwaukee Fire Department was on scene and Wisconsin Gas Company to shut the gas off to the residence the vehicle hit. MOHANY was cooperative with officers during this investigation. The business had no security officers on scene.

I reviewed video surveillance footage. The footage showed an unknown subject cross the street from the northside of W. Oklahoma Ave., walk to the side of a black Honda Accord facing westbound at the gas station at the pump, open the door and begin to drive westbound out the gas station, turn right on to S.35th St., make another right eastbound on W. Oklahoma Ave., cross the curb and gas station slabs, and crash into the northeast side of a residence.

While on scene, I observed the licenses posted and they were up to date. During my investigation for a

This report is written by PO Tiffany MORRELL, assigned to District Six, Day Shift, sq. 6122.

On Sunday, September 15th at 10:19a.m., I was dispatched to 3425 W. Oklahoma Av. for a Subject with Gun complaint. The caller stated that the store clerk had pointed a gun at him.

Upon arrival, we spoke with the caller, identified as Michael D. ADAMS (b/m, 05-14-73), who had waited outside the front of the store for our arrival. ADAMS stated that the store clerk, whom we were able to identify as Amro A. MOHANY (w/m, 11-29-83) had pointed a gun at him after an argument inside the store. ADAMS explained that he had purchased items from the store and was not satisfied with the products. ADAMS stated that he went back into the store on multiple occasions to voice his displeasure with the products he purchased, ultimately demanding his money back. ADAMS stated that he got his money back and he told the store clerk "fuck you." ADAMS stated that the store clerk then told him that he had a pistol, went and retrieved the pistol, and pointed the pistol at ADAMS.

I spoke with MOHANY regarding the incident. MOHANY stated that ADAMS had been in the store and had purchased items. MOHANY stated that ADAMS returned to the store to show that his cigars were dry and cracked. MOHANY stated that ADAMS came back into the store multiple times to complain about the damaged cigars, which MOHANY stated were not the responsibility of the store. MOHANY stated that he was attempting to make the situation right with ADAMS, and was being polite the entire time, but that ADAMS was being loud and "talking shit" with customers in the store. MOHANY stated that ADAMS had walked toward the door when MOHANY told him to leave, but that ADAMS kept "talking shit." MOHANY stated that he then went to the back and retrieved a pistol and showed ADAMS that he had it before tucking the pistol into his rear waistband.

I viewed the store footage of the incident. I was able to observe the incident on video with no sound. I observed ADAMS coming back into the store on multiple occasions and approach the counter, speaking with both MOHANY and the other clerk, identified as Win NAING (a/m, 02-11-02). The video showed ADAMS placing items back on the counter each time and appeared to point at the clerks behind the counter. The video showed ADAMS getting what appeared to be a refund, which ADAMS verified that he did, and walk toward the door, before stopping in front of the door and crossing his arms. A second camera showed MOHANY move quickly to the back room before re-emerging with a pistol in his hand. The video showed MOHANY waive the pistol in the air briefly before tucking it into his rear waistband. I observed that after ADAMS left the store MOHANY continued conducting normal business at the store.

I spoke with ADAMS again outside the store. ADAMS recounted his story the same. I asked ADAMS why he did not leave the store when he was initially asked to, and after he got his money back. ADAMS stated that he heard MOHANY stated that he was going to get a gun, so he "froze." ADAMS stated that he remained in place so that accusations could not be made that he himself was going to get a gun. I asked ADAMS if he was scared at that point, and he replied that it was not about being scared, and that it was about MOHANY being wrong for retrieving a pistol because someone told him "Fuck you." ADAMS again stated that he froze in place and that he did not wish to turn his back on MOHANY and get shot in the back.

I spoke with MOHANY again. I asked him if ADAMS had made any threats. MOHANY again stated that ADAMS was "talking shit" and that was why he retrieved the pistol. I explained to MOHANY that somebody "talking shit" does not necessarily give him the right to brandish a pistol. MOHANY then added to the story that he got the pistol because he did not know if ADAMS had a gun on him.

NAING made the same initial statements that MOHANY did, about ADAMS' dissatisfaction with the store products, and that it was not the store's responsibility if the cigars were not fresh. NAING stated that ADAMS continued to come back into the store and was being rude with both clerks regarding the dissatisfaction with the products. NAING made no mention of any threats being made by ADAMS. NAING later told officers that MOHANY retrieved the pistol because it was unknown whether ADAMS had a gun.

Neither clerk made any mention of being frightened for their safety during the initial interview. The

video showed that both clerks remained behind the counter during the incident and continued to help other customers as they entered and exited the store. Neither MOHANY or NAING called the police during or after the encounter.

Upon attempting to recover a copy of the video of this incident, MOHANY asked if we had a thumb drive to put it on and then became hesitant and asked if we had a warrant for it. Video was not obtained at that time due to officers no having a thumb drive. PO PRESI (sq. 6233) responded at a later time that day and retrieved video of the incident. This was placed on Evidence.com.

I took possession of the pistol, a black 9mm CZ P10, with a loaded 15 round magazine. The pistol did not have a round in the chamber when possession was taken. The pistol, magazine, and rounds were placed on MPD inventory, inv #s 24026480 and 24026481. I issued MOHANY a PP-33 property receipt for the pistol, magazine, and rounds, which MOHANY refused to sign.

This case was ordered into the District Attorney's Office for review.

I spoke to licensed premise owner Ehab A. MOHANY (u/m, 11/8/90) by phone and advised him of the situation.

While on scene, I observed the licenses posted and they were up to date.

On Monday, March 24, 2025, I was dispatched to 3425 W Oklahoma Ave, for a subject with a gun complaint.

Upon arrival we spoke with the manager, who was identified as MOHANY, Amro A. EDWARDS stated three black males enter the Petro Mart on a daily basis, and give the staff behind the counter a hard time and some days pay for merchandise and some days do not pay for merchandise. On today's date the three subjects were carrying semi-automatic pistols that were tucked into their armpits. The subjects arrived to the Petro Mart in two separate vehicles. One of the vehicles was a Chevrolet Cruze, gray in color. The second vehicle is unknown make and model. MOHANY stated that the subjects frequent the store on a daily basis continuously switching between four different cars that they arrive in.

The caller was not on scene when police arrived. Caller was identified as BELASKAZ, Marc (414-426-2104) from the caller information in the CAD.

I spoke to the manager identified as MOHANY, Amro A. and he agreed to let us view the surveillance footage of the gas pumps. While viewing the footage I could see the Chevrolet Cruze pull next to a gas pump and two black males wearing blue jeans and sweatshirts get out and enter the Petro Mart. The business does not have any security officers, does have multiple security cameras that show multiple views of the property on the outside and inside the store. The suspects were armed with semi-automatic pistols.

While on scene, I observed the licenses posted and the licenses were not expired. The license for weights and balances states there is only one scanner to be used, the Petro Mart is using two scanners. The filling station license states hours of operation are open 5:00AM to close at 11:59PM, I observed while on patrol the Petro Mart was still open after 12AM serving customers.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.

2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)

3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).

4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.

5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.) 6. You may then provide testimony.

a. Include only information relating to the above license application.

b. Include only information you have personally witnessed or seen.

c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.

d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.

7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.

8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
