Dear Ms. Lutzow Bralic:

This is notification that the sister city relationship with the City of Milwaukee and Medan, Indonesia will expire on May 12, 2020. Per section 335-7 of the Milwaukee Code of Ordinances, no later than 6 months prior to the expiration of a sister city relationship, the sponsoring entity may submit a renewal application to the city clerk on a form prepared by the committee. The Sister Cities Committee requests that you submit a formal renewal application, a copy of which is enclosed, by November 12, 2019 or at your earliest prior to the expiration date of the relationship.

Please note that in addition to some basic information, the renewal application requests detailed attachments regarding the sister city, your organization, and the organization in the sister city that will support this relationship. A thorough response to all questions will be most appreciated and will strengthen your renewal application.

The Sister Cities Committee will schedule a formal hearing on your renewal application, and you will be notified to attend. If the Committee recommends approval of the renewal application, it will be forwarded to the Common Council's Community and Economic Development Committee and then to the full Council.

We look forward to further exploring this sister city relationship with you. The City of Milwaukee is a member of Sister Cities International and adheres to its policies and procedures in reviewing possible relationships. We believe a limited number of such relationships are beneficial to cultural, economic, and educational growth and development for all involved.


