W. Sarasota Pl. – N. 95th St. to N. 100th St. (Sponsored by the City of Wauwatosa) (ST211070143):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

N. 97th St. – W. Sarasota Pl. to W. Fiebrantz Ave. (Sponsored by the City of Wauwatosa) (ST211070157):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

Alley between W. Grantosa Dr., W. Marion St., N. 99th St., and N. 100th St. (Sponsored by the City of Wauwatosa) (ST212070115):

Asphalt alley pavement resurfacing.

6th Aldermanic District

N. 24th St. – W. Nash St. to W. Vienna Ave. (ST211070120):

Asphalt pavement reconstruction, replace curb and gutter and sidewalk and driveway approaches where necessary, and sodding.

S. 24th St. – A point south of W. Lapham St. to W. Greenfield Ave. (ST211020121):

Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where necessary, and sodding.

W. Lapham St. – S. 34th St. to S. 35th St. (ST211070158):

Asphalt pavement resurfacing, replace all curb and gutter, replace sidewalk and driveway approaches where needed, sodding, and tree removal where necessary.

10th Aldermanic District

S. 91st St. – A point 300 feet m/l south of W. Adler St. to W. Adler St. (ST211070132):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.

11th Aldermanic District

S. 51st St. – W. Crawford Ave. to W. Wilbur Ave. (City of Milwaukee Portion) (ST211030125):

Concrete pavement construction, place curb and gutter, replace sidewalk and driveway approaches where needed, and sodding.

13th Aldermanic District

W. Edgerton Ave. – S. Howell Ave. to S. 6th St. (ST211060129):

Asphalt pavement resurfacing, replace curb and gutter, sidewalk and driveway approaches where necessary, and sodding.
