If the activities of the applicant involve a licensed premises, whether the premises tends to facilitate a public or private nuisance or has been the source of congregations of persons which have resulted in any of the following: disturbance of the peace; illegal drug activity; public drunkenness; drinking in public; harassment of passers-by; gambling; prostitution; sale of stolen goods; public urination; theft; assaults; battery; acts of vandalism including graffiti, excessive littering, loitering, illegal parking, loud noise at times when the licensed premise is open for business; traffic violations; curfew violations; lewd conduct; display of materials harmful to minors, pursuant to s. 106-9.6; or any other factor which reasonably relates to the public health, safety and welfare, or failure to comply with the approved plan of operation. The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 08/19/2009, the applicant was cited by Milwaukee Police Department for:

2. On 01/10/12 at 3:16 pm, Milwaukee police were dispatched to a Hold Up Alarm at 2100 W Grant Street. The owner, Saed Abdelal, stated to police he was the only one in the store when two males entered, one of them pointing a gun at Abdelal and demanding money. One of the suspects grabbed about \$250 dollars from the till and as the suspects fled from the store, one suspect grabbed packages of Newport cigarettes. Reports were filed.

3. On 03/16/12 at 1:33 pm, Milwaukee police conducted a License Premise Check at 2100 W Grant. Police observed advertisements on the front door and spoke with Saed Abdelal who was advised to have the advertisements removed. No other violations were observed.

4. On 08/15/12 at 1:36 pm, Milwaukee police were dispatched to 2115 W Forest Home for a Shots Fired complaint. Investigation revealed an armed robbery occurred at the Grant Market located at 2100 W Grant. Two subjects, armed with guns, entered the business and demanded money from the register. The owner, Saed Abdelal, took out his handgun from his waistband and fired 10 shots at the suspects, striking both suspects. Both subjects were later taken into custody. Abdelal was verified as being able to legally carry a concealed weapon under Wisconsin state law.

5.	On 03/13/2013 a Milwaukee police aide, who had not yet attained the legal drinking age of 21
	years, was working in conjunction with Milwaukee police and attempted to purchase a 6 pack
	of Budweiser brand beer from the applicant at 2100 West Grant Street (Grant Market). The
	applicant checked the police aides ID and refused to sell the beer.

6. On 05/19/23, Milwaukee Police were assigned to work Wisconsin, which checks area vendors for age compliant tobacco sales. At approximately 635p.m., a youth entered 2100 W. Grant and purchased a tobacco product from the cashier who was later identified as the agent. The agent was very cooperative and apologized for the violation.

On Friday, May 19, 2023, I was assigned to work for the Wisconsin WINS Youth Tobacco Prevention. Assisting in this assignment was Maurice L. NEWTON B/M 01/27/06 of 5102 S. Nicholson Ave., Cudahy, WI 53110 and Miliani J. DIAZ H/F 12/30/06 of 1729 S. 1st St. Milwaukee, WI 53204. Neither are 17 years old and not of legal age to purchase tobacco.

At approximately 6:35p.m., NEWTON entered Grant Market, located at 2100 W Grant. and purchased a Honey Fusion Dutch Cigar. NEWTON described the employee as a A/M older, bald head wearing a pink shirt. NEWTON stated the employee did not ask or check his identification.

I entered the store and identified the employee based on the description given. The employee was identified as the agent: Saed F. ABDELAL A/M 07/24/71. ABDELAL admitted to the sale and apologized. ABDELAL was very cooperative and felt really bad about the transaction since he recently passed both alcohol and tobacco enforcements. ABDELAL stated once the minor left the store, he immediately knew he made a mistake and should have checked the identification.



The hearing before the Licenses Committee will take place on 5/29/2024 at 1:00 PM in Room 301-B, Third Floor, City Hall. This is a public hearing. Those wishing to view the proceeding are able to do so via the City Channel – Channel 25 on Spectrum Cable – or on the Internet at http://city.milwaukee.gov/citychannel. Those wishing to provide oral testimony via internet are asked to contact the staff assistant, Yadira Melendez at (414) 286-2775 or stasst5@milwaukee.gov for necessary information. Please make such requests no later than one business day prior to the start of the meeting. You are not required to attend the hearing, but please see the information below if you would like to provide testimony. Once the Licenses Committee makes its recommendation, this recommendation is forwarded to the full Common Council for approval at its next regularly scheduled hearing.

Important details for those wishing to provide information for the Licenses Committee to consider when making its recommendation:

- 1. The license application is scheduled to be heard at the above time. Due to other hearings running longer than scheduled, you may have to wait some time to provide your testimony.
- 2. You must appear in person and testify as to matters that you have personally experienced or seen. (You cannot provide testimony for your neighbor, parent or anyone else; this is considered hearsay and cannot be considered by the committee.)
- 3. No letters or petitions can be accepted by the committee (unless the person who wrote the letter or the persons who signed the petition are present at the committee hearing and willing to testify).
- 4. Persons opposed to the license application are given the opportunity to testify first; supporters may testify after the opponents have finished.
- 5. When you are called to testify, you will be sworn in and asked to give your name, and address. (If your first and/or last names are uncommon please spell them.)

- 6. You may then provide testimony.
- a. Include only information relating to the above license application.
- b. Include only information you have personally witnessed or seen.
- c. Provide concise and relevant information detailing how this business has affected or may affect the peaceful enjoyment of your neighborhood.
- d. If by the time you have the opportunity to testify, the information you wish to share has already been provided to the committee, you may state that you agree with the previous testimony. Redundant or repetitive testimony will not assist the committee in making its recommendation.
- 7. After giving your testimony, the members of the Licenses Committee and the licensee may ask questions regarding the testimony you have given or other factors relating to the license application.
- 8. Business Competition is not a valid basis for denial or non-renewal of a license.

Please Note: If you have submitted an objection to the above application your objection cannot be considered by the committee unless you personally testify at the hearing.
