Dear Ms. Walls:

We have received your claim in the amount of \$578.00, relating to damage allegedly sustained on July 30, 2015 when the Milwaukee Police Department (MPD) made forced entry into your residence at 3749 North 49th Street.

The MPD records indicate that the police undertook the necessary and appropriate action to check on your welfare. As part of this process, they had the Milwaukee Fire Department force entry. Because the police and fire department were not negligent in this matter, the City would not be liable. Therefore, we are denying your claim.

If you wish to appeal this decision, you may do so by sending a written statement requesting a hearing within 21 days of the postmarked date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202. Please include a photocopy of this letter's envelope, showing the postmark, and retain the original in the event further proof is needed.

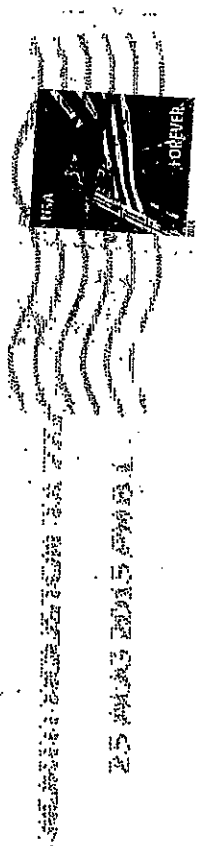
