Dear Ms. Simmons:


We have received your claim in the amount of \$1,110.00, relating to various audio and video items that were allegedly taken during the tow process.

Our investigation reveals that your 1996 Chevrolet was towed to the City of Milwaukee Tow Lot on December 29, 2007 for Obstructing an Alley/Driveway. The PT-27 Form which was completed prior to the vehicle's towing and the tow lot records all reflect that your vehicle was unlocked. The records also make no reference to the alleged items in your vehicle. The City followed proper procedures in this matter and there is no evidence to support your belief that these items were taken during the towing process, as such, the City cannot accept liability and we are denying your claim.

If you wish to appeal this decision, you may do so by sending a letter within 21 days of the date of this letter to the Milwaukee City Clerk, 200 East Wells Street, Room 205, Milwaukee, Wisconsin 53202, requesting a hearing.
