The Milwaukee Police Department's investigation regarding this application revealed the following:

Investigation revealed that a subject refused to stop for a loss prevention officer at the front door when asked to show a receipt for the property he had. The subject yelled profanities at the officer and left the store in an unknown direction with the property.

On Thursday, February 2nd, 2023, at the location 8110 W Brown Deer Rd, located in the City and County of Milwaukee, Wisconsin, my partner Brittany GALLOWAY, were dispatched to Battery complaint.

Upon arrival, at the above location, I spoke to the employee involved with this incident, Terry PEARSON (m/b, 6/8/97), who is a loss prevention security officer for Menards Lic #116392. PEARSON stated, while he was standing guard at the north entrance/exit of the store an unknown male subject tried exiting the store while in possession of some items without showing proof of purchase.

PEARSON stated the subject ignored his statements and tried to walk past PEARSON and exit the store anyway. PEARSON stated that is when he stepped in front of the unknown subject and the subject started yelling profanities at PEARSON in a boisterous manner which caused a disturbance, police were contacted regarding.

PEARSON stated when the unknown subject was informed police were responding, the subject exited the business without further incident, he entered his vehicle (dark color, unknown make/model/plate), and left the area in an unknown direction. PEARSON stated he did not want to be a victim/complainant for any prosecution against the unknown subject for the Disorderly Conduct.

I spoke to Menards manager, Christopher R. LOKKEN (m/w, 12/22/81), who stated since they did not know the subjects identify, they did not want to pursue any prosecution at this time. LOKKEN stated if they ever determine the identity of the subject, they will contact police to have him cited for Disorderly Conduct. LOKKEN further stated the unknown subject is no longer welcome on their property, and he will be informed of such if he ever returns. LOKKEN stated if the male subject, then refuses to exit their property, they will pursue prosecution for trespassing.



Viewing the security cameras at Menards, 8110 W. Brown Deer Rd.

I spoke to Cash LEE who works for O'Brien & Associates Security/Investigations at Menards. LEE allowed me to view the video of the incident. At approximately 2:52pm, I observed what appeared to be a black 2015-2018 Ford Escape come from the south east of the parking lot. The suspect vehicle then pulls up to KRAETSCH's vehicle. It appears two black males exit the suspect vehicle and start to go through KRAETSCH's truck. The suspect vehicle then continues west and pulls next to CRIPE's truck. The video is blocked by other vehicle's and the suspects cannot be observed. The vehicle continues west and KRAETSCH walks right past the suspect vehicle at this time. The suspect vehicle then continues to travel southeast and appears to attempt to enter another vehicle, but mobile security appears and the suspect vehicle flees towards W. Brown Deer Rd.
