This report is written by Police Officer David NOVAK, assigned to the License Investigation Unit, Days.

The Milwaukee Police Department's investigation regarding this application revealed the following:

1. On 12/30/16 at 5:18 am, Milwaukee police were dispatched to 405 N 27<sup>th</sup> Street for a strong arm robbery complaint. Officers spoke to the caller who stated he drove to the BP gas station to "buy candy". While at the gas station, he was approached by a homeless looking man in front of the store and showed the caller some weed. Both subjects then went to a car that was parked behind the caller's auto at the gas pump. Inside that car was three males and the caller got into the car with and they drove into an alley where they forced the caller out of the car and demanded the caller's property. Obtained were cash and a Samsung Galaxy S7 cell phone. The caller then returned to the station where he called for police. He was later arrested for loitering drug related and processed at D3. This case is pending.

2. On 01/07/17 at 5:50 pm, Milwaukee police observed a known subject aggressively panhandling in front of 405 N 27<sup>th</sup> Street. Officers asked this subject to leave and briefly did, but upon seeing the squad car leave the area, returned to the location and was seen approaching autos and asking for money. The subject was arrested and cited.

3. On 01/10/18 at 11:27 pm, Milwaukee police was dispatched to 405 N 27<sup>th</sup> Street for a Man with Gun complaint. Officers spoke with Loyd Milton, who stated he was a security guard working for the gas station. Milton stated he was having trouble with a subject who was selling shoes in the parking lot of the gas station. Milton stated this was an ongoing problem and that this subject has caused problems at the business before. Milton stated he asked the subject to leave and he refused and started walking towards Milton. Milton stated he feared the subject was going to do something so he pulled out his pepper spray and attempted to spray the subject. Milton stated the subject then fled on foot. Police checked the area for the subject, but could not locate him.

MILWAUKEE POLICE CAD SYSTEM THE CALLER STATED THERE WAS A BLACK MALE WEARING A YELLOW BACKPACK SELLING MASKS AND CIGARETTES REFUSING TO LEAVE. UPON OUR ARRIVAL, I OBSERVED A BLACK MALE MATCHING THE DESCRIPTION WHO WAS LATER IDENTIFIED AS SEAN L. BURROWS (B/M 9-4-1980) TALKING TO A FRONT PASSENGER OF A UNKNOWN RED VEHICLE. AS I APPROACHED BURROWS, I ASKED HIM FOR HIS NAME AND TOLD HIM WHY WE WERE TALKING TO HIM. DURING MY INTERACTION WITH BURROWS, HE WAS HIGHLY ARGUMENTATIVE WITH US AND REFUSED TO GIVE US HIS NAME, IMPEDING OUR INVESTIGATION. DUE TO HIS ARGUMENTATIVE BEHAVIOR, I WENT TO DETAIN BURROWS BY PLACING HIM IN HANDCUFFS BUT HE INTENTIONALLY AND ACTIVELY RESISTED MY PARTNER AND I BY PULLING HIS HANDS AWAY. P.O TRENCH WAS ABLE TO PLACE ONE HANDCUFF ON BURROW'S LEFT HAND, HOWEVER HE KEPT TIGHTENING HIS RIGHT HAND REFUSING TO PLACE IT BEHIND HIS BACK EVEN AFTER BEING TOLD MULTIPLE TIMES TO DO SO. DURING MY INVESTIGATION, I SPOKE WITH THE STORE CLERK JONATHAN CASTELLANOS (W/M 9-28-1985) WHO STATED THAT BURROWS WAS IN FRONT OF THE STORE SELLING MASK AT APPROXIMATELY 11:00 PM ON 10/17/20. THE MANAGER OF THE STORE ASKED BURROWS TO LEAVE THE PROPERTY HOWEVER AT APPROXIMATELY MIDNIGHT ON 10/18/20 BURROWS RETURNED AND CONTINUED TO SELL MASKS. CASTELLANOS AGAIN TOLD BURROWS TO LEAVE THE PROPERTY HOWEVER HE REFUSED. BURROWS WAS TAKEN INTO CUSTODY AND CONVEYED TO DISTRICT THREE TO RECEIVE HIS CITATIONS FOR TRESPASSING AND RESISTING AN OFFICER.

This report is written by Police Officer Demetrious Hudson assigned to District 3, modified Early Shift.

On Sunday, September 27, 2020, at 6:35pm Squad 9273 (Detective MELLETHIEN) and Squad 9266 (Detective Ryan BERGEMANN) to investigate the Armed Robbery/Carjacking CAD#202711708.

The two Victims were located at the scene 405 North 27th Street and the vehicle was recovered at 710 South 26th Street where the driver was also in custody after fleeing on foot from the vehicle.

Detective MELLETHIEN responded to the scene which is a BP gas station on the northwest corner of West St Paul and North 27th Street. The parking lot has 8 gas pumps on 4 islands and a convenience store and car wash building. The parking lot is well lit and the business has exterior surveillance cameras.

Upon arrival at the scene Detective MELLETHIEN received a briefing from PO TONDU and she advised that the initial investigation revealed that the incident occurred in the parking lot of the BP Gas Station at 405 North 27th Street. PO TONDU indicated that the victims stated that the incident stemmed from them attempting to sell their truck and that the stolen vehicle drove past the gas station about 1/2 hour after the robbery and District 3 Police Officers followed it and took (1) individual into custody.

## INTERVIEW OF GREEN

Detective MELLENTHIEN conducted an interview of GREEN in his unmarked Milwaukee Police Squad with GREEN seated in the front passenger seat.

GREEN stated that he is originally from Oneida Wisconsin and moved to Michigan several years ago, he met ARNOLD in Michigan and has known her for over a year and they are in a relationship. GREEN stated that they moved from Michigan to Oneida, Wisconsin and lived there for a while and most recently (about 2 weeks ago) came to Milwaukee to get work painting and fixing houses for Victoria and Ivan SOULIER (11th and Wind Lake on the south side) GREEN described their situation as homeless and almost completely broke and trying to get by here in Milwaukee.

GREEN stated that his phone and his 3 month old puppy were stolen while they were sleeping in the truck the other night (unreported to Police). Paul put it on the neighborhood facebook page.

GREEN stated that tonight (09/27/2020) he and ARNOLD were at a friend's (Paul) house on 26th and St. Paul. GREEN described Paul as an older gay gentlemen that ARNOLD met and became friends with and he added that Paul has watched their puppy in the past and they sit on the porch with him and have a drink. GREEN at first stated that he and ARNOLD took the vehicle to the gas station (405 North 27th

Street) because it was almost out of gas and that is where the two gentlemen approached them about buying the truck. He indicated that he never advertised the truck for sale, but that through word of mouth people had heard about it in the neighborhood over there by Walgreens. GREEN stated that he has found that people in Milwaukee will almost buy anything because a lot of people are desperate for money for drugs. GREEN added that when the gentlemen approached they asked him if the truck was for sale and indicated that the gentlemen had seen them before in that neighborhood (by Walgreens) before and that many people had offered them money (up to \$1000) for their Husky/Wolf puppy "Bowe") but they would not take it.

## **GREEN described the incident as follows:**

As they were parked at pump 1 he got out and checked the fluids and also prepared to check the tires because one was low. The two subjects approached them and Both subjects get out of a blue ford 4 door vehicle and Subject two starts checking the fluids on the truck with him and then GREEN gets into the vehicle and Suspect 1 gets into the driver's seat and subject #2 gets into the passenger seat and he is seated between them in the truck. Suspect #1 starts the truck and GREEN is telling him "no, no, my girlfriend is in the store and tells them that they have to put some gas in the car and then Suspect #1 pulls right into traffic and almost hits a car and then drivers west on St Paul and then stops the car and Suspect #1 points a small semi auto firearm at him and states "Don't let nothing bad happen to you" and GREEN asked to get his dads ashes and the pink duffle bag out of the car and he walked back to the gas station and they called the police.

GREEN changed different observations of the incident and when pressed with specific questions would avoid the request by stating I didn't really see that or remember. The firearm was initially described as being pulled out and pointed at him and then faced with the possibility that surveillance at the gas station may have captured the action he indicated that Suspect #1 actually held the gun down by his crotch area and only allowed GREEN to see the tip/front of the gun , he described it as a small semi auto. GREEN also indicated that the suspects arrived in the blue Ford vehicle and parked next to them at pump one, but when faced with the issue that the camera would show that GREEN changed it and indicated that the vehicle dropped the subjects off at the street.

GREEN's biggest indiscretion was indicating that the incident occurred at the gas station. During ARNOLD's interview she indicated that they initially met the two subjects at 26th and National and when she heard GREEN tell the initial officers how it happened at the Gas Station she knew that the surveillance at the gas station would show that it did not.

GREEN stated that the police arrived and about a half hour after the police arrived ARNOLD observed the truck drive by south on North 27th Street and he indicated that the police went after the vehicle and that he heard that there was only one person in the vehicle.

GREEN stated that he has never seen the suspects before and indicated that he believes that he could identify them both if he saw them again.

GREEN **DENIED** that this incident was drug related and added that he and ARNOLD drink alcohol, but do not use drugs. This would be later changed after GREEN was told that ARNOLD admitted during her

interview that she and GREEN have used meth, crack and marijuana since they have been in Milwaukee, but that they had not used anything tonight (09/27/2020) GREEN remained steadfast that the incident was not drug related and that he and ARNOLD were going to use the money from selling the truck to get bus tickets and go back to Oneida. GREEN could not explain what they were going to do with all of their belongings (there were 8/10 plastic totes) along with two rolled up tents and camping gear in the truck.

GREEN explained that he never discussed money with the subjects and he believed that they were just trying to get him out of the truck to drive away with it when they asked him to get out and open the hood. (This contradicted his initial statement about checking the fluid when they approached him). ARNOLD would also state in her interview that the two subjects were discussing offering \$100 for the truck while driving to the gas station and that she and GREEN looked at each other confused because they knew the truck was worth more than that.

After ARNOLD'S interview was completed Detective MELLENTHIEN confronted GREEN with the discrepancies in their statements and GREEN stated that he did believe that it happened at the gas station at first and did not remember the subjects meeting them at 26th and National. GREEN denied that the incident had no connections to drugs and offered the fact that since they came to Milwaukee people come up to them daily and offer to sell them drugs or buy stuff from them or sell them stuff. GREEN only admitted that he and ARNOLD used drugs before when Detective MELLENTHIEN advised him that a crack pipe had been located inside the truck and that it smelled strongly of marijuana. GREEN stated that marijuana was legal where they had come from (Michigan) and that the pipe may be one they had shared to smoke crack before, but that they are not addicted to or chasing drugs and were not using drugs tonight (09/27/2020). When asked why he lied about it earlier, GREEN stated that he did not know why he lied.

GREEN provided information during the interview consistent with his legal purchase of the truck in Michigan and that the signed title from the purchase was in the glove compartment of the truck. (The title for the truck recovered from inside WASHINGTON'S phone case reflected the information).

GREEN described that he and ARNOLD are out of their element in Milwaukee and that they have been victimized repeatedly since arriving here and that they are going back to the woods in northern Wisconsin.

Detective MELLENTHIEN explained that there was a suspect in custody and that if the suspect provides a statement about drugs that is provable and damaging to GREEN'S statement that he could be charged for obstruction and that the case against the suspects that stole his truck could also be jeopardized. GREEN stated that drugs were not involved.

GREEN stated that he would have never sold a running vehicle for \$100 or \$150 because he knew that he could scrap it for more than that.

GREEN described the subjects as:

## INTERVIEW OF ARNOLD

ARNOLD stated that she and GREEN were talking about selling the truck with each other and some people that they met on the street. On Sunday, 09/27/2020 at around 5:10pm they were parked on 26th and National just to the east of the Walgreens parking lot when the two suspects (she does not know them) got dropped off by a blue 4 door vehicle and approached them about buying the truck from them. ARNOLD stated that she was in the back access cab area of the truck and that GREEN was in the driver's seat and got out and talked with the suspects and then the subjects just got into the truck and indicated that they wanted to test drive it and suspect one got into the driver's seat and suspect two got into the passenger seat and GREEN got into the back area with her and were laying on the stuff in the back access area of the truck.

ARNOLD stated that from the instant suspect #1 started driving the truck she knew something was wrong because he was driving it hard and the transmission was starting to go and there was a leak in the front tire and it was low. ARNOLD stated that the two suspects were discussing that the truck was only worth \$100 dollars and she looked at GREEN and told him that this was not right and that she did not want to sell the truck to them. They pulled into the gas station and suspect #2 got out of the truck and was talking about buying it and she told him that she no longer wanted to sell it. Suspect two handed GREEN \$5 and told him to go pre-pay to put gas in the truck and ARNOLD whispered to GREEN to not do that thinking that if he left the truck the two subjects would drive away with her and God knows what would happen to her. ARNOLD stated that suspect #1 stayed in the driver's seat the whole time and was very young looking and quiet.

ARNOLD stated that she got out of the truck and took the \$5 to go get gas and suspect #2 and GREEN popped the hood and looked at the engine. When she went into the station to pre-pay for the gas the truck took off with GREEN inside of it and he came back minutes later and told her that one suspect had a gun and they took the truck and kicked him out. ARNOLD stated that by the way the subjects forced their way into the truck for the test drive she knew something was wrong.

ARNOLD was aware of GREENS initial statement to the police and she did not know why he told them that because the cameras would show it was not correct. ARNOLD denied that they used drugs at all and stated that crack pipe in the glove box was not theirs. When Detective MELLENTHIEN advised her that GREEN had admitted it was she then agreed and admitted that since they got to Milwaukee they have used Meth, Crack and Weed, but that they had not used any drugs tonight (09/27/2020).

ARNOLD stated that since they have been in Milwaukee they have had so many things stolen (dog) and been victimized and that they were not seeking drugs. ARNOLD stated that GREEN is too nice and not street smart and that he is too trusting of people. ARNOLD described that she believed that GREEN lied to the police about where it happened to make things more simple for the police and that he was not aware that it would effect the prosecution of the case. ARNOLD denied that she and GREEN discussed what they were going to tell the police and she denied that the incident had any connection to drugs.

ARNOLD described a similar description of the suspects and she referred to Suspect#1 as very young and cute or good looking. ARNOLD never saw a gun, but saw a bulge in suspect #1's front waistband area. She stated that a prostitute names A-1 that walks on National Avenue described a drug dealer to her that matched Suspect #1 (WASHINGTON's) description and that she told her that his street name was JT or Freeze or something like that. ARNOLD stated that when suspect #1 got into the truck he had a blunt wrap and some weed, but that he was only interested in buying the truck from them.

## SECOND QP OF TYDRELLE WASHINGTON

On Monday, September 28, 2020, at 8:12pm Detective MELLENTHIEN conducted a second mirandized interview of Tydrelle WASHINGTON. The first interview was conducted by Detective Kenneth JUSTUS and WASHINGTON admitted that he drove off with the vehicle without the owner's consent, but that he believed that a drug deal was supposed to have occurred between BLACK and the Victim and that BLACK started yelling that the victim had stepped on his drugs and then told him to pull off and he did not know what to do so he drove away. WASHINGTON indicated that he believed that he was going to purchase the truck from BLACK and he portrayed himself as involved only for the purchase of the truck after BLACK completed purchasing it with the drugs.

From the moment Detective MELLENTHIEN made contact with WASHINGTON he appeared to be very emotionally unstable and have minor anxiety attacks during the interview.

### *The following is a synopsis of points of the interview and not a word for word account*

WASHINGTON stuck to his version of the incident and Detective MELLENTHIEN provided him with partial details of the victims statements and emphasised that it was possible that the victims were not being totally forthright with him.

WASHINGTON agreed that he and Black met the Victims at 26th Street and National Avenue.

WASHINGTON appeared to indicate that black was the leader of the entire thing and he continuously started crying and hyperventilating when faced with hard matter of fact questions. WASHINGTON never provided any detailed information about BLACK's identity or information that could help identify or locate him. WASHINGTON declared that black was a homeless hustler who provided drugs to people.

WASHINGTON presented himself as a very simple individual who's only source of income was to raise puppies and sell them, WASHINGTON stated that he has two young children and just wants to get out of jail. He denied having anything to do with drug dealing or criminal activity and stated that his daily goal in life is to post things on social media to build a persona for himself that makes him feel better about his life, that he is poor and has nothing to feel good about.

At one point of the interview WASHINGTON indicated that BLACK was just a homeless guy who walks around with prostitutes and steals stuff. WASHINGTON stated that BLACK is a friend of his uncles (Gary) and then WASHINGTON could not provide any information on GARY and distanced himself by saying that GARY was not his real uncle and was a friend of his uncles. WASHINGTON stated that Gary was probably homeless also.

WASHINGTON also indicated that the dog was in the car when he drove off (the victims stated that the dog had been stolen from their truck the night before).

Prior to conducting the photo arrays Detective MELLENTHIEN spoke with both victims individually and provided them with a limited detail of WASHINGTON'S statement and they both indicated that they were both recovering addicts and before coming to Milwaukee had both gone significant amounts of time clean after being addicted to heroin. When they got to Milwaukee and things started going down hill (having the dog stolen and running out of money) they both were very dejected and depressed and BOTH of them indicated that the subject with the braids (WASHINGTON) had approached them two days prior to the incident and offered them a free hit of crack to sample his product, then GREEN gave him \$20 for more and they both smoked the crack. They both indicated that they were afraid to tell the police in the initial statement and then Detective MELLENTHIEN the truth because of how he questioned them about the incident being drug related

## VIDEO FROM SCENE

All 9 cameras from the location were reviewed and the location where the truck parked (pump #1) is a blind spot and you are only able to see the front end of the truck where it pulls into the pumps.

The BP Gas Station at the scene had exterior surveillance cameras that were reviewed on scene and footage was recovered that does support the location of the incident and you observe/Identify ARNOLD exit the truck and go into the store. T You also observe the subject "BLACK" opening the hood of the vehicle and GREEN get out of the vehicle and stand near him. At one point of the footage the vehicle lurches forward while BLACK And GREEN appear to be near the passenger door and get into the vehicle. Then the vehicle pulls out into traffic and almost hits oncoming traffic, but is able to clear the traffic and

There is surveillance video at the location, but the employees on scene did not have access to view it and had no knowledge about the specifics or retention time of the footage.

Detective MELLENTHIEN also checked the 24/7 Gas Station at (Shell Food Mart) at 1319 West North Avenue and again checked the physical property of the location and observed surveillance cameras, but was told that only the day shift has access to review the system.

This report is written by P.O. Stephen DOMBROWSKI assigned to District #3 Early Shift.

On Thursday, 12-31-20 at 7:21 P.M., P.O. BUI and I conducted an investigation at 405 N 27th St regarding a trouble with subject. I spoke to the cashier Deepak PANDEY (w/m, 12-02-76) who stated that around 7:05 P.M., a subject later identified as Phillip THOMAS (b/m, 10-20-59) came into the gas station and his girlfriend bought a lottery ticket, but allegedly wanted money back because she thought she overpaid. THOMAS argued with PANDEY who did not have time to explain to him why he was not going to give the money back since THOMAS was wrong and there was no overpayment. PANDEY stated THOMAS got mad and started throwing merchandise all over from the front counter. PANDEY stated THOMAS then started pounding his fist on the thick glass causing him to fear for his safety without consent. There were also several other customers waiting in line for service as THOMAS was throwing merchandise around. THOMAS left with his girlfriend who was identified as Breynader C WILLIAMS (b/f, 05-14-58). A store employee managed to capture the license plate 233-ZRP which was a white 1997 mercury sedan listed to WILLIAMS with address 4660 N 46th St. Went to speak to WILLIAMS who let me inside her home and informed her what i was doing there about the incident at 405 N 27th St. WILLIAMS was uncooperative but said the clerk was in the wrong and over charged her for a lottery ticket. WILLIAMS would not tell me if THOMAS was there or not and later said he left to his brothers. I observed the same exact coat on the chair next to me that THOMAS was wearing on video surveillance (very distinct tiger design on jacket. WILLIAMS stated he is now wearing a different jacket and he is not home and I needed a search warrant to look. WILLIAMS later said his name was Ronnie THOMAS, which happens to be known alias for THOMAS. P.O. BUI ran THOMAS and his DOT comes back to 4660 N 46th St and also on probation. I had left already and when I went back to show a photo to WILLIAMS she did not answer her door for me anymore. We went to district #3 and called probation WI DOC after hours and had them email a photo of THOMAS to compare to video surveillance, Etime photo and now DOC photo. They all matched and I mailed this citation to THOMAS and called probation parole who did not feel a warrant was necessary at this time.
